



Privacy Policy

Welcome to JC Williams Group, a website owned and controlled by Jill C Williams. I provide this privacy policy to let you know what information is collected and how it is used, shared and protected.

This Privacy Policy applies to the website located at www.jcwilliamsgroup.com (the "Site"), the tools and interactive forums made available through the Site. By visiting the Site or using the Services, you are accepting the policies and practices described in this Privacy Policy.

Privacy Practices for Visitors to the JC Williams Group Site:

(a) The Information We Gather and How We Use it: When you access the Site or Services, we may collect the following information:

- **Personal Information** - We collect Personal Information when you knowingly provide it, including when you request information or pay for a service. Personal Information is information that may be used to identify or locate an individual, like a person's full name, e-mail address, or phone number. We use your Personal Information to provide you services, to send communications, to respond to your inquiries, and to send marketing collateral (newsletters, etc) to those who ask for such messages.

(b) Information Sharing: We do not share Personal Information and via the Site with other companies or individuals.

(c) Forums: We may make interactive forums (blogs and private communities) available on the Site. Any information that you post to these interactive forums or otherwise choose to make publicly available, including your Personal Information, may be disclosed and available to all users who have access to any interactive forum and is no longer private. Please be thoughtful about what you post and make publicly available through our interactive forums.

(d) Accessing and Controlling our use of your Personal Information: If you have provided Personal Information when requesting services, you can opt out of receiving certain email communications from the Site by sending us a request to unsubscribe you (from our newsletter). We make every effort to remove your information promptly when asked to do so.

(e) Finance Data Transparency

We do not use or share with third parties any finance-related data. When using our site to make a purchase you will be directed to a third party payment processor that maintains data security and privacy policies.

Information Security, Retention, and Data Integrity

We restrict access to Personal Information to employees of the Site. These individuals are bound by confidentiality obligations and may be subject to discipline, including termination, if they fail to meet these obligations. However, we are unable to guarantee that the security measures we take will not be penetrated or compromised or that your information will remain secure under all circumstances.

Access
