Within this Privacy Notice, we refer to attending a Chaud Movement class or event (live in studio or live online), visiting our website, making a purchase on our ecommerce site, or otherwise interacting with Chaud Movement collectively as engaging in Chaud Movement "Activities."

SCOPE OF THIS NOTICE

This Notice applies to the information we collect from or about you when you participate in Activities, or otherwise interact with us. When we use the term "personal information" in this Privacy Notice, we mean information that identifies, relates to, describes, is reasonably capable of being associated with or could reasonably be linked, directly or indirectly, with a particular individual or household. This includes information such as, for example, your name, address and device information that can reasonably be linked to you or your household, such as your IP address. Personal information does not include information that is publicly available, de-identified, aggregated, or otherwise not reasonably linkable to an identifiable individual or household.

YOUR CONSENT

By participating in the Activities, you are consenting to the collection, use, disclosure, and transfer of your information as described in this Notice. If you do not consent to the collection, use, disclosure and transfer of your information as described in this Notice, you may not participate in the Activities. If you have questions about this Notice, please contact us using one of the methods described below.

OUR TERMS OF USE

This Notice is part of the Terms of Use (available <u>here</u>) that govern your participation in the Activities. The Terms of Use is provided on our website on the "Chaud Movement Policies" page.

THIS NOTICE MAY CHANGE

Chaud Movement reserves the right to update or modify this Notice, at any time and without prior notice, by posting the revised version of the Notice on our website. Any changes we make will be effective immediately upon posting, unless otherwise indicated, and will govern our processing of your information from the changes take effect. We will update the "Last Updated" date at the top of this Notice so that you are aware of the date the Notice was last updated. We encourage you to revisit this Notice often so that you are aware of any applicable changes. INFORMATION WE COLLECT

We collect information from you when you provide it to us, from third party sources, including social media platforms, and from you automatically when you participate in the Activities.

Information You Provide.

Chaud Movement collects information you provide to us when you participate in the Activities. For example, we collect the information you provide when you create an account, complete a questionnaire, communicate with us, sign up for or attend an event, take a class in person or through our Chaud Movement Live Online platform, make purchases from our website, fill out a webform or otherwise interact with this us. The personal information we collect from you directly when you provide it to us, when you interact with us, or when you visit our Site, may include the following:

Contact information, including your name and/or nickname, email address, mailing or delivery address and phone number

Order information, including the products you purchase or services you request from us, and your shopping behavior and preferences

Payment information, including billing address and payment method, in order to facilitate payments to us and keep a record of payments we receive.

Credential information for customers who create an account, including your username and password

Information about your interests, such as your buying habits based on previous purchases

Your correspondence with us, if you reach out to us for customer service or technical support.

Any other information you voluntarily provide to us, including information about any health or medical conditions you may have that you disclose to us as part of your Chaud Movement practice.

Information We Collect from Third-Party Sources, Including Social Media Platforms.

We may collect information about you from third party sources. Our website or online service offerings also may allow you to register with, log on to, or enhance the profile you create on our website by choosing to automatically populate the requested data fields with information you previously provided to a third-party social media platform (such as Facebook or Instagram), or to a third party eCommerce platform such as Shopify. Chaud Movement collects information that is sent to us automatically by your web browser or mobile device. Non-Personal Information

We may collect and use information that is not personally identifiable, such as information that is aggregated, de-identified or otherwise not personal in nature. We may also take personal information we have collected and de-identify it or compile it so that it is aggregated and no longer personally identifiable in nature.

to improve our marketing and promotional efforts

for security, or fraud prevention purposes for any other purpose disclosed to you for any other purpose you consent to or direct us to

INFORMATION DISCLOSURE

Chaud Movement may disclose the information we collect from and about you as follows:

With Service Providers, Vendors, and Consultants. Chaud Movement shares information we collect with third-party service providers, vendors, and consultants who act for us or on our behalf. We use third-party vendors to help us perform business, professional, and technical support functions for us, including to help us design and operate our website, and online services, conduct surveys, to help us with our marketing and promotional efforts, and to provide us with studio space, software, services, and platforms that we use to operate our business, among other reasons.

Through Technologies Used on our Website. We use certain technologies on our website to offer our products and services. These technologies may include cookies, pixels, and clear GIFs (described further below), and session replay technology. As you Consent to, or As Otherwise Described to You. In some circumstances, we may describe additional ways that your information will be disclosed at the time we collect the information from you. INFORMATION PROCESSING IN THE UNITED STATES

Chaud Movement is a U.S. limited liability company. The servers that support this Site are located in the United States. While it is in our possession, your information will generally be stored in Chaud Movement databases or databases maintained by our third-party service providers on servers and data storage devices located in the United States. U.S. data protection laws may not provide as much protection as the data protection laws in force in some other countries, however, we will process your information in accordance with this Policy no matter where our data is stored. Your California and Colorado Privacy Law Rights

Right to Request Access or Right to Know

You have the right to request that we disclose information to you about our collection and use of your personal information over the past 12 months. You have the right to request the following:

Right to Portability

Right to Deletion

After we receive and verify your request, we will delete (and direct any of our service providers that hold your personal information on our behalf to delete) your personal information from our records, unless an exception applies. We may deny your deletion request if retaining your personal information is necessary for us or our service providers, as permitted by law.

Right to Opt-Out of the Sale or Sharing of Personal information (California Residents)

Right to Appeal (Colorado Residents)

Exercising your California and Colorado Privacy Rights

You may only make a request to exercise your right to access and right to portability twice within a 12-month period.

The length of time a cookie stays on your device depends on its type. We use two general types of cookies on our websites:

Session cookies are temporary cookies which only exist during the time you use our website (or more strictly, until you close the browser after using one of our website). Session cookies help a website remember what you chose on the previous page, avoiding the need to re-enter information and improving your experience while using that website.

Persistent cookies stay on your device after you've visited a website and enable the website to remember you the next time you visit. Persistent cookies help us identify you as a unique user of one of our websites.

Can I control or manage cookies on my computer, smartphone, or other device?

Yes, there are two ways in which you can control or manage cookies on your device:

<u>Cookie Consent Tool</u>. When visiting our website for the first time, an option is presented allowing you to accept the use of cookies. Please note, we do not have control over the placement of cookies by other websites, even if you are directed to them from our website.

Can cookies pass on my Personal Information to others?
