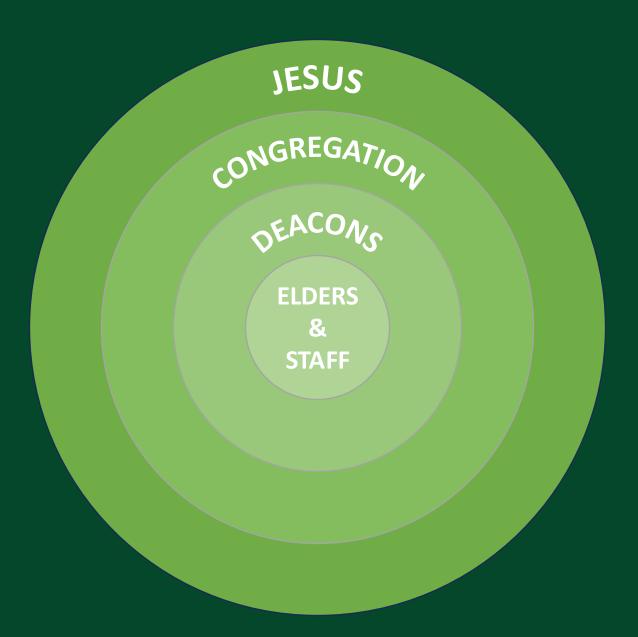

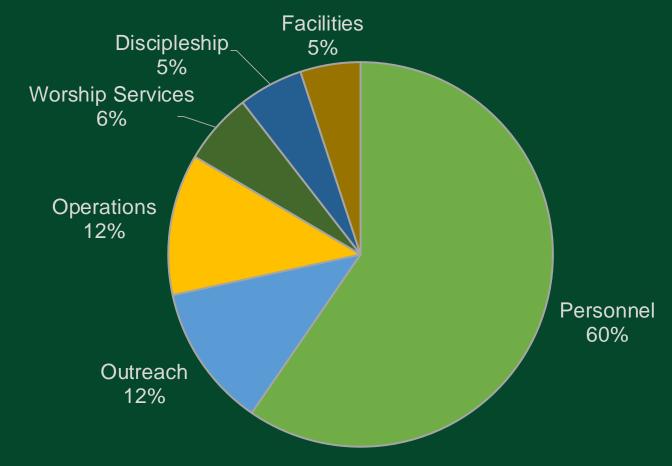
Annual Budget Overview

Monthly: \$ 43,642

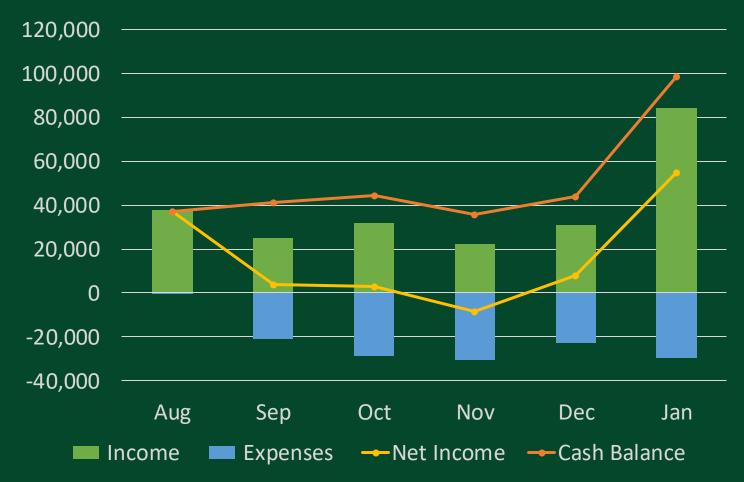
Weekly: \$ 10,071
