I am writing to submit myself as a candidate for continuing appointment in the Performing Arts Department here at SUNY Cortland.

I would like to express my gratitude for your unanimous support of my promotion to Associate Professor. As a member of this faculty I have enjoyed sharing the talents and expertise you all bring to enrich our program. In attending the various concerts and recitals presented by you and your students I have been enlightened and inspired. Unfortunately, my file is still held in that process so I cannot offer you my materials to review again now. Since you just recently completed the process for promotion, I hope that the file is still familiar enough for you to fairly assess my suitability for continuing appointment. The only materials I have to add are my Fall 2001 CTE's (including a written statement regarding the missing CTE's from Spring 2000) and some letters of support from faculty not already included in the file.

In my time here at Cortland, our program has started to grow and gain reputation. Students that are auditioning for well-established programs (Syracuse, Ithaca, Cincinnati Conservatory, etc.) are also now auditioning for our program. It is heartening that in a very short time we are being included in such a pool. I believe the success of my work as an artist and educator is most evident in the consistent growth of our students demonstrated in the various performances they have presented under my guidance. The very positive and supportive reaction from the campus and larger community is wonderfully encouraging. My students' willingness to take my guidance in class exercises and assignments, which do not always seem to fit "expected" agendas (like divorcing a lyric completely from its music to sufficiently explore the possibilities within the text itself) has helped them achieve a strong foundation of the skills required for success in musical theatre.

I deeply wish to continue the development of the musical theatre program at Cortland. I believe that the contributions I have made to the department, program and college have been important to the level of success we have already achieved and can be instrumental in continuing growth and success. The primary focus of my work here has been the establishment of the program. As the program becomes more stable, I look forward to the opportunity to serve on committees outside the department as well. By becoming more directly involved in campus wide issues, I hope I will be able to positively influence the direction of Cortland College as well as promote and support our department as a vital part of our institution. I believe there will be many opportunities for us to be instrumental in reaching across traditional department boundaries for interdisciplinary projects and courses, even now our production of *Godspell* has established collaboration with the media services office and the Communications Department through the video work included in the production. The imminent establishment of a teaching certification in theatre will provide an excellent opportunity for the Department of Performing Arts and the Education Department to collaborate.

I look forward to being part of what will be a very exciting time for our department and our institution.

### C. Course Development

Working in collaboration with instructor Cynthia Halpin a full range of Dance courses has been developed. Ballet I, II, III, IV, Jazz I, II, Tap I, II and Dance for the Theatre I, II. All courses have been taught very successfully under special topics and have been proposed as official courses. A balanced dance training sequence has been developed for the Musical Theatre Majors and is available to all Cortland students.

I enthusiastically concur with the Department of Performing Arts unanimous recommendation that Kevin Halpin should be reappointed.

In the short time that Halpin has been here, his accomplishments have truly been outstanding. Even though the major in Musical Theatre was not approved until this past summer, he has already identified the weaknesses and strengths of the program, and is working very hard to make the revisions necessary. He has expanded our offerings in dance, and was the primary force in the construction of a new dance studio.

Halpin, in the words of one of his departmental colleagues, is "immensely talented." His productions of *Little Shop of Horrors* (Fall, 1999) and *The Music Man* (Spring, 2000) were almost astonishing in their polish and scope. Please don't misunderstand; the musical productions of this department in the past were always very well done. However, Halpin has raised the standard immensely, and far beyond our original expectations.

Halpin is also a very gifted and effective teacher. He has earned his students' trust and respect, and has expanded their abilities as a result. The students do not work out of fear or intimidation; they want to perform well for him.

I also share the concerns expressed by the Department in Tom Hischak's letter. This is a new program, and the students and support staff sometimes have difficulty producing what is expected. I agree with the committee's recommendation that students need to be monitored as to their academic well-being through a system similar to that employed by coaches for the various athletic teams.

I am still in awe of what I have seen Halpin accomplish; his upcoming production of *Cabaret* will, I'm sure, continue in this tradition of excellence. I am confident that the concerns expressed by me and by the Department will be resolved to everyone's satisfaction.

The Fine Arts and Humanities Personnel Committee is very pleased to add its support to the recommendation of the Performing Arts Department Personnel Committee and the Performing Arts Department Chair that Kevin Halpin be reappointed.\*

In its deliberations this committee considered the three areas of criteria for reappointment-scholarship, teaching and service—and it was agreed that Kevin Halpin performed well in all three areas.

In the area of teaching, the committee recognizes that Mr. Halpin's enthusiasm and professional demands upon his students has resulted in some of the most noteworthy performances produced by the department here at SUNY Cortland. Though Mr. Halpin's efforts have not gone unrecognized or unappreciated, some concern was expressed by both Kevin's department and this committee with respect to the time demands placed on his students in preparation for performance. While such demands are common in the professional world of theatrical production, they are difficult to reconcile with the demands placed on the energies of full-time students. It is our understanding that the Department of Performing Arts and their Chair are making an effort along with Mr. Halpin, to develop a strategy that can accommodate the other demands required of the Liberal Arts student while continuing to maintain Mr. Halpin's high standard of excellence.
