MEMBERSHIP AGREEMENT TERMS & CONDITIONS (initials required)

_____ (initial) **YOUR BILLING DATE:** A membership fee will automatically be debited from your credit card each month. The day of the debit will be determined by the day on which you have signed up to be drafted. This debit will continue every month thereafter until your membership is terminated in the manner provided below.

_____ (initial) **FOR MY HYDRATIONBAR MEMBERSHIP FEE,** I hereby authorize HydrationBar to charge the amount that I have submitted to the credit card that I have authorized on the date(s) indicated in this membership agreement.

_____ (initial) **MEMBERSHIP SERVICES:** Your membership entitles you to receive only that which is listed within your specific membership package. If you are unable to use your monthly membership, you can defer that month to the end of your membership agreement. You will only be allowed to defer a maximum of 3 months. Your membership date will be extended to reflect that deferral. For example, you have a 12-month membership that starts June 1st, but you are unable to use your membership during August due to unforeseen circumstances. Your card will still be charged in August, but your monthly service will be deferred to the end of your agreement. HydrationBar has the right to cancel this agreement

when the buyer is not current during or after the initial contract term. **All unused services will expire 90 days after the original agreement termination date.**

_____ (initial) **PAID IN FULL MEMBERSHIPS:** Your membership entitles you to receive only that which is listed within your specific membership package. Services are to be redeemed within the time frame of your membership package. As stated in membership services, if you need to defer your monthly membership, you are only allowed to defer a maximum of 3 months. **All unused services will expire 90 days after the original agreement termination date. No refunds will be given for remaining unused services.**

_____ (initial) **AUTO RENEW:** HydrationBar membership contracts will not auto-renew.

_____ (initial) **HOW TO CANCEL/TERMINATE YOUR WELLNESS MEMBERSHIP:** You may cancel your membership (and thereby the continued monthly billing of your credit card) by filling out a cancellation form that can be provided to you in person at the HydrationBar location. We will not send a digital copy or hard copy via mail. You must come in person and fill out your form in writing. **If you have paid in full for your membership, no refunds will be given for unused services.**

_____ (initial) **EARLY TERMINATION FEE:** If you terminate your membership early, you as the buyer understand that you are responsible for an early termination fee of \$200.

_____ (initial) **NON-PAYMENT:** In the event that sufficient funds are not available in Buyer's account or debits are otherwise not accepted, HydrationBar may resubmit the charge up to 14 days after the scheduled draft date. If the fee is returned uncollected, the membership contract will be frozen until each missed payment is made in full.

_____ (initial) **CHARGES:** Buyer understands and waives the right to receive prior notice for charges with respect to any uncollected monthly fees, payments, or portions of the balance due described above.

_____ (initial) You (the Member) have three business days to cancel this agreement from the date of purchase. If you cancel, any payments made, whereas service has not been rendered, will be refunded.
