

In most countries with a parliamentary system of government, **Acts of Parliament** begin as a Bill which the legislature votes on. A draft act of Parliament is known as a **Bill**. In other words, a bill is a proposed law that needs to be discussed in the parliament before it can become a law. This principal Act of parliament needs specific laws to be made by executive branch creating legally enforceable regulations and the procedures for implementing them. The Societies Registration Act 21, 1860 continues until today and being an **Act of Parliament** comes under right to information act 2005.
