

# STOP SNITCHING ON YOURSELF ON THE STREET

You're Stopped

Ask "Am I Being Detained?"

Yes

No

Move Along

BYE BYE

*Frisk*  
A Frisk is a pat down on the outside of your cloths.  
Police can search your pockets only if they feel something that is "immediately apparent as contraband"

**Search?**

Say "I DO NOT CONSENT TO THIS SEARCH"

Politely but Firmly Say:  
"I don't want to answer questions."



Ask "Am I Being Arrested?"

Yes

**SAY IT LOUD!!**

**Questions?**

Say "I AM GOING TO REMAIN SILENT"

**SHUT UP!!!**



1. You have **NO OBLIGATION TO TALK** to the police
2. **EVERYTHING** you say can be **USED AGAINST YOU**
3. **NOTHING** you say will be used **TO HELP YOU**

YOU **DO** HAVE TO TELL THEM YOUR NAME

YOU **DON'T** HAVE TO SHOW ID

STOP AND FRISK: AKA DETAINED

IN CUSTODY

# STOP SNITCHING ON YOURSELF

FOR WITNESSES TO POLICE BRUTALITY

In Public spaces, you  
have the right to  
photograph and video  
anything in plain view

Witness Police Brutality?

Upload to a PRIVATE Space

**START TAPING!!!**  
**IF YOU SEE SOMETHING, FILM SOMETHING**

Cops ask you to stop?

Ask "Am I Free to  
Go?"

Yes

Keep Filming

No

Ask "What Crime  
Am i Committing?"

Remind the Cops of  
your Rights

Taking  
photographs is  
your right under  
the first  
amendment and  
does not  
constitute  
reasonable  
suspicion of  
criminal activity

**If the Cops Take or Destroy your Devices, HAVE SOMEONE TAPE  
THAT TOO!!**

Cops **may not confiscate** your device without a warrant

Cops **may not delete or destroy** your photos or videos



# STOP SNITCHING ON YOURSELF

IN THE HOUSE



Cops at the Door?

**Don't Let them See in the House**  
OPEN the Door, Step out,  
and CLOSE the Door Behind you

Ask "Do you have a  
Warrant?"

NO

Say "I Do Not Consent to a Search  
or to you Entering my House"

YES

Incorrect



**MAKE SURE the Warrant is Correct**

Correct


The Warrant Must:  
Be signed by a Judge  
Served By the End Date  
Have the Correct Address

Cops Conduct a Search

Questions?

Say "I want to speak to a lawyer" and  
"I am Going to Remain Silent"

You may follow the cops, but do not  
follow if they tell you to remain seated




# STOP SNITCHING ON YOURSELF

**IN CUSTODY**


**You're Locked UP**

**Cell Mates?**



Say "THE POLICE BROUGHT ME HERE"  
OR  
"MY LAWYER TOLD ME NOT TO TALK"



TALK ABOUT:  
The Phillies, The  
Sixers, Your Girl,  
Your Guy, The  
Weather

**IN POLICE QUESTIONING  
SHUT UP!!!**

SAY ONLY  
"I Want to Speak to My  
Lawyer"

**POLICE ARE ALLOWED TO LIE  
AND THEY WILL LIE TO GET  
YOU TO TALK**

# IN THE CAR



You're Stopped

Passanger Does Not  
Have to Show ID

Driver  
Must Show ID

The Police can  
search everything  
in "Plain Sight".  
They can also pick  
up things within  
arms reach.

The Police CAN search the  
Glove Box or the Trunk –  
**WITHOUT A WARRANT**

Police attempting to search  
the car Beyond Plain Sight?

*Note: Waiting  
for a warrant  
can take hours  
and even days.*

Say 'You Can't  
Search the Car'

Asked to Leave the Vehicle?

Take your Bag With  
you!!
