**Dog Registration:** Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee of \$25. You may register your dog online at <http://nasda.dog/registration>.

**Awards:** Awards will be handed out at the conclusion of each trial. Ribbons are awarded for qualifying scores, High in Trial, and new titles.

**Bitches In Season:** Bitches in season are eligible to compete. They must notify the Trial Secretary via email in advance of the trial. Bitches in season will run at the end of each class and must wear appropriate britches.

**Move Ups & Downs:** In accordance with NASDA rules, move ups and downs are permitted for teams who complete a title at the event. All changes must be made before the class in which the team wishes to compete begins.

**Venue:** This trial will be held on private property in Chatham, IL. Exhibitors will be crating in their vehicles or may set up tents outside of their vehicles. Please pack food and water for you and your dog.

- The event will run rain or shine. Please check the weather forecast and dress accordingly.
- Bring bug spray and/or sunscreen.
- Wear appropriate footwear for season/terrain.

**Notice to Exhibitors:**

- Pre-entry deadline is: 11:59 pm CT on May 9, 2025. Fees for entries made after/not paid in full by the deadline increase by \$3/run. Fees for day of show entries increase by \$5/run.
- Entries are limited to 8 hours of judging per day. If a particular day fills, a wait list will be created.
- Trials 1, 2, and 3 of each class/level will run sequentially. If you sign up for all three trials in a class/level such as Trailing & Locating Level I, you will complete Trial 1, then move immediately with the judge to the location of Trial 2, complete Trial 2, then move immediately on to Trial 3, etc.
- Cancellations must be made via email to [trialsec@citysniffers.org](mailto:trialsec@citysniffers.org) or via direct request in Secreterrier.
- Refunds for entries paid online and canceled prior to the closing date will be processed no later than 7 days after the event.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when competing in classes that allow off leash runs.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$25 fee for any returned check or payment. Checks must be made payable to City Sniffers Dog Sports Training.
- Checks will be deposited on the closing date. Any entries canceled prior to the closing date will have their checks shredded.
- City Sniffers reserves the right to refuse any entry without cause or explanation and to remove any individual for any reason from the premises.
- Absolutely NO alcohol or drug use allowed during the event. If suspected, you will be asked to leave immediately with no refund and your entries will not be accepted at any future City Sniffers event.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, weather, acts of God, public emergency, an act of a public enemy, or any cause beyond the control of City Sniffers.
