1. Executive Summary

Mantra Exploration Inc. ("the **Company**") is a growth company focused on the exploration and development of metals, including precious metals such as gold and silver, base metals such as zinc, iron and copper, and alkali metals such as cobalt and lithium. The Company has a project in Ontario, Canada and is reviewing additional advanced projects for acquisition.

Jean Iron Ore Project

The Jean Iron Ore Property ("Jean Property") is an iron ore exploration property located in the Thunder Bay Mining District of Northwestern Ontario, Canada. The property contains 84 mineral claims located approximately 65 kilometres to the southwest of Thunder Bay, approximately 2 kilometres north of the Whitefish Lake on Highway 588.

Prior to the transfer of the property by AsiaBaseMetals Inc. to Mantra Exploration Inc. the Jean Property, as of October 1, 2016, the Jean Property consisted of 18 mineral claims in 115 units covering 1,840 hectares' land. On November 16, 2016, AsiaBaseMetals Inc. forfeited 4 mineral claims consisting of 17 units covering 272 hectares' land. On March 14, 2017, AsiaBaseMetals Inc. staked one additional claim consisting of 1 unit covering 16 hectares' land. As at March 31, 2018, the Jean Property consists of 15 mineral claims covering 1,584 hectares land consisting of 99 units. As at September 30, 2020, the Jean Property consists of 78 mineral claims covering 1,560 hectares of land which were transferred to Mantra Exploration Inc. as detailed in the Plan of Arrangement on September 2, 2020. As of September 30, 2023, the Jean Property consists of 93 mineral claims. Company decided not to renew 9 claims when it was due on December 24, 2023. As a result, the Company recorded an impairment of \$1,299 during the year ended September 30, 2023. The Company did not renew 39 claims expiring on January 18, 2025 and restaked the 39 claims on January 21, 2025. The Company is assessing whether to continue to hold the property.

On July 27, 2022, an aeromagnetic survey was conducted on the project. The Company completed its NI 43-101 as published on Sedarplus.ca.

2. Third Quarter 2026 Highlights

For the nine months ended June 30, 2026 ("Q3 2026"), the Company incurred a comprehensive loss of \$55,892 and had an accumulated deficit of \$666,820. The Company's ability to continue its operations and to realize assets at their carrying values is dependent upon obtaining additional financing and generating revenues sufficient to cover its operating costs.

The Company's cash position at June 30, 2026 was \$3,454.

During the nine months ended June 30, 2026:

- Exploration expenditures of \$nil incurred during Q3 2026 compared to a recovery of \$1,750 during the nine months ended June 30, 2025 ("Q3 2025"). Exploration expenditures recovery in the prior period relates to the write off of accounts payable related to exploration expenditures.
- Professional fees of \$20,975 during Q3 2026 compared to \$5,401 during the comparative period. The increase is a result of a discount applied to audit fees in the prior year period, which reduced the comparative figure.
- Office, administration and miscellaneous costs during Q3 2026 were \$96 as compared to \$19,271 during the comparative period. These costs include bank services charges, news releases and office supplies. The decrease reflects a decrease in corporate activity during the current period.
- Travel costs of \$nil were incurred during Q3 2026 compared to \$6,286 during the comparative period, reflecting a decrease in corporate activity during the current period.

- Transfer agent fees of \$3,321 during Q3 2026 compared to \$1,814 during the comparative period. The increase reflects the timing of transfer agent and regulatory filing fees.
- Management fees of \$31,500 incurred in Q3 2026 were equal to fees of \$31,500 incurred during Q3 2025.

6. Liquidity and Capital Resources

As at June 30, 2026, the Company reported working capital deficit of \$212,550.

The Company held \$3,454 of cash or cash equivalents as of June 30, 2026.

Current assets excluding cash at June 30, 2026 consist of amounts receivable of \$2,337 and due from affiliated companies of \$3,000.

Current liabilities as at June 30, 2026 consist of accounts payable and accrued liabilities of \$212,341 and loan payable of \$9,000.

8. Changes in Accounting Policies

The preparation of financial statements in conformity with IFRS requires the Company to establish accounting policies and to make estimates that affect both the amount and timing of the recording of assets, liabilities, revenues and expenses.

9. Related Party Transactions

During the nine months ended June 30, 2026, the Company incurred \$31,500 (2025 - \$31,500) for management fees to a company controlled by the Chief Executive Officer ("CEO").

As at June 30, 2026, the following balances were due to officers and directors and/or related companies:

- i) Included in accounts payable is \$118,755 (September 30, 2025 – \$85,680) due to a company controlled by the CEO of the Company. These amounts are unsecured, non-interest bearing and have no fixed terms of repayment.
- ii) Included in accounts payable and accrued liabilities is \$18,698 (September 30, 2025 - \$17,085) due to the CEO of the Company. These amounts are unsecured, non-interest bearing and have no fixed terms of repayment.
- iii) Loan payable of \$9,000 (September 30, 2025 - \$9,000) due to the CEO of the Company. These amounts are unsecured, non-interest bearing and have no fixed term of repayment.
- iv) Due from affiliated companies of \$3,000 (September 30, 2025 - \$nil) is due from companies with common directors of the Company. These amounts are unsecured, non-interest bearing and have no fixed terms of repayment.

On September 20, 2021, the Company entered into an agreement with a company controlled by a director to provide CEO services at a rate of \$3,500 per month (\$42,000 per year) for an indefinite term.

Fair value

The fair value of the Company's financial instruments approximates their carrying value as at June 30, 2026 because of the demand nature or short-term maturity of these instruments.

Financial risk management objectives and policies

The Company's financial instruments include cash and accounts payable. The risks associated with these financial instruments and the policies on how to mitigate these risks are set out below. Management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

Financial Risk

(i) Credit Risk

Credit risk arises from non-performance by counterparties of contractual financial obligations. The Company's maximum credit risk is primarily attributable to its cash. The Company limits its exposure to credit loss for cash by placing such instruments with financial institutions.

(ii) Liquidity Risk

The Company's approach to managing liquidity risk is to ensure that it will have sufficient financial resources to meet liabilities when due. As at June 30, 2026, the Company had working capital deficit of \$212,550. All of the Company's financial liabilities have contractual maturities of less than 30 days and are subject to normal trade terms.

(iii) Interest Rate Risk

In management's opinion, the Company's interest rate risk is minimal as the Company does not have any bank indebtedness or loans payable that bear interest at fixed or variable rates.

(iv) Commodity Price Risk

The Company is exposed to price risk with respect to commodity prices. The Company's ability to raise capital to fund exploration and development activities may be subject to risks associated with fluctuations in the market price of commodities.

11. Business Operations

The Company was incorporated on July 6, 2020 under the laws of British Columbia. The Company's principal business activities include the acquisition, exploration and development of resource property. The address of the Company's corporate office is 6153 Glendalough Pl., Vancouver, British Columbia, V6N 1S5, Canada.

At June 30, 2026, the Company had not yet determined whether its property contains ore reserves that are economically recoverable. The recoverability of amounts shown for exploration and evaluation assets is dependent upon the discovery of economically recoverable reserves, the ability of the Company to obtain necessary financing to complete the development, and upon future profitable production or proceeds from the disposition of the resource property.
