## FOCUS ON IDAHO

IDAHO is a land of many owners and many objectives.

Federal, state and local governments own and or manage the majority of forest lands in Idaho. A smaller portion of Idaho's forest lands are owned by thousands of private businesses, Native American tribes, families and individuals. Forest lands in Idaho and throughout the West present unique challenges because of the large influence of federal ownership and management. Whomever the owner, each entity has different objectives for the land — sometimes environmental and, when possible, economic. But when it comes to how the forest is managed, the landowner must balance their objectives for the land with legal requirements.



FACT: National forests occupy nearly 40% of Idaho's land mass, more than any other state.

FOREST FACT: Of the 21.5 million acres of total forestlands in Idaho, 16.5 million acres are designated as timberland. Of that number, only 9.3 million acres are available for harvest. [www.idahoforests.org](http://www.idahoforests.org)

## THE POWER OF PARTNERSHIPS

Good Neighbor Authority (GNA) enables the Forest Service to partner with the Idaho Department of Lands to achieve restoration and resilient landscape objectives across ownership boundaries through cooperative agreements.

The goal of GNA in Idaho is to increase the pace and scale of forest and watershed restoration activities on federal forests. These cooperative efforts can help improve foresthealth, reduce fuels and threats to communities and watersheds from catastrophic wildfires, and create more jobs and economic benefits, including providing more fiber to Idaho forest products markets.

One million forested acres are actively managed to make money for public schools and other Idaho institutions, and for their long-term health. Idaho Department of Lands regulates forest practices in the state and provide assistance to forest landowners and communities to promote healthy, productive forests for years to come.
