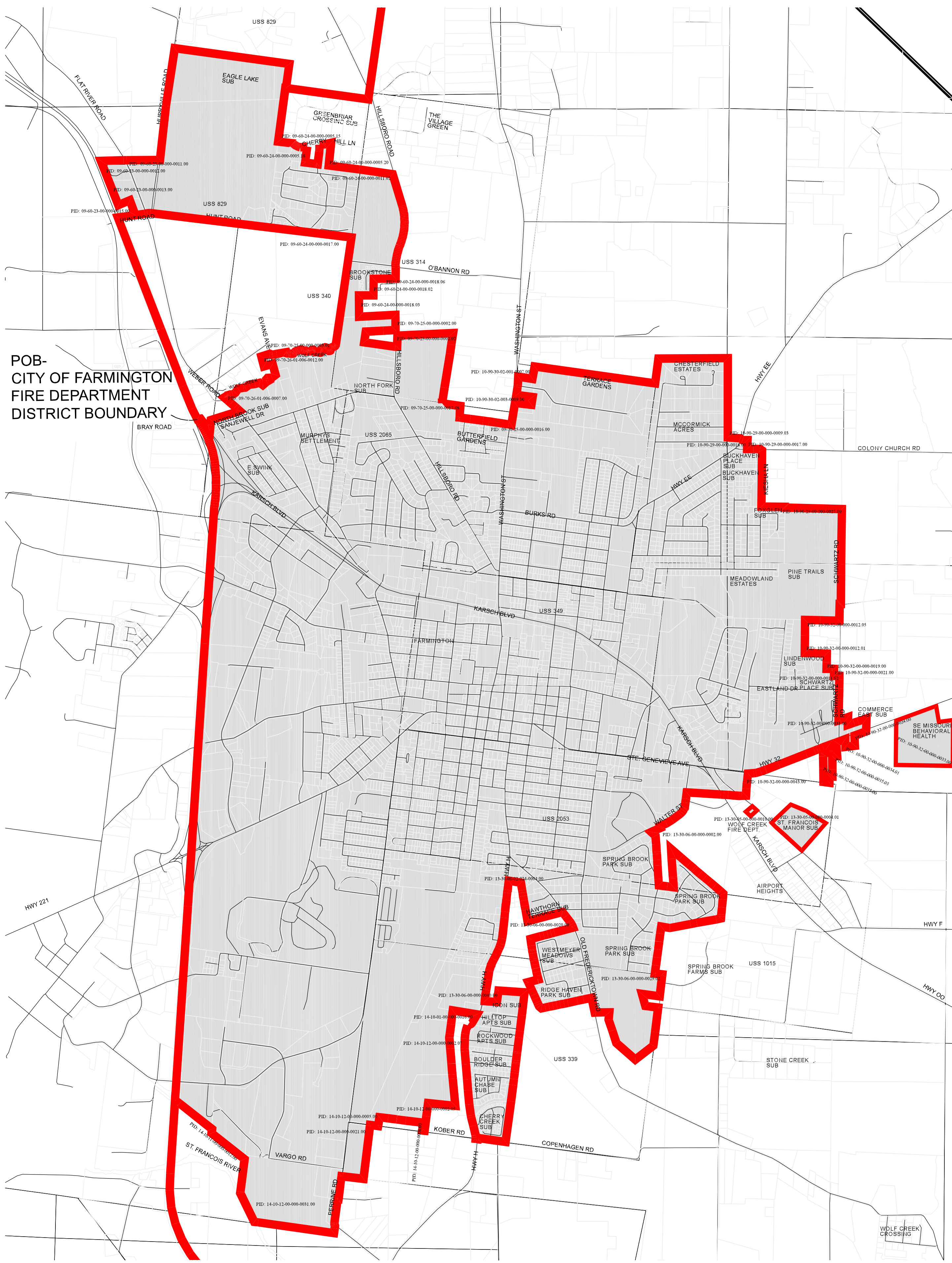


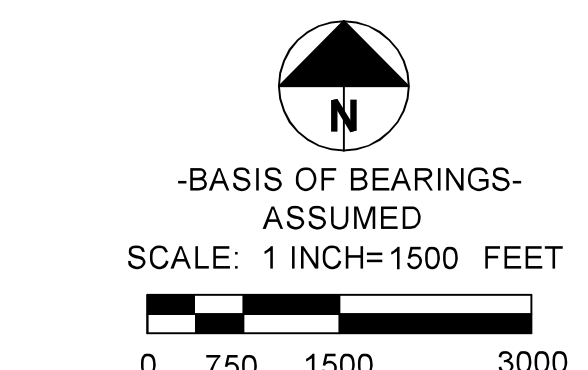
# CITY OF FARMINGTON FIRE DEPARTMENT DISTRICT BOUNDARY DESCRIPTION:

A TRACT OF LAND LOCATED IN ST. FRANCOIS COUNTY, MISSOURI, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
