If you would like to participate, this is what I need from you:

- Artist and Vendor application. Please be sure to fill out the application completely, as we cannot accept incomplete applications.
- A description of the products you plan to offer, as well as three photos – one of your booth and two of your products.
- Patience. Since this is a new event, we will need your patience. I will try my best to reply to all emails, texts, and phone calls in a timely matter.
- Let's get EXCITED! We have the potential to make Art in the Park HUGE! So, let's get excited and participate.

Booth reservations are now being accepted. To reserve your space, complete the attached form and send it, with your payment, to the address on the application. Each 10'x10' booth is \$50; electricity is available for an additional \$5. Payment can be made via Venmo, PayPal, check or cash.

Artist, Crafter and Food Vendor Guidelines

Thank you for your involvement in **Art in the Park** at the Lillian Recreational Park. We have many new things planned this year and we are very excited to have you join us for this year's inaugural **Art in the Park**.

The cost for participating in **Art in the Park** is \$50.00 per 10x10 booth space. If you need electricity, there is an additional \$5 fee.

Please be aware of the following general guidelines:

- All products must be handmade by the participating artist, crafter or food vendor. No exceptions.
- Hours of operation are 9 am to 4 pm.
- Please arrive in plenty of time to set up your booth and be ready to receive customers at 9 am.
- Each Artist/Crafter/Food Vendor will be assigned a 10'x10' space. You may purchase more than one space.
- You must provide your own tent, tables and chairs. If a tent is used, it **MUST** be weighted.
- All tables must be covered with either stretchable tablecloths or weighted tablecloths.
- There is no WI-FI or water available.
- For your safety and the safety of our customers, no vehicular traffic will be allowed inside the booth area from 9 am to 4 pm. Please park your vehicle in the designated vendor parking area after you have unloaded your vehicle.
- If cancellation of Art in the Park is necessary due to inclement weather, a notice will be posted on the Lillian Recreational Park Facebook page ("Lillian Recreational Park, Lillian, AL") by 6:30 am the day of the event. In case of cancellation, the show will be held the following day, Sunday.
- Permits, Licenses and Taxes: You are responsible for obtaining any necessary licenses and permits required for the sale of your product(s).
- Insurance: You are responsible for your own personal and product liability insurance.
- You must clean up and vacate your area by 5 pm. Everything brought to the site must be taken away, including, but not limited to, all trash, tents, chairs and vehicle.
