## 2025 Flea Market Vendor Guidelines

Thank you for your interest in the Flea Market at the Park at the Lillian Recreation Park. This year's flea market will be March 15, 2025, from 9 am to 2 pm.

The Park's address is 33914 Widell Avenue; Lillian, AL. (From Hwy 98, turn south at the Lillian Post Office onto Perdido St. Turn right onto Widell Ave.)

Please be aware of the following general guidelines:

### Set Up Times, Hours of Operation, and Cost per Space:

- Set up 6:30 a.m. to 8 a.m.
- Flea Market hours: 9 am to 2 pm.
- \$25 for a 10' x 10' booth space. If you want electricity, there is an additional \$10 fee. We also have some shade tents that can be rented for \$10, but they get spoken for fast, so make sure to request it as soon as possible.

### General Guidelines:

- Please submit your application and payment by March 7.
- Please arrive in time to set up and be ready to serve customers at the market's opening at 9.
- Each vendor will be assigned a 10'x10' space 2-3 days prior to event. Multiple spaces are available if desired.
- We accept cash, checks, PayPal (LillianRecreationalPark@gmail.com), and Venmo (@LillianRecreationalPark).
- You must provide your own tables, chairs, and tents/sun covers. If a tent is used, it MUST be weighted.
- All tables must be covered with either stretchable tablecloths or weighted tablecloths.
- There is no Wi-Fi.
- Please be mindful of the electric stations around the field when pulling in your vehicle to set up your booth. If you damage it, you will be responsible for paying for the repairs.
- For the safety of our customers, there is no vehicular traffic allowed inside the market area once we open for business. Vehicles should be moved to the designated parking area once unloaded.

Cancellation: If cancellation of the market is necessary due to inclement weather, it will be posted on the Lillian Recreational Park Facebook Page ("Lillian Recreational Park, Lillian, Alabama") by 7 am the day of the event. We will reschedule for the next day, so there are no refunds.

Permits, licenses and taxes: The Lillian Recreational Park does not require any permits or licenses to participate; however, you are responsible for obtaining any licenses and permits required by governmental entities for the sale of your product(s).

Insurance: You are responsible for your own personal and product liability insurance.

Clean-Up: You must clean up and vacate your stall by one hour after the flea market. Everything brought to the site must be taken away, including, but not limited to, all trash, tents, chairs, and vehicle.
