Thank you, in advance, for your interest in the Market in the Park at the Lillian Recreation Park. The fees for participating are listed below. There will be no markets in July and August. **We are always grateful for any additional donations to the Park**. Also, please share the date and times of the market with your friends and family and on social media.

The Lillian Recreational Park address is: 33914 Widell Ave., Lillian, AL. (From Hwy 98, turn south at the post office onto Perdido St. Turn right onto Widell Ave.)

Please be aware of the following general guidelines:

Set Up Times, Hours of Operation, and Cost per Space:

- Market in the Park Set up 7:00 a.m. to 9 a.m. Market 9 a.m. to 1 p.m. \$25 per space.
- November 16 Holiday Market. Set up 7:00 to 9 a.m. Event, 9 a.m. to 2 p.m. \$30 per space.

General Guidelines:

- Please arrive in time to set up and be ready to serve customers at the market's opening.
- Each vendor will be assigned a 10'x10' space 3-5 days prior to event. Multiple spaces are available if desired. We accept cash, checks, PayPal, and Venmo.
- Booth rental is \$25. If you would like access to electricity, there is an additional \$10 fee.
- Tent rental is \$10, if available. (Please contact Kelly Verret, market coordinator, for availability prior to paying.)
- You must provide your own tables, chairs, and tents/sun covers. If a tent is used, it MUST be weighted.
- All tables must be covered with either stretchable tablecloths or weighted tablecloths.
- There is no Wi-Fi.
- Please be mindful of the electric stations when pulling in your vehicle to set up your booth. If you damage it, you will be responsible for paying for the repairs.
- For the safety of our customers, there is no vehicular traffic allowed inside the market area once we open for business. Vehicles should be moved to the designated parking area once unloaded.

<u>Cancellation</u>: If cancellation of the market is necessary due to inclement weather, it will be posted on the Lillian Recreational Park Facebook Page ("Lillian Recreational Park, Lillian, Alabama") by 7 am the day of the event. There are no refunds. Payment moved to next market.

<u>Permits</u>, <u>licenses</u> and <u>taxes</u>: The Lillian Recreational Park does not require any permits or licenses to participate; however, you are responsible for obtaining any licenses and permits required by governmental entities for the sale of your product(s).

Insurance: You are responsible for your own personal and product liability insurance.

<u>Clean-Up:</u> You must clean up and vacate your stall by one hour after event. Everything brought to the site must be taken away, including, but not limited to, all trash, tents, chairs, and vehicle.

<u>Payment</u>: We accept cash, checks, PayPal (*LillianRecreationalPark@gmail.com*) and Venmo (@LillianRecreationalPark). Paying by check? Send to Lillian Recreational Park, PO Box 865; Lillian, AL 36549, along with your application. Payment must be made at the time you reserve your space and should be made 7 days prior to the event.
