Waiver of Liability

All participants over the age of 18 must sign below. For any participant who is 17 years of age or younger, these terms and conditions must be read and accepted by the legal guardian of the participants listed above.

I hereby absolve and release Pleasanton Valley Club (PVC) and all persons associated with the Club, of any responsibility or liability for any accident or injury of my participation and/or my child(ren), as a result of his/her/their participation in said activities.

In consideration for permission to access and use the Pleasanton Valley Swim Club facility and equipment ("the Facility") for my personal recreational use, I hereby release, waive, discharge and promise not to sue all persons associated with the Club, its members, employees, volunteers acting on its behalf of PVC, from any and all liability, claims demands, actions and causes of action whatsoever arising out of or related to any loss, damage or personal injury suffered or sustained by me or to any of my property, whether caused by the negligence of PVC or otherwise, while accessing or using the Facility. My use of the Facility is completely voluntary and at my own risk.

I understand that signing this waiver is required prior to my access and use of the Facility because such access and use will expose me to a variety of risks and dangers associated with the Facility. I further understand that the use of this facility, including but not limited to restrooms, showers, and high-touch equipment can all carry an added risk of exposure to contagions such as flu and Coronavirus/Covid-19. I represent that I am familiar with the risks associated generally with the use of high-touch equipment, with exercise and recreational activities, and the risks associated with the specific activities available at the Facility. I further represent that I understand that the risk of harm includes, in addition to bodily injury, sickness or death, the potential to cause and/or aggravate emotional distress. Knowing the risks associated with access and use of the Facility, as described above, nevertheless, I am voluntarily participating in these activities with knowledge of the danger involved, and I hereby agree to assume those risks and to release and hold harmless all of the persons and entities mentioned above.

Furthermore, I agree to indemnify, defend and hold harmless Pleasanton Valley Swim Club, from and against any damages suffered by me or to my property, or from and against any claim by a third party, arising out of, incident to, or in connection with my conduct while at the Facility whether or not such damages resulted in part from the negligence of PVC. It is further understood and agreed that this waiver, release, and assumption of risk is to be binding on my assignees, heirs, guardians, and legal representatives.

As a condition to permitting you to participate in any PVC Activity, Swim Team or Swim Club you agree as follows:

The undersigned acknowledges, appreciates, and agrees that there is a risk of contracting the COVID-19 virus as a result of my participation in PVC Activities, that the disease caused by the COVID-19 virus is serious and could result in my death, and that such risk cannot be eliminated. It is further understood and agreed that this waiver, release, and assumption of risk is to be binding on my assignees, heirs, guardians, and legal representatives.

Pool Safety Rules

Every member is expected to be aware of all safety rules and regulations (also posted on the website). The rules are to be followed during guarded and non-lifeguard hours. The Pleasanton Valley Club Board of Directors requests that every member cooperates in the collective enforcement of these rules and regulations.

POOL RULES

- Walk Only, No Running on the pool deck.
- No diving in the shallow end.
- No alcohol permitted at the facility.
- Do not hang on the lane separation lines.
- No roughhousing, horseplay or chicken fights.
- No twisting, flipping or jumping backwards into the pool from the deck.
- No Glass containers.
- Kickboards are only used for lap swimming.
- Coast Guard Approved Flotation Devices Only: Members shall provide their own Flotation Devices which must fit properly and be secured appropriately on the user. NO arm floaties or inner tubes, mats, etc. will be allowed.
- A parent or guardian MUST be in the water with the child at all times and within arm's reach.
- Water Balloons are not permitted in the pool. Grass area only.
- PVC Employees are only permitted for provided formalized swim instruction.
- All children must be under the supervision of an adult at all times.
- For your own safety, do not swim alone.

HEALTH & SAFETY RULES

- Persons having currently active diarrhea or who have had active diarrhea within the previous 14 days shall not be allowed to enter the pool water. If you feel ill, stay at home.
- No spitting on the decks or in the water.
- Children who are not potty-trained must wear a swim diaper
- Swimmers may not have an open wound, sores, or infection.
- Report all injuries to the lifeguard, no matter how small.
- Report all incidences of illness or accidents to the lifeguard.
- If the facility experiences a power outage, the pool will be cleared.
- Smoking is not allowed anywhere within the gates of the pool premises.
- No pets are allowed anywhere within the gates of the pool premises.

MEMBER CONDUCT POLICY

- Profanity, vulgarity, or improper behavior will not be tolerated.
- No loud or disorderly conduct. Any behavior resulting in a police complaint will be reported to the Board of Directors and may result in a loss of key privileges.
- Members are responsible for their guests and must stay on the property with their guests.
- Members are responsible for cleaning up their trash and belongings before they leave the club.
- PVC employees are only permitted to provide formalized swim instruction.

ENTRANCE POLICY

- While the lifeguard is on duty, children ages 12 and under are required to have adult supervision.
- When a lifeguard is not present, adult supervision for those under the age of 18 is required.
- It is the responsibility of the host member to inform guests to follow the rules and regulations.
- A swim test may be required to ensure the safety of members over the age of 12 to swim when a lifeguard is not present.
- Swimming privileges: (based on safety), the guard has the discretion to limit pool use or limit a section of the pool to be used by a swimmer.
- Parents are responsible for the conduct of members and guests under the age of 18.
- The childcare provider may accompany the children to the pool. They must be over the age of 16 and may not bring guests. Groups larger than 5 must notify management.
- Authorized personnel only in the pool office and pump room.
- Facility keys must remain in the members' possession and may not be loaned out to anyone.
- Members who loan or share their membership access key card will be subject to suspension of membership.
- Members are not permitted to prop open the front gate.
- All organized group events and parties must be cleared with the business office.
- Groups with minor children attending (birthday parties, sports parties, etc) require a lifeguard. Members holding unauthorized parties will be billed.
- Bike riding, skateboarding, and rollerblading is not permitted inside the facility.
- Violation of these rules and regulations may result in disciplinary action by the Board of Directors that could include loss of membership privileges.
