- □ Uniforms/protective clothing
- 🛘 Union fees and professional memberships
- \square Other work-related purchases
- 🗆 Self-education expenses
- \square Charitable donations (receipts for donations over \$2)
- 🛘 Income protection insurance premiums
- 🛘 Interest on investment loans (e.g. property, margin loans)
- ☐ Tax agent/accounting fees
- ☐ Child support payments
- \square Private health insurance details
- ☐ Interest paid on ATO debts
- 🗆 Superannuation contributions (personal, not employer)
