Cancellation Policy

If the Client cancels the scheduled services for any reason prior to the start date, the Client is strictly required to pay a non-refundable cancellation fee equal to 20% of the agreed-upon complete fee. Any remaining balance already paid above this 20% threshold will be refunded to the Client.

Confidentiality

The Provider shall maintain strict confidentiality regarding all aspects of the deployment. The Provider will keep the Client's event details, property layout, and personal or corporate identity entirely private. No information will be shared with third parties without prior written consent from the Client.

Limitation of Liability

The Provider performs duties to mitigate risk and enhance personal safety. The Provider is not liable for any damages to real or personal property during the term of services. Client releases Provider from any property damage claims arising during the performance of duties.

Governing Law

This Agreement and all services provided shall be governed by, and construed in accordance with, the laws of the State of Georgia in the Country of the United States of America.
