Grand Knight's Report



I came across this story and since we celebrate "Memorial Day" in May I thought it would be fitting to share it with everyone. I'm not sure if it's true or not, but does that really matter?

We in the United States have all heard the haunting song, "Taps." It's the song that gives us that lump in our throats and usually tears in our eyes. But, do you know the story behind the song? If not, I think you will be interested to find out about its humble

beginnings.

Reportedly, it all began in 1862 during the Civil War, when Union Army Captain Robert Ellicombe was with his men near Harris's Landing in Virginia. The Confederate Army was on the other side of the narrow strip of land. During the night, Captain Ellicombe heard the moans of a soldier who lay severely wounded on the field. Not knowing if it was a Union or Confederate soldier, the Captain decided to risk his life and bring the stricken man back for medical attention. Crawling on his stomach through the gunfire, the Captain reached the stricken soldier and began pulling him toward his encampment. When the Captain finally reached his own lines, he discovered it was actually a Confederate soldier, but the soldier was dead. The Captain lit a lantern and suddenly caught his breath and went numb with shock. In the dim light, he saw the face of the soldier, it was his own son. The boy had been studying music in the South when the war broke out. Without telling his father, the boy enlisted in the Confederate Army. The following morning, heartbroken, the father asked permission of his superiors to give his son a full military burial, despite his enemy status. His request was only partially granted. The Captain had asked if he could have a group of Army band members play a funeral dirge for his son at the funeral. The request was turned down since the soldier was a Confederate. But, out of respect for the father, they did say they could give him only one musician. The Captain chose a bugler. He asked the bugler to play a series of musical notes he had found on a piece of paper in the pocket of the dead youth's uniform. This wish was granted. The haunting melody, we now know as "Taps" ... used at military funerals was born. The words are:

Day is done . . . Gone the sun . . . From the lakes . . . From the hills . . . From the sky . . . All is well . . . Safely rest . . . God is nigh . . . Fading light . . . Dims the sight . . . And a star . . . Gems the sky . . . Gleaming bright . . . From afar . . . Drawing nigh . . . Falls the night . . . Thanks and praise . . . For our days . . . Neath the sun . . . Neath the stars . . . Neath the sky . . . As we go . . . This we know . . . God is nigh . . .

Don't Assume You Can't Afford Disability Income Insurance

One of the biggest mistakes you can make regarding disability insurance is to assume you can't afford it or you won't qualify. Before you make that assumption, do some basic research and apply for coverage through the Knights of Columbus. 1. Choose a two-year or five-year maximum benefit period.

An elimination period is the number of days a total disability must exist before benefits begin to accrue. Typical elimination periods are 30, 90, or 180 days. Why Do Catholics Worship Mary, the Mother of Jesus?

Today, the English word "worship" is not a good translation for the theological action of offering prayer and honor to God, Mary, or the saints in heaven. Generally, the word adoration in English is reserved for God alone. The word worship is derived from the West Saxon dialect. This word worship was used in a strong sense in relation to God. But it was also used in a weak sense in relation to man, for instance, "His Worship the Mayor", or "Your Worship" (when addressing a magistrate in Court), or the worship of the saints as distinct from the adoration of God. Adoration provides a clear unequivocal, therefore better, translation and expression of the absolute sacrificial reverence due to God alone.

The veneration and honor that Catholics give to Mary and the saints in heaven, therefore, is not equal to adoration reserved for God. Mary is understood to be a created being and therefore is not divine or equal to God.

The technical term used in worshiping God alone is the Latin word *latria*. For all other persons to whom *veneration* or honor is given, the Latin word dulia is used. Mary, through God's grace, had a uniquely important role in salvation history as well as living the greatest life of virtue, so she deserves the highest degree of veneration for any human being. She therefore has been given the title Hyperdulia, the greatest Dulia. But no matter how hyper she is, she still is not Latria, divine. Although held in the highest esteem and the most highly venerated of all the saints, she should not be viewed as equal to Jesus.

Mary is so highly honored because, in choosing her as the Mother of His Son, God exalted her above anyone else. Mary herself prophesied, "For he has looked upon his handmaid's lowliness; behold, from now on will all ages call me blessed. The mighty one has done great things for me, and holy is his name" (Luke 1:48-49).

Catholics should know that every bit of the glory given to Mary adds to the glory of her divine Son, just as Mary's soul magnified God. To worship Mary as divine, or honor her as one honors God, would be a disordered act, and may be sinful (depending on one's culpability).

Through our Lord Jesus Christ, your Son, who lives and reigns with you in the unity of the Holy Spirit, one God, for ever and ever.

In November 1991 ground breaking was held for the present Church of St. Rose of Lima. On December 24, 1992 the then-Bishop, Most Reverend John M. Smith, dedicated the Church. The Church has served the spiritual needs of Catholics of the central and northern parts of Santa Rosa County. Part of the beauty of the Church consists in the stain-glassed windows which adorn and add to the spiritual experience of those worshipping and visiting the Church.

If one looks up towards the heavens, one can see twelve circular stain-glass windows. These represent the twelve apostles. These articles will examines the twelve stain-glass windows, explains the symbolism of the images, and gives a short history of the saint, the feast day of the saint, along with the opening prayers from the Roman Missal for the feast day of the saint.

Council By-Laws: Article VII-Funds by SK Joe Scialdone, 2nd Year Trustee

This article is intended to provide clarification of the Council's funding regulations. Nothing contained herein should contradict the current By-Laws (adopted 3/13/2008), Laws and Rules of the Order, or the guidance of our current Grand Knight Rusty Bradberry. Our Council's By-Laws are the most restrictive funding guidance; however when they lack specific details for completing a task, our Worthy Grand Knight (WGK) can provide clarification to be used during his term. This is the case with the Funding Motion Form (FMF) which was implemented by our prior WGK John Recke, and agreed to by our current WGK on 7/3/2013. The FMF can be found at www.KofC7027.com

The Financial Secretary maintains a \$200 "Relief Fund" which can be used to assist any brother who is reported to be in distress, or in need of relief. There is a "Relief Committee," comprised of the WGK, Financial Secretary, and the Treasurer who is tasked with investigating the case of any brother in distress. If in the Relief Committee's judgment the brother is in need of relief, they have the power to draw from the Relief Fund to afford assistance (limited to a single case) in an amount not to exceed "\$100 be paid out without reference to and approval by the Council."

If the requested assistance is for an amount in excess of \$100 the case must be brought to the Council using our Funding Motion Form. Any time that a FMF is completed it must be presented at the first business ("planning") meeting of the month. The funding request at the planning meeting should be presented to the WGK using a FMF during the new business category. The submission at the planning meeting affords the Council's Board of Trustees time to evaluate the funding motion for appropriateness and budgetary reasonableness. The Trustees will then forward their "recommendation" to the FMF initiator prior to the regular business meeting during that same month.

If the FMF amount requested is in excess of \$500, the FMF must be read at one regular business meeting and then be voted on at a regular business meeting subsequent to the regular business meeting at which the FMF was introduced. In essence funding in excess of \$500, except for use in paying the Council's regular bills, will take two regular business meetings (or two months) to approve.

If any member requests that funds be allocated from an Activities Committee's Budgeted Funds, the initiator must submit the FMF to the Activity Chairman prior to the planning meeting for the month which the funds are requested. Although budgeted funds are already approved by the Council when the budget is approved, a FMF is required to provide a paper-trail of budgeted fund expenditures.

Your Council's current elective Board of Trustees are: Ron Winn, Joe Scialdone and John Recke; and are tasked with conducting semiannual period audits (in January and July) of the Council's finances². We work for you, and are available should you need further clarification.


