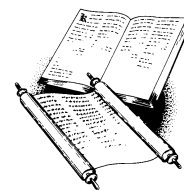

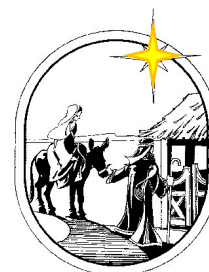

## DEACON'S TEACHING By Deacon Chris Christopher

### Emperor Constantine and His Mother Helena

#### Part II of II – St. Helena

**H**elena, or Saint Helena, as mother of Constantine the Great, became the Empress of the Roman Empire when her son assumed its sole control. She is

commemorated on May 21 in the East and August 18 in the West.

She was born in Asia Minor to parents of humble means in 248 or 250 AD. Little is known of her early life. She married Constantius Chlorus, and their son Constantine was born in 274. Constantius divorced her in 294 in order to further his political ambitions by marrying a woman of noble rank. Helena never remarried and lived for a time in obscurity, though close to her only son, who had a deep regard and affection for her.

Constantine was proclaimed Augustus of the Western Roman Empire in 306 by his father's troops after he died. Showing his mother Helena great honor and respect, he brought her back to the imperial court; she soon appeared in the Eagle Cameo portraying Constantine's family, probably commemorating the birth of Constantine's son Constantine II in the summer of 316.

She was granted the title "Augusta" in 325, died around 330 with her son at her side, and was buried in the Mausoleum of Helena, outside Rome on the Via Labicana.

Her sarcophagus is on display in the Pio-Clementine Vatican Museum, although the connection is often questioned. Next to her is

the sarcophagus of her granddaughter Saint Constantina (Saint Constance). Helena's skull is displayed in the Cathedral of Trier, in Germany.

In 313 Constantine and the Eastern Roman Emperor Licinius issued the Edict of Milan that guaranteed religious tolerance for Christians. Helena, who was by now a Christian, may have influenced him in this decision. After three hundred years of persecution, Christians could finally practice their faith without fear.

The emperor deeply revered the victory-bearing Sign of the Cross of the Lord, and wanted to find the actual Cross on which our Lord Jesus Christ was crucified. He appointed his mother Helena as Augusta Imperatrix and gave her unlimited access to the imperial treasury in order to locate the relics of Judeo-Christian tradition. Sending her to Jerusalem (326–328), he provided her with a letter to (St.) Macarius, Patriarch of Jerusalem

Although Helena was already in her declining years, she set about completing the task with enthusiasm. Searching for the Life-Creating Cross, she questioned both Christians and Jews, but her search remained unsuccessful. However, in 326, she was directed to an elderly Hebrew named Jude who stated that the Cross was buried at the Temple of Venus. Emperor Hadrian had the temple built during the 130s over the site of Jesus's tomb near Calvary. Accounts differ concerning whether the temple was dedicated to Venus or Jupiter.





According to tradition, Helena ordered the pagan temple demolished. After praying, the ground was excavated and soon the Tomb of the Lord was uncovered. Not far from it were three crosses, a board with the inscription ordered by Pilate, and the nails that had pierced the Lord's body.

In order to determine the true cross on which the Savior had been crucified, the empress refused to be swayed by anything short of solid proof and had Macarius perform a test. He had a woman who was near death brought from the city. When the woman touched the first and second crosses, her condition did not change, but when she touched the third and final cross she suddenly recovered. Helena declared the cross with which the woman had been touched to be the True Cross.

Having beheld the recovery from near death, everyone was convinced that the Life-Creating Cross was found. On the site of this discovery, Constantine ordered the building of the Church of the Holy Sepulcher.

In relying on the nails' miraculous power to aid her son, she allegedly had one placed in Constantine's helmet, and another in the bridle of his horse.

While in Jerusalem, Helena performed a variety of good works, including giving money to the poor. She also ordered that all places connected with the earthly life of the Lord and His All-Pure Mother be freed of all traces of paganism, and directed that more than 80 churches be built at each of these places. She gave the Life-Creating Cross to the Patriarch for safekeeping, retaining part of the wood and nails for taking back to Constantinople.

Helena left Jerusalem and the eastern provinces in 327 to return to Rome, bringing with her parts of the True Cross and other

relics. According to bishop and historian Eusebius of Caesarea, she was about 80 on her return from Palestine.

Tradition says that the site of the Vatican Gardens was spread with earth brought from Golgotha by Helena to symbolically unite the blood of Christ with that shed by thousands of early Christians who died in the persecutions of Nero. It is said on acquiring the Holy Tunic, Helena sent it to Trier.

According to Byzantine tradition, Helena is responsible for the large population of cats in Cyprus. Supposedly, she imported hundreds of cats from Egypt or Palestine in the fourth century to rid a monastery of snakes. The monastery is today known as "St. Nicholas of the Cats" and is located near Limassol.

Several relics purportedly discovered by Saint Helena are now in Cyprus, where she spent some time. Among them are items believed to be part of Jesus Christ's tunic, pieces of the holy cross, and pieces of the rope with which Jesus was tied on the Cross. The rope, considered to be the only relic of its kind, has been held at the Stavrovouni Monastery, which was also founded by Saint Helena.

Helena entered into the Eternal Kingdom in 327. Because of her great service to the Church and her efforts in finding the Life-Creating Cross, Empress Helena is called "*the Equal of the Apostles.*"

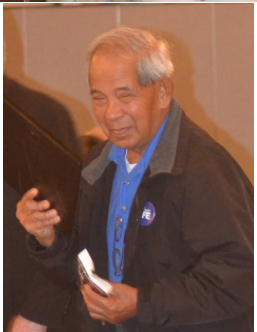

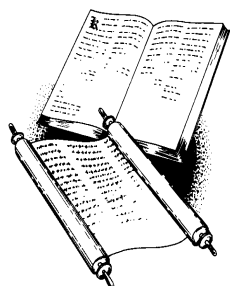

## Praying with the Church



At dusk, dawn, and noon I will grieve and complain, and my prayer will be heard. Ps 55:18

*Daniel ... continued ... to kneel in prayer and give thanks to his God in the upper chamber three times a day.* Dn 6:11

*He was praying in a certain place, and when he had finished, one of his disciples said to him,*

*"Lord, teach us to pray just as John taught his disciples."* Lk 11:1

**A**nd He taught them the Our Father to enhance their long tradition of praying the psalms multiple times a day. This rich tradition is handed on to us in the Liturgy of the Hours or Divine Office. Saint Rose of Lima will host a day to prayerfully experience this official prayer of the church on **Saturday, December 2, from 8 AM until 5:30 PM.** Msgr. Michael Reed and Sister Margaret Ann Calcutta will lead us deeper into praying and living the psalms. Lunch, Adoration of the Blessed Sacrament, Benediction, Confession and Mass will be part of the day. Whether you can stay the whole or only part of the day, plan to attend and learn by example to pray as the Church prays. A perfect addition to the Psalms study or for those with no experience praying the Liturgy of the Hours.

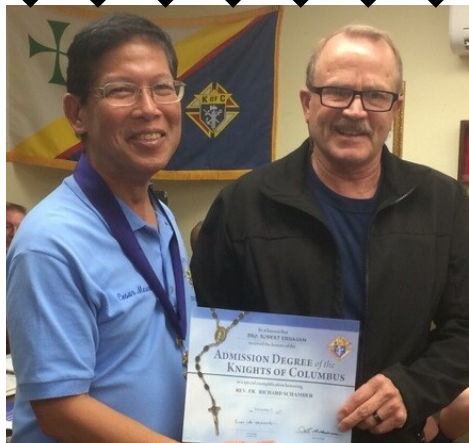
