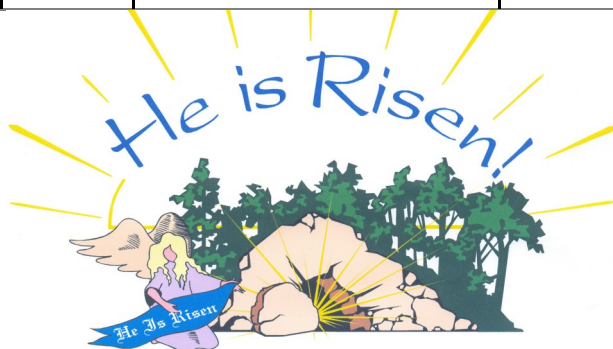

# Deacon's Teaching

## Holy Week and the Triduum

### HOLY WEEK

As we come to the close of our Lenten Season, we reach its climax during Holy Week beginning with Palm Sunday and ending with the Triduum. If you feel you haven't made much progress growing in holiness during this period, try to enter this final week with renewed enthusiasm, and maybe, just maybe, you'll catch on fire.

**Palm Sunday** commemorates our Lord's triumphant entry into Jerusalem just days before the completion of his earthly ministry of redemption for mankind as people placed palm branches on the road while He rode his donkey into town. Today, parishioners usually assemble outside the church where the palms are blessed, are handed out, and then everyone processes either around the church or nearby neighborhood behind the clergy and acolytes, all the while singing a familiar hymn of adoration.

However, another name for this day is **Passion Sunday**. Its name is appropriate because the Mass for this Sunday is on the passion of the Lord, the story of his arrest, trial, and death. Some interpret the term Passion Sunday as that extreme form of love (passion) that Jesus exhibits in redeeming mankind.

**Spy Wednesday** is a name for the Wednesday of Holy Week that alludes to Judas agreeing with the Sanhedrin to betray Jesus.

**THE TRIDUUM** (Latin for "three days.") is the *Great Three Days* of the last week of Lent, Thursday, Friday, and Saturday.

**Holy Thursday:** This day begins with **Maundy Thursday Mass**, an ancient English

name for Holy Thursday coming from the Latin, *Mandatum novum da nobis* (*I give you a new commandment* <sup>John 13:34</sup>) that began the ancient foot-washing ceremony. It is more commonly known as the Mass of the Last Supper.

This Mass opens as usual. The Gloria is sung, usually with bells ringing, but will not be heard again until the Easter Vigil on Saturday night. After the normal Liturgy of the Word, there is The Washing of the Feet by the celebrant. The Creed is not said, and the Liturgy of the Eucharist follows. Extra hosts are consecrated during this Mass for distribution on Good Friday. You will notice that the tabernacle door will left open and the ciborium containing extra consecrated hosts will be left on the altar and not reposed in the tabernacle after communion.

The Mass concludes with a procession of the Blessed Sacrament to the tabernacle of repose in the chapel where Eucharistic adoration is encouraged. The main altar is then stripped. **There is no final blessing or dismissal after this Mass.**

During that Last Supper, Jesus gave himself in the Eucharist, and instituted the ministerial priesthood to his apostles. It is a special day for all priests since it marks the origin of their ministry.

Liturgically, The Triduum is one-day beginning with this Holy Thursday Mass and ending with the Easter Vigil on Saturday night. As evidence of this, you'll notice that on Thursday there is the usual opening of Mass, but no final blessing and dismissal after it. At the Easter Vigil Mass on Saturday night, there is no usual opening of Mass because it occurred on Holy Thursday, but there is a final blessing and dismissal ending the liturgical one-day Triduum.



**Good Friday:** The Good Friday Service is the second day of the Easter Triduum that commemorates the crucifixion of Jesus. We don't genuflect as we enter church because the Blessed Sacrament is not present in the tabernacle, in fact, the tabernacle is usually left wide open.

Good Friday is a service, not a Mass - it is the commemoration of the death of Christ on the Cross. Its liturgy has three parts: the Liturgy of the Word, the Veneration of the Cross, and the Service of Communion.

The Gospel reading recalls the crucifixion of Jesus through the reading of the Passion according to John. Next follows the Veneration of the Cross whereby Catholics go to the sanctuary and reverence the cross by either kissing it, touching it, or giving it a bow. By this act, Catholics acknowledge the great sacrifice Jesus made for us. After this comes Communion. As this is a Service and not a Mass, the deacon will go to the chapel and retrieve the reserved Blessed Sacrament and bring it into the church. These are the extra sacred hosts consecrated on Holy Thursday.

At the end of the Good Friday service the ministers and assembly depart in silence and the altar is then stripped, but the cross remains.

**Holy Saturday:** This is a commemoration of the day that Jesus lay in his tomb and Masses are never offered. The Church waits at the Lord's tomb in prayer and fasting, meditating on his Passion, Death, Descent into hell, and awaiting his Resurrection.

**Easter Vigil:** A celebration of the *Feast of Feasts*, the *Solemnity of Solemnities*, because of Jesus' resurrection from the dead; it is the greatest feast day of the liturgical year, even greater than Christmas. For without Jesus' resurrection, he would have died just as any other prophet like so many before him. This vigil is a celebration from Darkness to the Light of Christ, the Resurrection. It is held after nightfall on Holy Saturday.

The celebration begins outside the church with the blessing of the fire from which the Pascal Candle representing Jesus' resurrection as the "*return of light into the world*," is lit. The candle is then taken in procession into the darkened church where parishioners are waiting with their own small, unlit candles. Once inside the church, parishioners' small candles are lit from the Pascal Candle as it is processed to the sanctuary. The deacon then sings the Exultet (The Easter Proclamation) after which the church lights are turned on and the parishioners extinguish their candles.

Next comes the Liturgy of the Word, a maximum of nine readings in all. After the last Old Testament reading, the Gloria is sung while bells are rung (according to local custom), followed by the New Testament readings and a short homily. After the homily the Litany of the Saints is sung.

If there are to be baptisms, this is when they take place after the water is blessed. The Creed is not said because the congregation recites its Renewal of Baptismal Promises. Next follows the Liturgy of the Eucharist.

Mass ends with a Solemn Blessing and dismissal, with a double alleluia, completing the liturgical, One-day Triduum.

Hopefully with the aid of this short outline, you'll be better able to see the continuity and significance of Holy Week and benefit from becoming more fully engaged in it. May you have a fruitful conclusion to Lent.

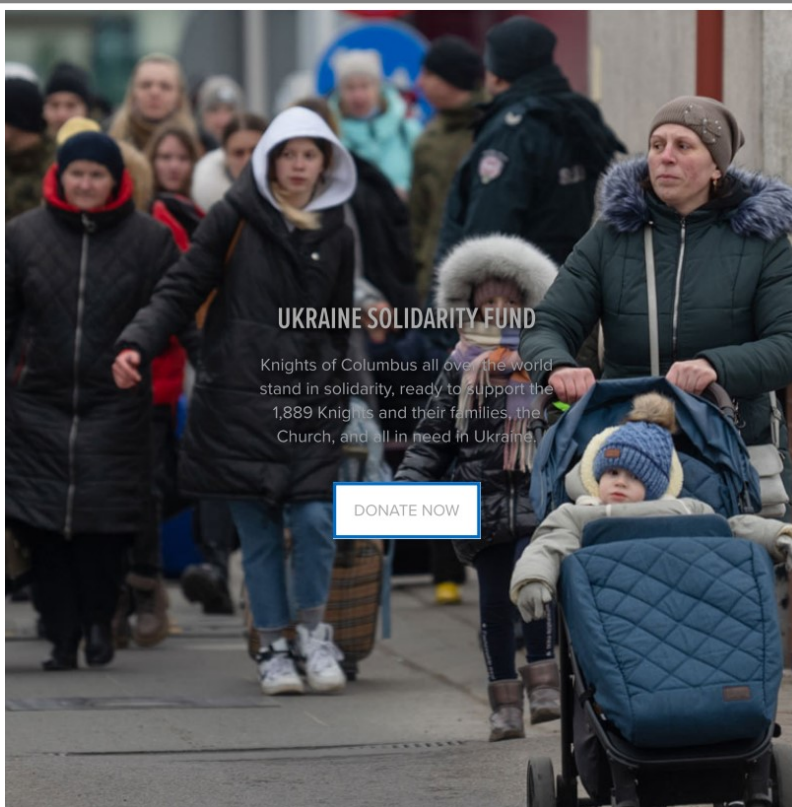

## The Image of The Divine Mercy



In 1931, our Lord appeared to St. Faustina in a vision. She saw Jesus clothed in a white garment with His right hand raised in blessing. His left hand was touching His garment in the area of the Heart, from where two large rays came forth, one red and the other pale. She gazed intently at the Lord in silence, her soul filled with awe, but also with great joy. Jesus said to her:

Paint an image according to the pattern you see, with the signature: Jesus, I trust in You. I promise that the soul that will venerate this image will not perish. I also promise victory over [its] enemies already here on earth, especially at the hour of death. I Myself will defend it as My own glory (*Diary*, 47, 48). I am offering people a vessel with which they are to keep coming for graces to the fountain of mercy. That vessel is this image with the signature: Jesus, I trust in You (327). I desire that this image be venerated, first in your chapel, and [then] throughout the world (47).

At the request of her spiritual director, St. Faustina asked the Lord about the meaning of the rays in the image. She heard these words in reply:

The two rays denote Blood and Water. The pale ray stands for the Water which makes souls righteous. The red ray stands for the Blood which is the life of souls. These two rays issued forth from the depths of My tender mercy when My agonized Heart was opened by a lance on the Cross. Happy is the one who will dwell in their shelter, for the just hand of God shall not lay hold of him (299). By means of this image I shall grant many graces to souls. It is to be a reminder of the demands of My

mercy, because even the strongest faith is of no avail without works (742).

These words indicate that the Image represents the graces of Divine Mercy poured out upon the world, especially through Baptism and the Eucharist.

Many different versions of this image have been painted, but our Lord made it clear that the painting itself is not what is important. When St. Faustina first saw the original image that was being painted under her direction, she wept in disappointment and complained to Jesus: "Who will paint You as beautiful as You are?" (313).

In answer, she heard these words: "Not in the beauty of the color, nor of the brush lies the greatness of this image, but in My grace" (313).

So, no matter which version of the image we prefer, we can be assured that it is a vehicle of God's grace if it is revered with trust in His mercy.

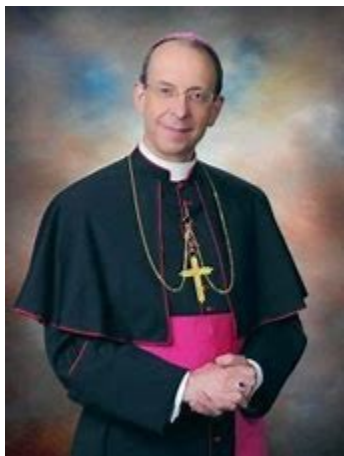

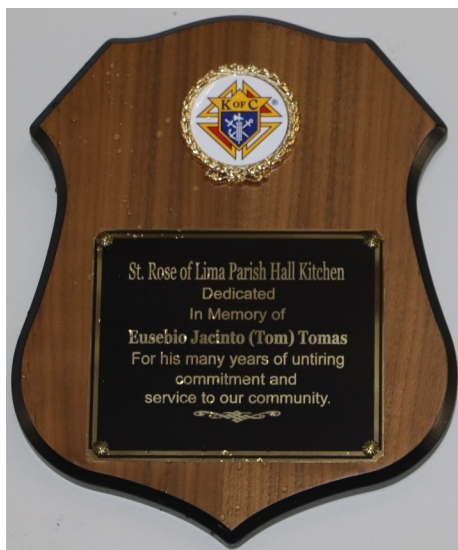

## Columbia Club of Milton, Inc. (CCMI) News

The CCMI Board of Directors is proposing to amend the articles of incorporation (by-laws) as amended on the 8th of February, 2017. A summary of the proposed changes is presented below, but first: **What is CCMI?**

The Columbia Club of Milton, Inc. is a not-for-profit corporation formed to own and manage the building and property located at 5470 Dogwood Drive in Milton ( the "Old Knights Hall") in support of the KofC Council 7027, its mission and that of the Order of the Knights of Columbus. Knights of Columbus councils are prohibited from owning property so the management of such property does not interfere with the goals of the Knights of Columbus.

The Corporation members are the members in good standing of the KofC Council 7027. The CCMI Board of Directors is elected by the membership and consists of 7 members; 4 officers and 3 directors or members-at-large. The Board of Directors is entrusted with the management of the Corporation and the control of its financial affairs. Any member of the KofC Council 7027 and is not an elected officer of the council is eligible to serve on the CCMI Board. The term of service for a CCMI board member is a minimum of 1 year but generally runs for 3 years. Current board members are: President, Michael Stafford; Vice President, Brian McQuire; Treasurer, Ralph Crago; Secretary, Rusty Bradberry; and Directors; Sid Roussell, Adam Rapach and Bruce Donatelli.

Currently the Dogwood property is under lease and a significant portion of the rent payments to CCMI are handed on to KofC Council 7027. For the financial details see the budget for Council 7027 in the document section of the member only part of the council website.

**Now the proposed significant changes** to the by-laws are presented for membership review and comment and will be voted on at the annual general membership meeting this summer. For a more comprehensive view of proposed changes please visit the Council 7027 website ([www.kofc7027.com](http://www.kofc7027.com)) in the document section of the member only part. The proposed changes are in **bold red** on the web document.

**Article VI, Section 2a:** Delete last sentence of (a) which reads: "A quorum for the Annual Meeting shall be (15%) of the membership , and not less than 35 members.

**Rationale:** A quorum as presently described is rarely met if ever. A "majority vote" as stated in the first sentence of (a) should stand.

**2b:** To read: " The term of an elected Director shall be for three years. One and two year terms may be utilized at the discretion of the Board to ensure continuity of corporate knowledge". **Rationale:** As it stands.

**2c:** Sentence added: "A Board member may not serve more than two consecutive terms". **Rationale:** As it stands.

**Article VI, Section 5a:** Change "The Board shall meet monthly" to "at a minimum of once a quarter". **Rationale:** Why meet if there is no business. A special meeting can be called at any time as specified in Article VI, Section 5b.

**Article VIII, Section 2:** Sentence added "Should the President and Vice President be unavailable the Secretary may be authorized to sign if the issuance of a check is of an urgent nature. **Rationale:** Check issuance requires 2 signatures, usually the treasurer and one other. This change allows for all board officers to have signing authority. Experience as shown that more than one Board Officer may not be available when a check issuance is needed.

**Article XI, Section 2:** Financial audit is changed from twice a year to at the least every 18 months and at the end of the Treasurer's term. **Rationale:** Accounting is straight forward and is not complicated to follow using "Quick Books". Only a few transactions are conducted each month and are repeated with the exception of tax related and insurance expenses.

## College Scholarship Opportunity for St. Rose High School Seniors

The Knights of Columbus, Council 7027 at St. Rose of Lima Catholic church will be offering three \$1,000 college scholarships to High School Seniors who are "registered" members of St. Rose of Lima parish and will be attending college in the Fall of 2022.

Three \$1,000 scholarships will be awarded based on the "thoroughness and effort" in completing the application packet as evaluated by an eight member Scholarship Committee.

Application packets will be on the church website and can be picked up at the Parish Office beginning April 4, 2022.
