#### Hello ladies,

I can't believe it's already the middle of March. Where has this year gone to?

I'm ready to get back to club work. I've had both of my vaccines but I must admit I'm still a little reluctant to get 'out there' since so many others have not. Los Cerritos District will probably not have in-person meetings until September so LBWC is not planning on a Summer Auction. It was suggested at the last meeting we can rename it to Fall or Winter Auction. I guess we'll still have to play it by ear.

**Are you 'Knitting Your Bit'?** I am. The scarves (6"x60") should be neutral in color and they're easily and rapidly done using large needles. These scarves will be going to VA Medical Centers throughout the country. When they're received they will store them for one month in quarantine to insure they will be covid-19 free before passing them on to a Veteran.

**Dues are due**. Here's the break-down: GFWC International dues - \$15.00; CFWC - State dues - \$4.00; Los Cerritos District - \$2.00; and \$17.00 goes into the clubs' treasury to be used for philanthropies and projects. That total is \$38.00 and with your dues you'll be a member of one of the largest women's service organizations in the world. GFWC has nearly 70,000 members throughout the United States and internationally.

**We provided an afternoon meal to RMcD House.** They are always so appreciative it's a pleasure to donate. I also took 13# of pop-tops. Keep saving them because they're still needed to bring awareness to the funding that helps to maintain the house.

**CFWC is holding workshops** throughout the month of March. 'March Madness' offers 10 Workshops on many chairmanships and you're invited to attend on ZOOM. I haven't seen the details yet but there will be workshops in April as well (and we've heard a rumor that our own **Julie Lehenbauer** will be leading one and that the last one in April will be with the past CFWC Presidents - we're pretty sure that Vicki might be a part of that one!).

**EQUAL RIGHTS AMENDMENT** - Urge Members of Congress to cosponsor bipartisan House Joint Resolution 17 and Senate Joint Resolution 1 to remove the deadline for ratification of the Equal Rights Amendment. In January 2020, the necessary three-quarters, or 38 states, ratified the proposed Equal Rights Amendment (ERA) as the 28th Amendment to the United States Constitution. Unfortunately, the United States Archivist refused to publish and certify the ratification based on a 2020 memorandum from the U.S. Department of Justice, Office of General Counsel, stating that the <u>deadline</u> had passed. <u>Deadline</u>? I can't believe we're still debating this resolution.

**April is National Child Abuse Prevention Month**. Nationally, neglect is the most common form of abuse. Three-out-of-five (nearly 61%) of victims were neglected only, more than 10% were physically abused only, and 7% were sexually abused only. These are very sad and shameful statistics.

Our next meeting will be at the Crab Pot in Long Beach on the  $24^{th}$  of March at 11:00 am. I hope to see you there.


