PROMOTION EXAMINATION AGREEMENT

I, the signed applicant on the reverse side (front) hereby agree to abide by and observe all the rules and regulations of the Atlantic-Pacific Tang Soo Do Federation and will accept any grade or belt rendered by the testing panel of the Federation with complete satisfaction, neither contesting nor demanding a higher grade or belt.

The Atlantic-Pacific Tang Soo Do Federation is obligated to furnish a competent judge and adequate facilities for the promotion examination and will also issue a certificate in accordance with the requirements listed in the current Student Manual. I also understand and agree that the promotion examination fee is not refundable under any circumstances.

RECOGNIZING THE STRENUOUS NATURE OF THIS ACTIVITY INVOLVES RISK OF INJURY, I AGREE TO HOLD THE ATLANTIC-PACIFIC TANG SOO DO FEDERATION, IT'S OFFICERS, INSTRUCTORS, TESTING EXAMINERS, GUESTS, AND MEMBERS FREE AND HARMLESS OF ANY LIABILITY OR DAMAGES.

I further agree that any pictures taken of or by me in connection with said test can be used by the Atlantic-Pacific Tang Soo Do Federation for publicity or promotion without compensation at this or any other time. If at any time, I violate any of the following "Conditions" expressly agreed upon between the Federation and I, I will hereby agree that the Atlantic-Pacific Tang Soo Do Federation reserves the right to withdraw and revoke any rank and/or status.

THEREFORE, I EXPRESSLY AGREE:

1. That I will strictly adhere to the attendance requirements of this school and participate in all classes, seminars, clinics and other activities to enhance my mental, physical and spiritual health; and to protect the honor and dignity of the Art of Tang Soo Do.
2. If I ever become inactive for a period of more than three (3) months or if I ever become lackadaisical in my training after this examination, my rank will be re-evaluated and demoted to the grade of novice.
3. That I am prohibited from using any Tang Soo Do techniques unless it reasonably appears necessary to defend myself or another against an apparent threat of unlawful and immediate violence from another.
4. That I will not engage in the instruction of the Art of Tang Soo Do in any form whatsoever and in any circumstance without the express written consent of the Atlantic-Pacific Tang Soo Do Federation.
5. That I will not engage in the demonstration of the Art of Tang Soo Do in any form whatsoever and in any circumstance without the express written consent of the Atlantic-Pacific Tang Soo Do Federation.

I have read and fully understand this agreement and this agreement contains all the terms and conditions agreed upon by the parties hereto, and no other agreements, oral or otherwise, regarding the subject matter of this agreement shall be deemed to exist or to bind any of the parties hereto.
