NOTABLE 2020 DEDUCTIONS

- Allowance of distributions from retirements accounts limited to \$100k or less without penalty due to age.
- Above the line deduction of \$300 for charitable contributions for those who do not itemize their deductions.
- The medical expense deduction remains at 7.5 % of income.
- It is important that clients submit pertinent deductions to the office. In some situations, especially for Maryland residents it may make sense to itemize on federal returns even if deductions are below the threshold to save on state income taxes.
- The single greatest tax "loophole" for most taxpayers is the deferral of up to \$19,500 in your retirement plan through your employer with a catch-up contribution of up to \$6,500 if you are over 50.

ELECTRONIC FILING

The 2021 IRS Electronic filing is scheduled to begin sometime in January and the timely filing deadline is April 15th. It is strongly encouraged that you file your taxes as soon as your documents are available. Please note that by law, tax refunds for returns that are eligible for the earned income credit and the refundable portion of the child tax credit cannot be issued until mid-February.

I urge parents of college students to file their taxes for them, since more often than not they can get the benefit of a greater educational deduction and the student must use the special dependent filing status for their taxes.
