# FINANCE

# REGISTRATION

INITIALS

### New Enrollees

New enrollees are required to pay a registration fee of \$80.00. The following are due at the time of enrollment: registration fee and documents, first week's tuition.

# **Continuing Students**

Continuing students must have a Information & Financial Handbook completed or acknowledgment. Information & Financial Handbook and registration fee must be submitted together.

# **TUITION PAYMENT PLANS**

INITIALS

Parents have the option of paying weekly or monthly. You will choose your method of payment at the beginning of your Contract. It will remain in effect until the end of our fiscal year (10 months. You may change your financial method when registering for the new school year. <u>ALL FEES ARE WEEKLY OR MONTHLY.</u>

Monthly: All fees are due by the  $5^{th}$  of the month. A late fee will be applied on the  $6^{th}$  of the month.

Weekly: All fees are due on Monday the week of attendance. A late fee will be applied at 6:30 A.M. Tuesday.

ONE TUITION-FREE WEEK: Your child may be absent for <u>ONLY</u> one week without tuition [illness, vacation, etc.] per 365 days.

### **TUITION COMMITMENT**

# **LEARNING MATERIALS FEE**

INITIALS

All students must pay a learning materials fee. This fee varies by age level due to the curriculum requirements.

1 - 2-year-olds	\$ 40.00
$2\frac{1}{2}$ – 4-year-olds	\$ 65.00
5-year-olds	\$100.00

# **LATE / COLLECTION FEES**

ΙΝΙΤΙΔΙ S

Not only is it important that all fees remain current, but they must be paid on time.

<u>Late fees are taken off the top of any payments</u> received.

Tuition late fee: \$35.00

Overtime late fee: \$25.00

Your weekly or monthly fee entitles your child to 10 hours per day – unless your program is subsidized. Should you exceed this time limit your account will be assessed the above fee.

\*Subsidized Care: hours should not exceed 52.50 hours. If your hours exceed 52.50 hours, a co-payment will be assessed and must be paid weekly on Monday.

Pick-Up: \$35.00 for the first 15 minutes; \$1.00 for every minute thereafter.

If an account goes unpaid for two weeks, the parents will be billed, and the bill will be due and payable upon receipt with a five-day grace period.

If the bill is not paid within five business days a \$35.00 late fee will be added to the outstanding balance for each week the tuition is not received. In addition, after 30-days interest for 24% of the total outstanding balance will accrue daily.

After 90-days the account is closed, and the Parent/Guardian of Signature (whoever signed the Contract) will be responsible for all accruing administrative costs, collection, and court fees.

We strongly encourage you to stay CURRENT on your fees.

# TWO-WEEK NOTICE

INITIALS

The provider may terminate the child's enrollment in the facility effective upon two (2 weeks prior written notice to the parent if any of the following conditions arise:

- (a) Any of the conditions listed above;
- (b) In the sole judgment of the Provider, Motivated Minds' program does not meet the developmental, behavioral, or special needs of a child;
- (c) Parent or child fails to abide by any of the terms, policies, rules, and regulations of the program; or
- (d) Provider ceases to operate the facility.

# **REFUNDS**

INITIALS

Registration and Materials fees are NON-REFUNDABLE. A refund will be issued on a monthly-prorated fee and will be refunded with a two-week written notice (refunded at the end of the two weeks - when all fees are paid in full).

# POLICIES

# **ALTERNATIVE PAYMENTS**

INITIAL

If you enroll your child in Motivated Minds under an Alternative Payment Plan, you are responsible for the following fees:

- 1. New Student Application Fee
- 2. Early / Continuing Registration
- 3. Late Paperwork Fee
- 4. Over-Time Fee
- 5. Return Check Fee
- 6. Withdrawal Fee
- 7. Field Trip Fees

If the program paying your tuition terminates, *for any reason*, you are responsible for any fees that accrue thereafter.

All paperwork for any alternative payment program is to be signed and given to the Director by the 3<sup>rd</sup> of every month no later than 6:00 P.M. If not received, you will be assessed a \$15.00 fee.

# WITHDRAWAL

When withdrawing from Motivated Minds, you must submit a Drop Form to the Director immediately to insure proper billing and/or refund.

Parents may terminate their Parent-Provider Agreement within two weeks with a two-week notice. If the child is withdrawn without the two-week notice, the Parent agrees to pay Provider the weekly/monthly fees for two weeks, in accordance with the fees, as per the signed Contract.

If the child is withdrawn with less than the stipulated two-week notice, the Parent agrees to pay the Provider for two weeks in accordance with monthly or weekly fees in the signed Contract. If the two-week notice falls in the middle of the week the full week is payable and will **NOT** be prorated.

# **CANCELLATION OF SERVICES**

ΙΝΙΤΙΔΙ

If the Provider cancels the Parent-Provider Agreement for any of the reasons listed below, <u>Weekly or</u> Monthly Fees will not be refunded.

The provider may terminate the child's enrollment in the Provider's program effective immediately upon written notice to the parent of such termination if any of the following conditions arise:

- (a) In the sole judgment of the Provider, the child's/parent's behavior is defiant, disrespectful, belligerent, or threatens the physical or mental health or well-being of one or more of the other children or staff at the facility,
- (b) Any payment owed by a parent to the provider is not paid within seven days of being due,
- (c) Child is picked up late more than five times in any 30-day period, or
- (d) On more than three occasions within any 30-day period, in the sole judgment of the Provider, the child shows evidence of obvious symptoms of illness, but not limited to runny nose, fever,

or vomiting, when brought to the facility or parent fails to pick up the child from facility promptly when notified by the provider that child is ill.

# RETURNED CHECK POLICY

INITIALS

Returned checks will be charged \$35.00. Each infraction will receive a separate invoice. Payment is due upon receipt in cash or money order – NO EXCEPTIONS. If payment is not received within 5 business days an additional \$35.00 late fee will be assessed to the outstanding balance for each week the fee is not received.

After 2 infractions tuition payments must be paid in cash or by money order for the remainder of the fiscal year.

# **DELINQUENCY POLICY**

INITIALS

Payments for delinquent balances must be paid in cash or money order ONLY - NO EXCEPTIONS.

Failure to comply with our Delinquency Policy will affect your child's placement in our daycare.

Motivated Minds reserves the right not to accept your child(ren) until your account becomes current.


# ILLNESS INITIALS


In the event your child is out due to illness, Motivated Minds will acknowledge a 1-time only dismissal of your weekly fees if the week (5 days) is missed. A note from your doctor must clearly state your child's name, and illness, and list the days of absence.

# **TUITION PAYMENT ENVELOPES**

INITIALS

Parents are to fill out the payment envelopes. Payment envelopes are to be deposited in the payment box. Payment envelopes are not to be handed to Motivated Minds staff. Please use the back of the envelope for comments about your payment.





# **MANDATORY SIGN-IN / OUT**

INITIALS

Parents are required to sign their child in and out daily - California Code 101229.1.

OFF SITE MEALS

INITIALS

If your child is eating any meal outside the documented mealtimes provided by Motivated Minds, their meal must be finished before arriving. This includes infant bottle feeding, and toddler and preschool-aged child's meal. (Please see Daily Schedule for MEALTIMES)

LUNCH

Motivated Minds will provide morning and afternoon snacks. Lunch must consist of a piece of fruit and vegetable, or two vegetables daily.

# MOTIVATED MINDS SPECIAL OCCASIONS

INITIALS

Motivated Minds staff is not available to change students' clothing or assist with grooming, including combing or brushing hair. You are welcome to stay and assist your child, however, he/she should arrive dressed for all special occasions.

# **BIRTHDAY PARTIES**

INITIALS

You are welcome to celebrate your child's birthday. Parties may be scheduled on Friday afternoon from 2:30-4:30 P.M., following naptime. This includes time for you to set up and clean up.

# AUTOMATIC DISMISSAL FROM MOTIVATED MINDS

INITIALS

Children who are absent from Motivated Minds for 3 consecutive days without any communication from the parent or guardian will automatically lose their enrollment status.

# **DOCTOR APPOINTMENTS**

INITIALS

Doctor appointments are not exempt from the 8:30 a.m. lock-out. Parents, please schedule appointments accordingly, (a) morning appointment – you must keep the child until 12:00 p.m. or (b) afternoon appointment – pick up at 12:00 p.m. Continuity of Motivated Minds' schedule is crucial and interruptions by drop off's or pick up's outside of the times provided is disruptive.

# AFTER SCHOOL PROGRAM

# NO MIDDAY DROP OFF OR EARLY PICK UP

INITIALS

Midday drop-off is disruptive to our schedule and is not allowed for any reason.

Motivated Minds does not pick children up early from school due to discipline issues or illness. Parents need to make the necessary arrangement for their child's pick up from school, no matter the emergency.

If your child is not picked up at the time of school dismissal, they are considered absent from the program for the day. Parents need to call the staff or write on the communication log if their child will be absent from school so we do not go to the campus looking for them.

# WINTER, SPRING, OR SUMMER SCHOOL RECESS

ΙΝΙΤΙΔΙ

If your child is attending after-school or is on Winter, Spring, or Summer recess, Motivated Minds will provide a morning and afternoon snack.

Parents, please be aware, that even though the child is on "recess" from school they still need to be here no later than 8:30 a.m. and must adhere to Motivated Minds' schedule.

Children enrolled in the program during the Winter, Spring, or Summer recess will be charged at the regular tuition rate.

Students are officially absent for the day if they are not dropped off and signed in by 12:30 P.M. and must stay with the parent or guardian.

If the door is locked when you arrive, please do not ring the bell, knock on the door, or call after 8:29 A.M. asking the staff to let you into the facility. We will not accommodate your request without proper

communication. A telephone call must be made to Motivated Minds before 8:29 A.M. because the telephone ringer is turned down in preparation for the school day.

Example: If the doors lock at 8:30 A.M. but you call Motivated Minds Childcare NO LATER THAN 8:29 A.M. and ask for more time, we will grant it. Coming to the door with an excuse is not a sufficient cause to let you into the facility.



### ILLNESS POLICY







# ILLNESS POLICY

This is a very important policy, and one in which we need to be particularly diligent. The law requires that ill children be excluded from school.

The signs we look for include: vomiting fever

diarrhea unidentifiable rash

colored mucous (yellow or green)

Children with these symptoms will be excluded from school and considered to be contagious unless we are otherwise notified by a doctor in writing. A child who is sent home from school or has had a fever, vomiting, diarrhea, or rash MUST be free from these symptoms for 24 hours before returning.

EXAMPLE: If your child is vomiting on Monday from 7:30 a.m. until 3:00 p.m. — they became symptom-free at 3:00 p.m. and may return to Motivated Minds on Wednesday, unless symptoms return.

If we call you to pick up your child due to illness, you need to do so within an hour. We understand that you need to work but we have to take the entire class population into consideration. If we allow ill children to attend, then the rest of the children are exposed as well as the staff.

We appreciate your adherence to these policies. We have your child's best interest at heart. Thank you for helping us maintain a safe and healthy environment for ALL of our "Bundles of Joy".
