



New England/New Hampshire Rebellion Women's Tackle Football 2026 Player Contract

This contract provides information about the New England/New Hampshire Rebellion (the "Team"), a member team of the American Women's Football League (the "AWFL"). By signing this contract, you agree to follow all Team and AWFL rules and policies. Any player who violates these policies may be subject to disciplinary action, up to and including removal from the team.

PROFESSIONAL CONDUCT

As a member of the New England/New Hampshire Rebellion, you represent the Team at all times. We expect professional behavior whether you are a player, coach, or staff member. This includes when you wear Team uniforms or apparel, post on social media, or participate in any Team activities (practices, games, events, fundraisers, etc.). Maintain a positive attitude and treat teammates, coaches, staff, volunteers, fans, opponents, vendors, sponsors, and AWFL representatives with respect. Negative or disrespectful comments in any forum, including social media, may result in disciplinary action.

ATTENDANCE AND PARTICIPATION

Players must arrive on time and participate fully in all scheduled activities, including fundraisers, training camps, team meetings, practices, games, and community events. The Team's success depends on each player's commitment. Missing scheduled practices without notifying the owner or coach may result in fines, reduced playing time, additional conditioning, or removal from the team.

PLAYER STATUS

Players are not employees of the Team. Your relationship with the Team is voluntary and "at-will," meaning either you or the Team may end this relationship at any time, for any reason or no reason. If you choose to leave the team, please provide notice to team leadership.



TEAM EXCLUSIVITY

During the term of this contract, you may not play for or be associated with any other professional or semi-professional women's football team without express written permission from the Team.

UNIFORM AND DRESS CODE

Players must wear the complete Team uniform during all exhibition, preseason, regular season, and post-season games. You must also wear Team-designated attire for pregame activities, fundraisers, and promotional events. Failure to comply with the uniform policy will result in suspension from participation until the policy is met.

INJURY AND MEDICAL CARE

If you are injured during a Team activity and are asked to seek medical attention, you must do so before returning to participation. All players must follow the advice of medical personnel.

HEALTH INSURANCE REQUIREMENT

All players must maintain valid health insurance throughout their entire time with the Team. The Team does not provide health insurance coverage for players. You are responsible for all medical treatment costs if you are injured.

FEES, AWFL REGISTRATION, AND EXPENSES

Team Fees:

By signing this contract, you agree to pay the following fees to the Team:

- \$100 – Payment due on or before December 15, 2025
- \$150 – Payment due on or before January 15, 2026
- \$150 – Payment due on or before February 15, 2026
- \$150 – Payment due on or before March 15, 2026
- \$100 – Payment due on or before April 10, 2026

Total Team Fees: \$650



Fundraising Opportunities: Team fees can be offset through fundraising activities and sponsorships. Players are encouraged to participate in team fundraisers or seek individual sponsors to help reduce out-of-pocket expenses.

AWFL Registration:

You must register with the American Women's Football League (AWFL) and pay the registration fee of \$25 directly to the AWFL on HostedSports.com.

Travel Expenses:

The Team does not cover travel expenses. You are responsible for your own transportation, meals, and lodging for away games.

Important: All fees are non-refundable.

PUBLICITY AND MEDIA RIGHTS

You grant the Team and the AWFL permission to use your name, signature, likeness, and photographs for all publicity and promotional purposes. You may not engage in promotional, advertising, sponsorship, or other commercial activities using the Team or AWFL name, logos, trademarks, or copyrights without prior written permission from both the Team and the AWFL.

CONFIDENTIALITY

Information shared internally with Team members is strictly confidential unless otherwise specified. This includes playbooks, game film, operational information, and other materials not intended for public use. This confidentiality obligation continues even after you leave the Team, regardless of the reason for your departure.



ABOUT THE AMERICAN WOMEN'S FOOTBALL LEAGUE (AWFL)

The New England/New Hampshire Rebellion is a proud member of the American Women's Football League (AWFL). The AWFL is a national organization dedicated to women's tackle football, consisting of teams across the country.

AWFL Registration Benefits:

Once you register with the AWFL (registration fee: \$25), you will:

- • Be added to the Team's official roster
- • Be eligible to play in the 2026 season
- • Be eligible for AWFL awards and recognition
- • Receive access to game film and league resources

For more information about the AWFL, including league rules and bylaws, visit the AWFL website or contact team leadership.

AWFL Playoff Eligibility:

To be eligible to compete in playoff games, players must be dressed in uniform and present at a minimum of 3 regular season games. Being present on the sidelines in your assigned jersey counts toward eligibility, even if you do not play in the game.

PLAYER AGREEMENT AND SIGNATURE

I have read and understand this contract. I agree to play for the New England/New Hampshire Rebellion in the American Women's Football League (AWFL) for the 2026 season. I agree to follow all Team and AWFL rules, policies, and codes of conduct. I will not sign a contract with any other team during the 2026 season. I release the Team, its officials, players, personnel, coaches, trainers, medical staff, general manager, owner, and spectators from any and all liability for accidents or injuries I may suffer as a result of my participation.

I agree to pay all team fees and AWFL registration fees. I understand that I may fundraise or seek sponsorships to reduce my personal expenses. I understand that all fees must be paid in full by April 10, 2026, and that all fees are non-refundable.
