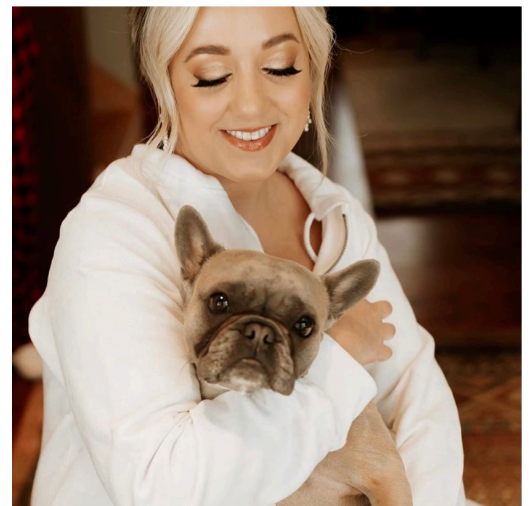
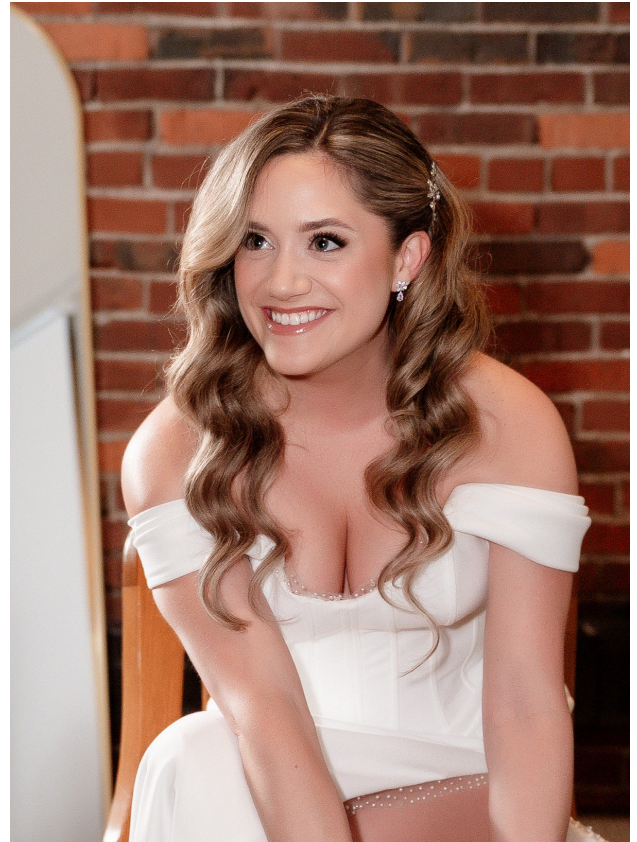
## *Policies*

**THE CONTRACT:** will be signed by the person booking services for a particular session, and will specify the location, date, time, number of persons receiving makeup and/or hair services. Due to the possibility of schedule conflicts, additional services added after contract signing or changes made to the location, date, and time of event will be done at the sole discretion of artist, Julia Hofmeister. This contract is the only agreement between the person(s) booking / contracting the services of Julia Hofmeister [hereafter referred to as Client(s)] and Julia Hofmeister(Nikd Beauty) [make-up artist].

**BOOKINGS:** To secure a date, a signed bridal contract and \$100.00 retainer are required. This deposit is non-refundable and non-transferable. This deposit will be put toward the client's total wedding day balance if the client chooses wedding day services. This amount can also be used to cover the cost of the trial run. The remaining balance will be due on or before the day of the event. Accepted forms of payment include: cash, or check, or venmo/ paypal. The retainer fee is required to book the date desired. Please be advised, dates and scheduled makeup times will only be reserved when a signed contract and retainer are received. An Early Morning fee of \$50 per hour (per artist) for each hour prior to 8 am will be added *when applicable*.

For larger parties or parties with limited time to get ready, an Assistant artist and/or additional stylist will be needed. The additional flat rate for an extra stylist is \$100. The cost per each makeup application still applies. The need for an assistant(s) will be pre-determined when signing the contract will be and based on head count and time frame (finish time). If finish time is not yet determined, the need for an additional artist or any changes afterwards are at the discretion of the artist.

**PREVIEW & TRIAL:** Trials are available for brides as well as their bridal party members. Previews and trial runs are held at my studio OR on location if desired. Any trials will be subject to an additional \$50 travel fee + mileage if the client is not willing to come to my studio space.





**SATISFACTION GUARANTEED:** Makeup will be completed to the client's satisfaction, and acceptance of the completed makeup application is acknowledgement by the client that the makeup is done to their satisfaction.

**TRAVEL FEES:** There must be a minimum of 4 faces under contract for on-site makeup services on your wedding day. Any on-site services will be subject to a base fee of \$125 + mileage. Travel within 10 miles of 15129 (Pittsburgh, Pennsylvania) is completely free of mileage charge. Any travel outside of this radius is subject to a fee of \$1/mile. This applies for round trip travel- both to and from the getting ready venue.

Example: Venue is 40 miles away,  $40 \text{ mi} \times 2(\text{round trip}) = 80 \text{ miles } \$80$

Any location over 100 miles (one way) will require a hotel stay, which is paid for (in full) by the client.



**PARKING/TOLLS:** Where parking, valet or toll fees may be incurred; the amount will be included with the final bill and due for payment on the day of the event.

**LIABILITY:** All brushes, tools, and makeup products are sanitized between every makeup application. Makeup products used are hypoallergenic. Any allergies and/or skin conditions should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client(s) agree to release the makeup artist, Julia Hofmeister, and Nikd Beauty Studio, its owners, and all employees and agents

from liability for any complications due to allergic reactions or sensitivities.



**PAYMENT:** The final balance is due on or before the day of the event before the makeup artist departs — no exceptions. The person(s) responsible for the entire balance of payment is the person(s) whose name(s) appear on this contract. If bridesmaids, others, are paying separately, it will be the duty of the contract holder to gather payments from those responsible and submit to the MUA in the amount of the contract.

**DELAYS:** A late fee of \$50 will be charged for every 30 minutes of delay when a client is late for set start time, or if scheduled makeup exceeds allotted time because of client delays or added services. If a client in the wedding party wants to add on a makeup service day of the wedding, they will be subject to normal application cost plus late fee of \$50.

**CANCELLATION POLICY:** Cancellations must be made at least sixty (60) days prior to the client's reserved date or the client will be held responsible for paying the full amount of services agreed upon in this contract. If makeup artist cancels at any time or is unable to perform services on the date of the event for any reason, 100% of the retainer paid will be refunded by the client's preference of check, paypal, or venmo immediately upon cancellation.

**SEVERABILITY:** If any provision or provisions of this Agreement shall be held to be invalid, illegal, unenforceable or in conflict with any of the law(s) of any jurisdiction, the validity, legality and enforceability of the remaining provisions shall not in any way be affected or impaired thereby.

Please submit contract below in full. If finish times are not yet known, an estimate can be made until the day of coordination timeline is finalized. Please be aware any extra artist fees and early start fees will be determined and added at a later date if timeline is not yet established.
