#### What do our finances look like:

In the financial year 2025/26 so far:

Income: £13 in bank interest! (Money from Lilbourne windfarm, c£1,500, is paid in Jan each year).

Expenditure £528. £172 on defib spares, £103 flowers for planters, Elizabeth Tree sign £250

In addition, we have spent £1,475 on the allotment fence (in line with Josh's circulated proposal after the last meeting), and funds for this have been received from the Eight Parishes CIC (Swinford Windfarm).

The balance in our account is currently just over £2,500.

## **Village Finance Governance**

After the last Village Meeting in May, it became clear that the Village Meeting needs a simpler and clearer way to apply for funds and decide how they are used.

It was agreed that we should create a Funding Request Form (FRF). I received two suggested versions and have now combined them into one simple form. From the discussions at the last meeting and afterwards, it seems the main issue comes up when larger amounts of money are requested. Smaller spending, such as for Halloween or the Christmas Lights switch-on, continues to run smoothly.

It is proposed that any spending over £400 should include a completed Funding Request Form. This will then be discussed and voted on at the next Village Meeting. Once a FRF has been completed and reviewed by the Village Meeting Chair, it will be shared with villagers before the meeting.

For spending under £400 that has already been agreed in principle, it makes sense to keep things flexible. The details can be agreed between meetings on the Village WhatsApp group. These decisions will then be noted in the minutes of the next meeting.

The Funding Request Form is available from Quintin, and I will post a copy on the WhatsApp group and the Village website.

#### Questions

- 1. Will there be any exceptions to the £400 limit, for example, for time-sensitive events?
- 2. How should we approve small, unexpected costs (under £100) between meetings? For example, the Halloween Party was not originally approved at a Village Meeting.

# Conduct at meetings and village discussions

It is important that all residents have an equal voice in decisions that affect the village, and some residents have said that they felt uncomfortable with the tone of the discussion at the meeting and afterwards, including on WhatsApp.

I am sure you will join me in wanting to make sure that our meetings and discussions remain fair and respectful, giving everyone the chance to speak and be heard — even when we disagree.

## **Harborough District Council**

In December 2024, the Government announced plans to change how local councils are organised. The aim is for all areas that currently have both district and county councils — like Leicestershire — to move to a single level of local government, known as a **unitary authority**. This is intended to make local government simpler and more efficient.

Two different proposals have been put to the Government:

- 1. Keep the City and County Councils and remove the District Councils, such as Harborough; or
- 2. Create three new councils **North Leicestershire**, **South Leicestershire**, and **Leicester City**. No timetable has been set, but the changes are expected to take effect around **April 2027**.

Separately, Harborough District Council will also be reviewing the boundaries of parish councils and parish meetings. I will share more information when the review begins.
