

Terms and Conditions

By bringing my vehicle to LC Repair and/or entering the premises at 410 S Wyandotte St, Locust Grove, OK, I agree to the following terms and conditions:

1. Assumption of Risk: I acknowledge that automotive repair and maintenance involve inherent risks, including but not limited to potential damage to my vehicle, mechanical failure, or personal injury. I assume all risks associated with the repair, maintenance, or storage of my vehicle at LC Repair, as well as my presence or the presence of others I bring onto the premises.
2. Release of Liability for Vehicle Damage: I hereby release, waive, and discharge LC Repair, its owners, employees, agents, and affiliates from any and all liability, claims, demands, or causes of action for any damage, loss, or destruction to my vehicle, whether caused by negligence, acts of God, or any other cause, while the vehicle is on LC Repair's premises or under its care, custody, or control, except to the extent caused by the gross negligence or willful misconduct of LC Repair.
3. Release of Liability for Personal Injury: I hereby release, waive, and discharge LC Repair, its owners, employees, agents, and affiliates from any and all liability, claims, demands, or causes of action for any personal injury, harm, or death to myself or any person I bring onto the premises, whether caused by negligence, hazardous conditions, equipment failure, or any other cause, while on LC Repair's property, except to the extent caused by the gross negligence or willful misconduct of LC Repair.
4. Refusal of Recommended Services: If I refuse any service(s) or repair(s) recommended by LC Repair, I acknowledge that such refusal may result in unsafe vehicle operation, further damage to the vehicle, or other risks, including but not limited to mechanical failure, accidents, injury, or death. I release LC Repair from any liability for damages or injuries resulting from my refusal of recommended service(s) or repair(s).
5. Vehicle Retention for Non-Payment: I agree that LC Repair may retain possession of my vehicle indefinitely until all charges for services, repairs, parts, labor, storage, or other fees owed to LC Repair are paid in full. I understand that LC Repair may exercise its possessory lien rights under Oklahoma law (e.g., Oklahoma Statutes Title 42) to hold the vehicle until payment is received. I waive any claims against LC Repair for costs, damages, or losses (including but not limited to loss of use of the vehicle) arising from the retention of my vehicle due to non-payment.
6. Storage Fees: If payment is not received within 7 days after completion of services, I agree that LC Repair may charge storage fees of \$25 per day for the continued storage of my vehicle. These fees will be added to the total amount owed.
7. Payment for Services Regardless of Outcome: I agree to pay for all services, repairs, parts, and labor performed by LC Repair as agreed upon, regardless of whether the services or repairs resolve the vehicle's issue(s) or achieve the desired outcome. I acknowledge that automotive repairs may not always resolve underlying issues due to factors beyond LC Repair's control, such as the vehicle's condition, hidden defects, or other mechanical complexities. I hereby release, waive, and discharge LC Repair, its owners, employees, agents, and affiliates from any and all liability, claims, demands, or causes of action arising from the failure of services or repairs to resolve the vehicle's issue(s), except to the extent caused by the gross negligence or willful misconduct of LC Repair.
8. Hold Harmless and Indemnification: I agree to indemnify and hold harmless LC Repair, its owners, employees, agents, and affiliates from any claims, damages, losses, or expenses (including attorney fees) arising from my vehicle's condition, my actions, or the actions of any person I bring onto the premises.
9. Limitation of Liability: To the fullest extent permitted by law, LC Repair's liability for any claim related to the vehicle or my presence on the premises shall be limited to the amount paid for services rendered. LC Repair shall not be liable for any consequential, incidental, or punitive damages.
10. Customer Property: I acknowledge that LC Repair is not responsible for any personal property left in my vehicle or on the premises, including but not limited to valuables, electronics, or other items, and I release LC Repair from any liability for loss, theft, or damage to such property.
11. Authorization: I confirm that I am the owner of the vehicle or have the legal authority to authorize repairs and agree to these terms on behalf of the vehicle owner.
12. Anyone on the premises that does not agree to these terms and conditions is trespassing.
