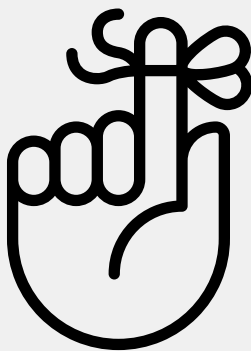

THESE BYLAWS NEED TO BE FOLLOWED

QUORUM - Article VI, Section 6.04

At least 10 current members must be present before we can conduct business or vote.

PROGRAM ATTENDANCE - Article VIII, Section 8.02(d)

Organizations are requested to send a representative to every general membership meeting.

FUNDING-REQUEST ATTENDANCE - Article VII, Section 7.03(b)

A requesting program must be represented when its funding request is reviewed.

FINANCIAL RECORDS Article VIII, Section 8.02(a-c)

- Deposits require completed cash count sheets.
- Programs must maintain complete bookkeeping records.
- Expenditures require completed check requests.

THESE ARE NOT NEW RULES.

Consistent participation and complete records are necessary for Booster support.

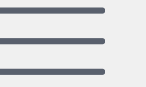
