EU and EIC officials agree to raise efforts to reach ESG goals

September 30, 2021, Prishtina

Environmental, Social, and Corporate Governance (ESG) is the European initiative that aims to foster long-term sustainable and responsible corporate behaviour across the EU to support and drive many of the EU's other flagship ESG policies. Efforts of Kosovo in achieving ESG goals, was a topic of discussion the European Investors Council CEO, Mr. Emrush Ujkani, the ProCredit Bank CEO and at the same time the EU Relations Director of EIC, Ms. Eriola Bibolli, and the representative of the Raiffeisen Bank, Ms. Antigona Limani had with the EU Office representatives in



Kosovo. Ms. AnnaCarin Platon-Head of political, Economic and European Integration Section and Mr. Miran Vatovec-Policy officer Political, Economic and European Integration section. There were other important issues raised in the meeting

such as strengthening the co-operating between the EU office and the EIC in addressing needs of the private sector in Kosovo. They also talked about the election for the new Board Members of EIC and preparations for the White Book 2021, a publication that contains legal and economic expertise, recommendations and analysis of progress in key economic sectors, which is due to be published in the upcoming months.

$Business\,associations\,met\,with\,EBRD\,high\,officials$

The new five years strategy of the European Bank for Reconstructions and Development was discussed between EBRD high officials and Kosovo business associations. The meeting was led by Mr. Pierre Heilbronn-EBRD deputy President for Policy and Partnership, Mr. Jens Lundsgaard- Director of the Board for Denmark, Lithuania, Ireland, and Kosovo, Oleg Levitin- Deputy Director of Governance and Political Affairs, and Neil Taylor-Resident Head of the EBRD Office in Kosovo. In this meeting that was held with the European Investors Council (EIC); National Council for Economy and Investment (NCEI); American Chamber of Commerce in Kosovo

(AmCham); and German Chamber of Commerce (KDWV). In the core of discussion was the need for cooperation in driving further the digitalization process, renewable resources and energy efficiency, and connecting vocational training with the labor market. Business associations unfolded their ideas on private sector development plan.

A huge legal step is on the way towards digital economy

• The Kosovo Parliament has reviewed the Draft Law on Electronic Identification and Trusted Services in Electronic Transactions

Electronic Identification and Trusted Services in Electronic Transactions is key for digitalizing the economy. In the last week of September, this draft law has been reviewed by the Commission for Economy, Industry, Entrepreneurship and Trade.

The law aims to regulate the Digital Identity Portfolio, define conditions for the use of electronic signature, electronic stamp, electronic documents and others. During the public hearing, the deputy chairwoman of the commission, Ms. Jeta Statovci, said that the law has two sides effects, firstly, it will ease the shift to digital economy and will reduce the operation cost, and secondly, will contribute to the environment by creating paper independence.

Business associations were present in the meeting and the executive director of EIC, Mr. Emrush Ujkani welcomed this legal initiative, urging to proceed for approval with no delays. "This digital segment is very sensitive, therefore a holistic approach is required," he said during the discussion.

During the hearing there were concerns raised on the timing of implementation, and also the human and technological capacities of the responsible institution.





Petroleum products and renewable fuels to be newly regulated shortly

September 22, 2021, Prishtine

Adoption of the Draft Law on Trade in Petroleum Products and Renewable Fuels, that has been prolonged for over a decade, now is expected to be approved by the parliament. The law touches on a very powerful industry and aims to regulate the legal structure, meeting requirements of EU directives and standards, for a safe and quality supply of petroleum products and determine the conditions for a competitive product market. In a public hearing chaired by MP Mimoza Kusari-Lila, participated business associations, including EIC representatives. Business associations proposed that in this law should be included the acceptance of losses caused during the transfer of petroleum products, similarly as it is applied in the EU legislation. Also, part of the law should be the cleaning of tanks which must be done every 10 year, to guarantee quality control.

• The European Investors Council CEO met with officials from the Mission of Kingdom of the Netherlands in Kosovo

The European Investors Council is growing even during the pandemic period, and this proves that the organization is performing well, said the deputy Head of Mission of Kingdom of the Netherlands, Mr. Peter van Bloemen, during a meeting with the EIC executive director, Mr. Emrush Ujkani. They also agreed on continuing the cooperation between the Embassy of the Kingdom of the Netherlands and the EIC.

EIC contributes in creating a climate to boost Croatian investments in Kosovo

 The good relations between Kosovo and Croatia should be materialized

The European Investors Council continuously holds meetings with European Countries, Missions in Kosovo, aiming to expend cooperation and build good relations that could lead to new European investments in Kosovo.

In September, representatives of the EIC, met with the First Secretary of the Embassy of the Republic of Croatia in Kosovo, Mr. Nedjeljko Spilek. The focus of the meeting was on how to improve investments climate in Kosovo. The Croatian official expressed the readiness of the embassy to support initiatives that would contribute in building a better legal infrastructure and environment for foreign investors, that would facilitate the process of doing business in Kosovo.

The cooperation and communication between the EIC and the Croatian Embassy in Kosovo, is expected to expend with the aim to boost Croatian investments in Kosovo.

The show shifts from the present to the past, eventually connecting everything in one piece, which left the audience in awe with the way everything fitted together like the last piece of a giant puzzle. Kosovo's gov reciprocity measure with Serbia, brings tension in the North

The Kosovo-Serbia border has been blocked by ethnic Kosovo Serbs, protesting a decision by Kosovo authorities to start removing Serbian license plates from cars entering the country. The traffic chaos raised fears that it may unleash much deeper tension between the two Balkan neighbors. Tensions soared Monday (September 20, 2021) when Kosovo special police with armored vehicles were sent to the border to

impose a rule on temporarily replacing Serb license plates from cars while they drive in Kosovo. It's a minor annoyance for drivers with a big symbolic impact. Kosovo authorities say they are only copying a program by Serbian police, who have for years been taking off registration plates from Kosovo-registered cars entering Serbia. Drivers then need to pay 5 euros for a temporary license plate. Kosovo authorities said a 2016 deal with Serbia reached in European Unionmediated talks had expired and now only proper Kosovo symbols are valid. (Source: Associated Press,)
