The Covenant of Judahtocracy Ratified on January 19, 2025.

The Judahite signed the New Covenant before the Second Court of Heaven, as stated in Jeremiah 31:27-34, on January 17, 2025, marking a significant milestone in the transition of Judah to the Promised Land. On January 19, 2025, the High Court ratified the Covenant of Judahtocracy in the timely sequence preceding the inauguration of Judahtocracy on January 20, 2025.

- ❖ *“The LORD says, ‘The time is coming when I will make a new covenant with the people of Israel and with the people of Judah.’”* Jeremiah 31:31.
- ❖ *“I, the LORD, say that the time is coming when I will fill the land of Israel and Judah with people and animals.”*

Reunifying the Ten Tribes and Judah

“Behold, the approaching days, saith the LORD, that I will sow the house of Israel and the house of Judah with the seed of man and beast.” Jeremiah 31:27

“Behold, the approaching days” refers to the first day, which arrived on January 17, 2025, when The Judahite signed the Reunification Declaration, as per Jeremiah 31:27-34.

The Preamble to the Reunification Declaration

- *“And it shall come to pass, that as I have watched over them to pluck up, to break down, to throw down, to destroy, and to afflict, so I will watch over them to build and to plant, says the LORD.”* Jeremiah 31:28

In practical terms, social unity exists between Judah and the Ten Tribes of Israel, albeit constrained by social oppression and the political economy of racism. In contrast, the reuniting of Judah and the Ten Tribes, as envisioned by the Transitional Movement, has a different foundation of unity, predicated on the cosmological Edenic Judicial Decree.

The Ten Tribes, numbering in the billions worldwide, will unite with Judah in a single operational governance, the Commonwealth of Labor, characterized as a Judahtocracy. All institutionalized components will come under the Stone Kingdom, a social system assigned to the Congregation of Israel, which will grow into a planetary system with no termination dates.

New Covenant vs. Old Covenant

To fully understand the New Covenant, it is essential to compare it with the Old Covenant. In review, the tribal clan of Jacob seventy went down to Egypt during the global famine and departed four hundred and thirty years later, numbering over two million. The tribal clan grew into a nationhood.

Symbolically, as the Congregation of Israel passed through the Red Sea, they received the Holy renewal of the DNA of Noah, Abraham, Isaac, and Jacob, washing away all the spiritual impurities of Egypt.

After the Red Sea validated its foundational DNA, the Congregation met the precondition of becoming a state, a nation. As such, the statehood received the theological rules of moral behavior that would make the Israelites a peculiar nation. Days before the Holy Convocation at Mount Sinai, everyone was required to wash themselves and their clothing, an act of purification.

At Mount Sinai, the LORD inaugurated the statehood of Israel as a priestly people to be a model for the rest of the world. The Ten Commandments were given as precepts for daily life.

Having received its theological constitution at Mount Sinai, the Congregation was tasked with shaping institutionalized religious traditions and customs under the five books of Moses. A legal system was established to develop case law and resolve interactive, relational conflicts. Credit is given to Jethro, Moses' father-in-law, who played a crucial role in establishing and organizing the judicial system for the nation of Israel. In summary, minor legal complaints would be handled on a case-by-case basis by men of integrity per tribal nation. At the same time, the most challenging cases would be assigned to Moses, who would seek God's guidance for resolution.

A point of interest: Jethro, a Midianite, is the son of Keturah and Abraham. This illustrates God's wisdom in using Abraham's lineage. From Jethro to Balaam, we understand that a judicial system was established on the principle of appeals, which remains in use today. The Congregation of Israel is more inclined to grasp the principles of planetary science and governance than Gentiles.

To ensure a new generation would be planted in the Covenant Land under its Theological Constitution, the LORD decreed that those twenty years of age and below would enter the Covenant Land of inheritance. WISDOM. The new generation would be free from the memories of Egyptian enslavement and better able to focus on making a new world with a theological constitution.

Contrary to today's geopolitics, which will soon fade away, the land of Israel and much of the Middle East is an inherited legacy of the Congregation of Israel. However, the focus of contention lies in the intentionally false narratives promoted by the Edomites, or the descendants of Esau, in collaboration with Zionist Judaism and Muslim Arabs of Ham's descendants. Why? Fundamentally, the core answer is found in Moses' military battles after he led the Israelites across the Red Sea. Indeed, the Edenic genetic struggle is manifested between Jacob's descendants and the Edomites and Canaanites. Esau married Canaanite women to the disapproval of his parents.

Moreover, the conflicting interplay is evident in different forms of expression, with each camp having a distinct objective. Jacob's children aim to ensure that the Serpent's descendants eat dust, never sustain success in their endeavors, and become servants to Japheth and Shem. However, the spiritual rationale is that Jerusalem is the location of a heavenly portal. Jacob marked this location where he created his stone pillow and witnessed the portal open, seeing Elijah, Gabriel, Yeshua, and others descend and ascend from Earth to Heaven and vice versa. Noah planted his vineyard within the territory known as Israel. As Daniel aptly stated, the Land of Israel is an image of the Garden of Eden, as Judea is referred to as the Pleasant Land. The Book of Jubilees records that Israel's lands belong to Shem.

The sons of Noah — Shem, Ham, and Japheth — submitted their global partitioning plan to Noah for approval, and Noah rejoiced when he saw the map of Shem's territory, as that was where he intended to plant his vineyard.

Noah planted his vineyard on the land of Shem and became overwhelmed by the spiritual goodness of the LORD's grace. Indeed, Noah's three sons followed the Lord's directive to be fruitful, multiply, and fill the earth.

Noah did nothing wrong by being naked, for he had a personal right to undress for whatever reason in the privacy of his dwelling.

For prophetic clarification, Ham is the biological father of Canaan; Noah adopted Canaan as his son. Likewise, Jacob adopted Joseph's sons, Ephraim and Manasseh, as his prophetic sons. Canaan went into Noah's tent, looking for the map or some way to redraw it to include his interests. He emerged from the tent without success, casting a twisted view of Noah. Shem and Japheth walked backward, not looking at their father's nakedness, and covered him. The allegory: walking back in time to the Garden of Eden, reminiscing about spiritual innocence when Adam and Eve lived there, unencumbered by sin and clothing.

Sleep denotes a delay of a contextual circumstance. Indeed, after 430 years of inactivity in Egypt, the Israelites awoke to a land filled with large, unmatched fruits, unlike those found in other parts of the region and the world.

Israel became a nation after crossing the Red Sea; however, the twelve tribal nations had to be divided into provinces.

We learn that Canaan's family came to the Pleasant Land, also known as the Covenant Land, during the seven years of global famine. After the global famine, the LORD blessed the land with phenomenal-sized fruits, such as grapes as large as apples. Whereas the Canaanites farmed the land as servants of Shem, the land was never deeded to Canaan. In the metaphor, the Canaanites confused their role as servants with that of legal owners of state property and wealth.

The LORD told Moses to repeat the directive to Joshua that the Amalekites must be eliminated, as waging war with them from generation to generation until they are wiped from the face of the earth. The second directive given to Joshua: after crossing the River Jordan to the Promised Land, the people in the land must be destroyed, including women, men, both old and young, and domesticated animals, for the state to maintain good spiritual health. In the alternative, the LORD said he would drive the Congregation from the land if they failed to drive the Canaanites out. The rest is history.

Edenic Adjudicated Ruling

The Edenic trial involved Adam, Eve, and the Serpent. Adam and Eve presented their defenses, while the Serpent remained silent, showing his defenselessness. It is in the Serpent's nature to use tactics to disguise sin against the Lord intentionally. Thus, the Serpent had no factual defense to offer. Under divine judgment, the Serpent's conflict with Adam's descendants would be transgenerational, leading to a time when the Redeemer would remove the Serpent's influence of attractiveness to sin from Adam's bloodline, rendering the Serpent weak and immobilized.

- ❖ *“And the LORD God said to the serpent, Because you have done this, you are cursed more than all livestock and more than any wild animal; you will crawl on your belly and you will eat dust all the days of your life.” Genesis 3:14*

The Serpent transcended established boundaries regarding shapeshifting and human interpersonal relationships by modifying Eve's DNA, allowing for the formation of all types of personalities.

❖ *“Adam named his wife Eve because she was the mother of all human beings.”*

Genesis 3:20

Not all women have the same molecular genes or personality traits as Eve. Insightfully, Eve shares a three-part genetic relationship. First, Eve was created from Adam’s ribs; still, Eve possessed her DNA mixture of uniqueness; next came the Serpent with his molecular genes combined with Eve’s. The LORD’s Adjudication reveals the complex interplay among designer personality genes.

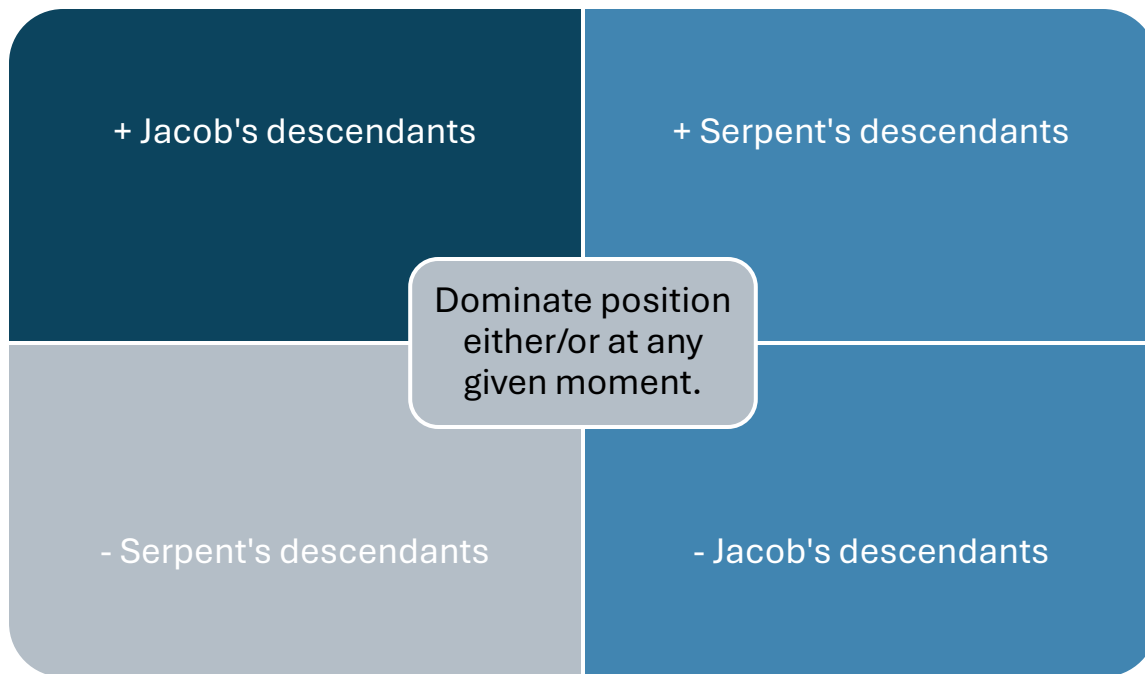
“I will put enmities between you and the woman, between your offspring and her offspring. She will crush your head, and you will lie in wait for her heel.”

Thus, the LORD’s statement to eliminate everyone in the land of Canaan aligns with His Edenic Ruling. The Israelites disregarded the directive and became culturally intertwined with the tribal nations of Canaan, adopting idolatry.

Often misunderstood, the objective intent behind the Serpent Seed and Adam’s seed is not mechanical—a tit for tat. The mutually conflicting aims of biting the heel or crushing the head never cease, although they may be more intense at times than others. Nevertheless, throughout various historical events, Adam’s descendants have held the upper hand in governmental, social, financial, and religious matters.

However, the conflict continues on all fronts, shaping the worldview of each opposing party across society through policies, rules, regulations, and other means. Generally, serpent descendants make up the majority or hold administrative control, such as in a department or a leading social organization. In such cases, it can be said that the department or organization reflects who and what possesses the upper hand or the prevailing circumstances.

We revisit the Garden of Eden and witness the expulsion of Adam and Eve. The LORD made clothes for Adam and Eve, after which they were expelled from the Garden of Eden. It would take thousands of years for Adam's descendants to qualify for a return to paradise as outlined in the 400-year Covenant of Abraham. In the fourth generation, not at the start of the fourth generation.

In conversation, Elohim reasoned among themselves in logical deduction that since the Adamic race knows good and evil, the ability to discern spiritually right from wrong, a desirable trait for elevating themselves along the pathway to form great civilizations, they postulated that it would be a matter of time before they return to the Garden of Eden to eat from the Tree of Life and live forever. Thus, the question is, what should be done?

And He said, 'Behold, Adam has become one of us, knowing good and evil; now, therefore, lest he put forth his hand and take also of the tree of life, and eat, and live forever.' Therefore, the LORD God sent him forth from the Garden of Eden to till the ground from which he was taken. Genesis 3:22-23.

Genesis 3:22 is one of the most enigmatic texts in the Bible, followed by Genesis 3:24

"So, the LORD God drove out the man; and he placed at the east of the garden of Eden Cherubim, and a flaming sword which turned every way to guard the path to the tree of life."

Returning to the Pleasant Land, the deeded land under the Covenant.

After transitioning to the deeded land, the Messianic Age begins. Several milestone events have facilitated a relatively smooth transition. For example, the Ten Tribes and Judah have a ratified Covenant to follow the LORD's statutes for a wholesome life. Unlike any covenant made before, the Israelites no longer need to ask anyone about the law and its meaning, as it will be placed in their minds with the restoration of Adama's genetics. If anyone asks about the New Covenant, it will indicate that the person is either not part of the Covenant or that a person of the Covenant wishes to return to a life of sinning.

The Tree of Life.

Now, under a ratified New Covenant, the Redeemer, Yeshua, has restored Adam's original DNA genetics, which Yeshua created initially for the Adamic Race.

Once back in the Pleasant Land, we will eat from the Tree of Life. **In definition:**

^{15:5} I am the vine; you are the branches. Those who remain in Me, and I in them, bear much fruit, for apart from me, you can do nothing.”

^{15:6} If anyone does not abide in Me, he is cast out as a branch and withers; and they gather them and throw them into the fire, where they are burned.

^{15:7} If you abide in Me, and My words abide in you, you will ask what you desire, and it shall be done for you.

^{15:8} By this My Father is glorified, that you bear much fruit; so you will be My disciples.

Presuppositions without extensive discussions. The Serpent placed his genetic material inside Eve. Although the Judahite acknowledges the controversy over the means of implantation, what is most important is that Eve's genetics distribute the Serpent's DNA genetic material to offspring.

- A. When Adam's descendants, the sons of God, began to marry the daughters of men, the Serpent's seed fostered ever-growing evil thoughts in their imaginations and behavior. Today, the Internet has enabled the rapid spread of wickedness. Scriptures say that as it was in the days of Noah, so it will be in the latter days.

“ So, the LORD said, “My Spirit will not contend with man forever, for he is mortal; his days shall be 120 years.” Genesis 6:3

- B. Evil would have overtaken the world had it not been for the fact that a limit of 120 years was placed on the Serpent's genetics before its disintegration. Each person possessing the Serpent's genetics will never live beyond 120 years without birth defects. For Adam's descendants, this limitation is conditional if the Serpent is mobile. One day, the Serpent will be paralyzed.
- C. Elijah left Earth as a Restatement of Redemption, having been restored with Adam's genetic proof because he escaped mortal death.
- D. Elijah returned to Earth as John the Baptist to prepare the way for the Redeemer, Yeshua. As the Son of Man, Yeshua embodies the doctrinal Tree of Life.



Yeshua, The Redeemer

As an oath to the Adamic race found in the Edenic Judicial Decree, the Redeemer would restore molecular Adam's genetic material to its original state before the Serpent's injection. This topic is quite advanced. Aware that many might not fully grasp the Redeemer's significance in the end times, Yeshua provided allegorical taglines and parables to guide us, enabling a deeper understanding of the Israelites' rich spiritual heritage.

- A. Consider the divine testimony of Job, whom The Judahite believes to be Shem, regarding reversing Adam's DNA to its original state.

"For I know that my Redeemer and Vindicator lives, And He will finally take His stand upon the earth." Job 19:25

"Even after my [mortal] skin is destroyed [by death], Yet from my [immortal] flesh, I will see God." Job 19:26 from the Amplified Version.

Whom I will see for myself. My own eyes will look at him— there won't be anyone else for me!— He is the culmination of my innermost desire." Job 19:27

With profound insight, Job understood the connection between earthly genetics and the genetics of immortality! Noah's bloodline was not corrupted by the Serpent's injections, nor was Enoch. Shem learned from Enoch's writings and the teachings of Enoch's son.

- B. The first half of Redemption is a case study about the archetype of reversing Adam's genetic code to its original form. In a two-step procedure, Yeshua reinserted his original genetic code for the Adamic race supernaturally or inter-dimensionally.

"And the tombs were opened; and many bodies of the saints that had fallen asleep were raised; After his resurrection, they came out of the tombs, entered the holy city, and appeared to many." Matthew 27:52-53.

In synchronicity with the opening of the tombs, the veil covering the Holy of Holies was torn from top to bottom, ending the requirement for the priest to enter the Holy of Holies annually to seek forgiveness for the sins of the priests and the people, thereby attaining atonement.

When the tombs opened, the saints awoke and were restored to Adam's original genetic makeup. The saints arose and walked for three days. Again, in synchronicity, Yeshua was resurrected on the third day, and the saints walked into Jerusalem to see the Son of God before Yeshua's ascension.

Thus, Job 19:27 was fulfilled. Indeed, he beheld the Redeemer with his own eyes, equipping us to understand Job's archetype of sainthood and the model of the resurrected saints when the trumpet of good news sounds from heaven on the Day of Judgment when those with new genetics will live eternally, and those with the Serpent's genetics will face eternal damnation.



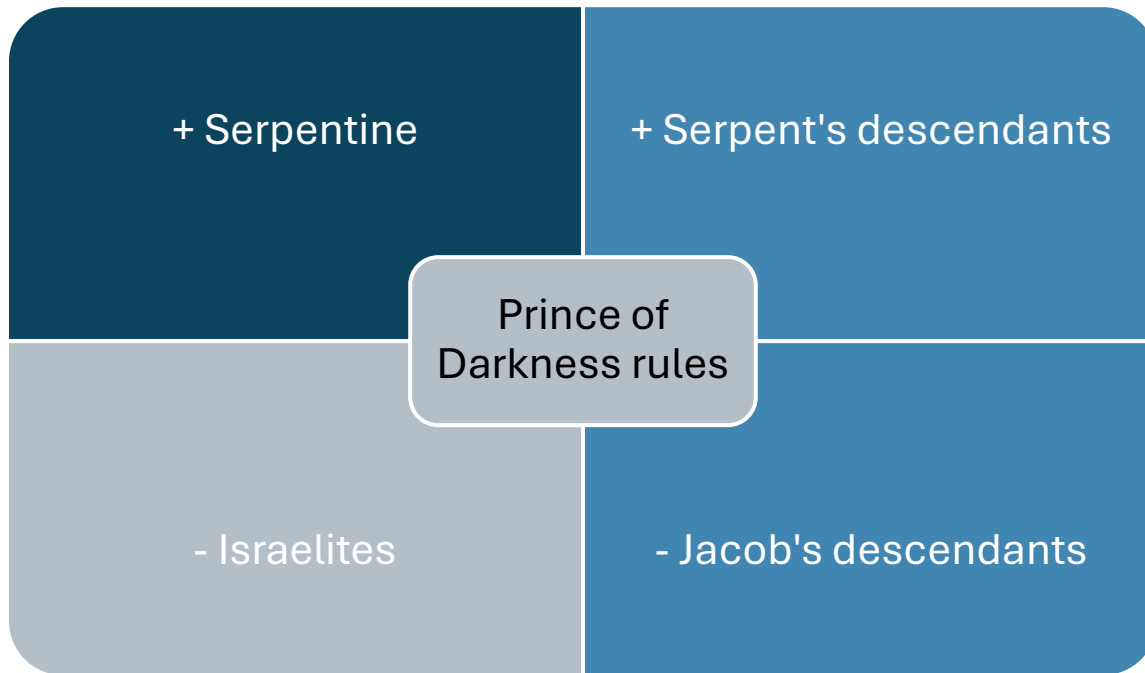

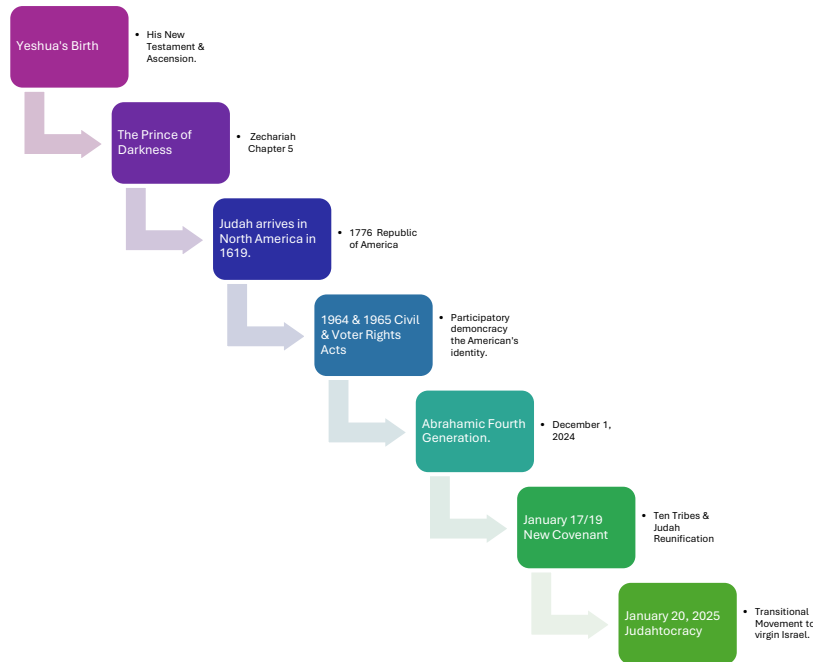

(THE TEN TRIBES OF ISRAEL)

And I will set my eyes upon them to be pacified, and I will bring them again into this land: and I will be their God: and I will build them up and not pull them down: and I will plant them and not pluck them up. Jeremiah 24:6

And I will give them a heart to know me, that I am the Lord: and they shall be my people, and I will be their God: because they shall return to me with their whole heart. Jeremiah 24:7

Jacob's descendants, freed from oppression, symbolize a decisive judgment that excludes the Gentiles as the primary beneficiaries of Jacob's tithing.

"For the LORD has ransomed Jacob and redeemed him from the hand that had overpowered him." Jeremiah 31:11

Jeremiah indicates the conclusion of the Gentiles' last social system when Jacob's tithing blessing will cease to flow and will be redirected to the Israel Commonwealth of Labor.

The verb forms "redeeming" and "redeemed" refer to an exchange of power that grants liberties to subjects, whether they are justly or unjustly constrained. Another word to consider is "surety." The LORD mandated Jacob's economic and financial exploitation as a guarantee to fulfill all the fundamental components of Daniel's Man Statute, which represents the four social systems of the Gentiles as they progress toward their conclusion.

For methodological purposes, let's consider divine and earthly redemption, although the intent is the same. Initially, the Serpent's DNA was implanted in Eve, and she passed these genetic traits down to her offspring. Unfortunately, Adam's genetics became corrupted. However, after the Edenic Judicial Ruling, Adam ecstatically rejoiced, knowing the Serpent's genetics would be purged from his bloodline, restoring his race to daily communal interaction with Elohim.

Indeed, Yeshua, the Redeemer, shed his **divine** blood in Gethsemane and his **earthly** blood at Golgotha, the hill of Skull. In the first sentence of Genesis, the Son of God tells us, pictographically in Hebrew, that He gives His life willingly and reclaims it through his will. It follows, therefore, that in the Garden of Gethsemane, Yeshua shed His divine blood in prayer to His heavenly Father without trepidation, unconditioned by any man's pressure.

In Luke 22:44, Yeshua sweated, and significant drops of blood fell on the ground. The phenomenon is known as hematidrosis; however, the medical term provides insight into the internal cause of blood loss, but it is divinely limited. Now, consider that the Adamic race is intertwined with a low-grade genetic material from Elohim. Remember:

"Then God said, 'Let Us make man in Our image, according to Our likeness; let them have dominion over the fish of the sea, over the birds of the air, and over the cattle, over all the earth and over every creeping thing that creeps on the earth.'" Genesis 1:26

Low-grade because humans had to evolve in all aspects of life.

Yeshua tells us in a parable that a man came at night and planted tares in the owner's garden or field without the owner's knowledge. The next day, the owner realized the misdeed. The parable applies to the Serpent in the Garden of Eden, who injects his genetic material into Eve.

Once the Serpent's genetics mixed with the sons of God, the world became full of bloodshed; wickedness ruled the world. Yeshua had to come and atone for humanity's sin. By renewing the Adamic race's original genes, the adversarial separation within the community of righteousness rejoined or reconnected. Hence, the Unity of One, a realigning with God's purpose once again.

We don't fully understand the operations within the heavenly realm. Given our stage of evolution compared to life forms that have existed for hundreds of millions of years, we may never know. Our life form is composed of blood, which differs from other life forms that do not have blood. Despite never knowing, there will be those who continue to advance meaningless theories, although they may be entertaining.

The Most High had a plan when the Earth was formed. Did the Heavenly Father and his Son know about sin entering the world and gaining the upper hand in social immorality? Yes! The Judahite's late father told him on various occasions that Yeshua agreed to come down from the right hand of God to redeem humanity before the Earth was formed. Yes, they knew that the Serpent would taint the Adamic Race, and the only way to reset the secret realignment was through Yeshua's sacrificed blood. There was no other way to redeem humanity. Yeshua, the Son of God, is the ultimate divine superior; there is no other cosmic divine holiness. He is Holy; therefore, his methodology is secret.

For atonement, the Son of God prayed. The most challenging phase was when he bled profusely in Gethsemane. What? The process of purification took place in heaven. To understand what happened, we must have been in parallel realities. No, there is no intention to explain except to defer to the Scriptures.

However, a genetic blood transfusion took place an hour earlier at the Last Supper when Yeshua performed the theological ritual of serving his genetic blood, which would be seen in Gethsemane. The bread served at the Last Supper is earthly, representing His body, from which we will see the genetic flesh at Golgotha.

The theology of the Last Supper, as practiced in Holy Communion, centers on the Divine Unity of One. In theological contexts, a genetic dialysis apparatus was established to facilitate genetic renewal. Indeed, each time we partake in Holy Communion, our blood is renewed, as illustrated in the Garden of Gethsemane. Every Sunday, over a billion people worldwide undergo the same blood dialysis that Yeshua's disciples experienced. With our blood, we continually triumph over the Serpent in the long run, as its genetic code has a lifespan of 120 years consecutively.

The Mount Sinai Covenant was meant to be perpetual, but the Israelites' disobedience led them to coexist with the Canaanites. Over time, not all Israelites adopted the Canaanites' deities, thereby relegating their theological constitution to a position of lesser meaning.

Disobedience to the law, as expected, forced the Northern Kingdom, the Ten Tribes of Israel, from their land. Ultimately, thirty-seven years after Yeshua's ascension, the expulsion of Judah occurred in AD 70. Adam and Eve's disobedience is portrayed as the archetype of expulsion due to disobedience.

After AD 70, the tribe of Judah seemingly disappeared from the pages of history, yet it served as the foundation of capitalism from which imperialism evolved.

Following instructions and adhering strictly to Jeremiah's letter to the Babylonian exiles, Judah had to endure until the Gentiles' fourth and final social system ran its course, as outlined by the Abrahamic Fourth Generation, which began on December 1, 2024.

In conjunction with the Abrahamic Fourth Generation, Judah and the Ten Tribes united under their theological New Covenant of governance. The Covenant was signed on January 17, 2025, and ratified on January 19, 2025, leading to the inauguration of the Judahtocracy, a unified system of governance, on January 20, 2025.

Inauguration

Appropriate for the inauguration and the start of the Fourth Generation, 1 Peter 1:18-25 offers a doctrinal treatise on Yeshua that elucidates the genetic concept of the Redeemer:

- *Knowing that you were not redeemed with perishable things, such as silver or gold, from your aimless conduct, which you received by tradition from your ancestors, but with the precious blood of Christ, as of a lamb without blemish and spot."*

In brief, having reached a mature developmental stage, God's laws and statutes are ingrained in the very genetic makeup of Israel and Judah. No one needs to ask or be told what constitutes right and morally wrong conduct. The Redeemer represents a divine atonement, eliminating and neutralizing the Serpent's genetic influence on the Israelites.

The New Covenant of Redemption establishes the Stone Kingdom.

Judahtocracy appears as an earned gift, according to Jeremiah 31:11. Beginning on Inauguration Day, January 20, 2025, Isaiah 44:23 provided the Declaratory Relief at the start of the Fourth Generation, marking the end of over two thousand years of living in exile. With 100% absolute certainty, during the Fourth Generation after America's punishment, the Israelites will be in their homeland.

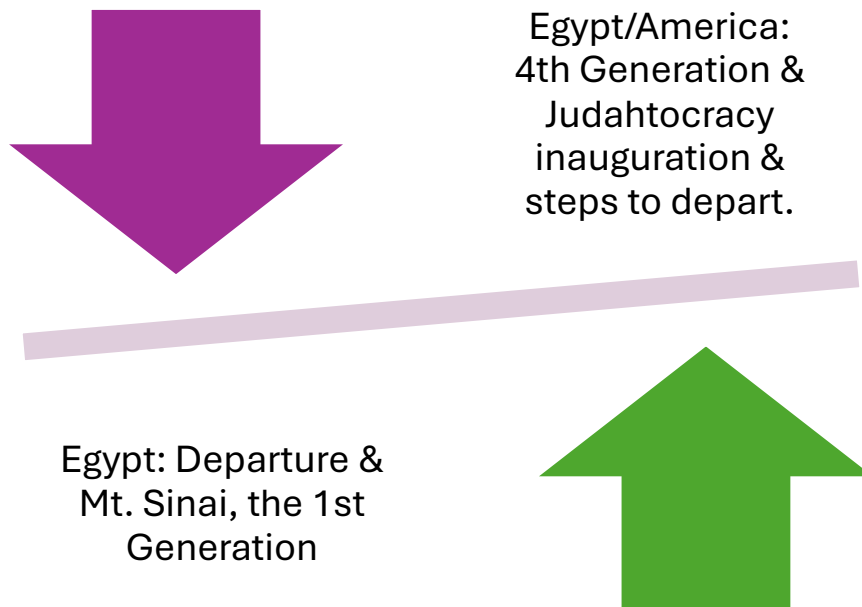

Ratification Day: January 19, 2025

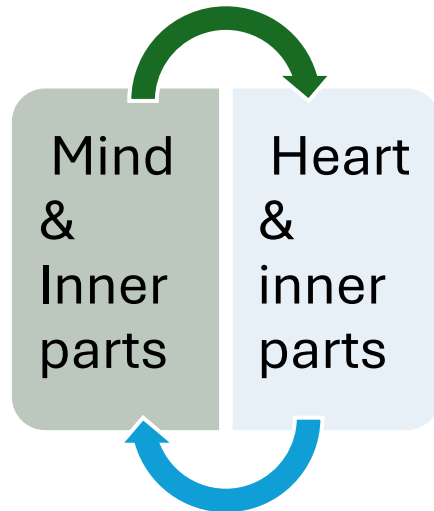
“Behold, the days are coming,” says the LORD, “when I will make a new covenant with the house of Israel and the house of Judah.”

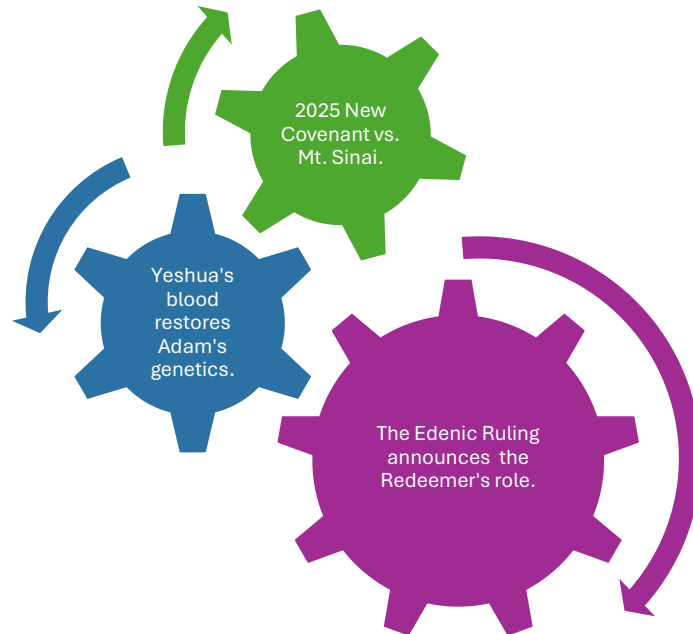
This covenant is designed for the Ten Tribes because of their long history of being drawn to the sins of the Gentiles. The solution:

“Not according to the covenant I made with their fathers, on the day I took them by the hand to bring them out of the land of Egypt: the covenant they made void, and I had dominion over them, says the Lord.” Jeremiah 31:32

When the disciples sought guidance on removing those with the Serpent's genes, which reflect certain character traits, Yeshua replied, "No! Do not." Let the tears grow alongside the Wheat. Otherwise, metaphorically speaking, significant damage will be done to the soil, and families will face potential psychological harm. At the end times, a decisive separation will occur, with the goats on one side and the sheep on the other. This procedural separation will eliminate all guessing and second thoughts about those family members who are damned, for individuals made their own decisions regardless of reason.

As is known, families often include both Adam's and the Serpent's offspring, as seen in the stories of Cain and Abel and Esau and Jacob. "Let both grow together until the harvest, and at the time of the harvest, I will say to the reapers, *'Gather up first the tares and bind them in bundles to be burned, but gather the wheat into my barn.'*" *Matt 13:30*

Undoubtedly, the spiritual weeds, representing Satan's opposition to the righteous, will be cast into the fire of damnation. Fire is the only guaranteed method to eradicate the Serpent's genetics; otherwise, there is a risk of gene jumping, which often occurs in disease, allowing it to find another host and continue living.

Self-Indictment:

The subject's evidentiary history informs divine justice.

The caption is somewhat obscured but can be understood within the framework of divine justice. Biblically, we have numerous resources available to help us craft a focused message. First, we have the oracles given by Jeremiah regarding the wine cup of national wrath. Per God's instructions, Jeremiah sent the cup of wrath to the nations on the LORD's list. Many countries were reluctant to accept the package containing their national history of misdeeds and thus declined to take it. The delivered package of wrath cups included the destruction of cities, inflicting hunger on the people, severed body parts for various reasons, deaths from disease, national plundering, captives taken, and national subjugation.

Like hardened criminals, justice was and will be forced upon them in dual prophecy. Jeremiah was not the only one to deliver prophecies of national destruction, although that was his mission; Isaiah, Ezekiel, and others also prophesied against latter-day nations.

In Ezekiel's case, he ate a daily meal cooked on cow dung for 390 days to represent Israel's iniquity, and for 40 days representing Judah's iniquity. *Ezekiel 4:1*

Fitting the punishment, the cow dung was a caricature of Israel's fate when considering that they worship the Calf of Samaria (*Hosea 8:5-6*). The Assyrian Empire waged war with the

Northern Kingdom of Israel, transforming it into dust despite years of fighting to preserve their lives; they inevitably saw their demise.

In the case of Isaiah, he walked naked for three years. No! It was not a laughing matter. Those who understood prophecy recognized it as a representation of a future reality that would impact many people, namely Egypt and Ethiopia (Isaiah chapter 20).

Moreover, consistent with the Lord's forewarning of divine justice, the Judahite is associated with dung, whether or not this is accurate. In the Bible, dung symbolizes the finality of judgment. Nevertheless, this association serves symbolically as a template modeled by enemy forces that are anti-Judah.

Biblically, we understand that corpses will fall like dung in the latter days, as defined by our seasonal time. Depending on the interpretation of historical periods or how events align with Scripture, more than half of the world's population will perish.

Revelation 6:7-8 states that one-quarter of the world's population will perish;
Revelation 9:18 states that one-third of the world's population will perish;
Zechariah 13:8 states that two-thirds of the world's population will perish.

The estimates are mentally staggering; however, the template of smell now reveals a dimension that makes people tremble. People will indeed smell the rotten corpses of others before they, themselves, fall and smell like those they saw six hours earlier.

Although The Judahite embraces 2/3 of the world's population perishing, the 1/4 and 1/3 could be rolled up in the 2/3. Still, as a practical matter, seven months are given for cleaning up the corpses in designated areas.

Earth has seen many great civilizations, arguably far more significant than our contemporary ones. Humanity continually uncovers lost civilizations as people explore the world's waters and conduct archaeological digs. However, the discoveries are not as impressive as a few educated individuals in higher learning have concluded that the world they inhabit is destined to come to an end, regardless of the cataclysmic agent. Overall, very few people possess this planetary insight.

By examining the past, we gain insight into our future. Indeed, life is a continuous progression, onward, upward, and making quantum leaps.

Usage of terms

Now is the time to enhance our terminology. The Serpent is often linked to the genetic code. The Snake embodies the Serpent, slithering on its belly. Satan represents communication through words and text, an adversarial stance against God's laws. The Devil signifies actions and physical constructs that undermine and destroy all interpretations of Yeshua's teachings.

Judah and the Ten Tribes are now united under the ratified Theological Covenant.

Genetically,

Judging a person's character is a good measuring stick. Again, those within these capitalist ideological forms must fight for their interests according to the rules of political

economy. Fighting for the rights of blacks, women, and others is necessary. However, the laws of social production and the rules of political economy will not exist in the Commonwealth of Labor's self-automated rotating economy, which is based on preserving and maintaining the spiritual needs of society. Jacob's tithing blessing to the Gentiles would have been redirected for the primary interest of the Stone Kingdom. No more manufacturing useless junk in the interest of imperialistic profits. **e)** Overall, the Ten Tribes, numbering in the billions worldwide, have been redeemed and are now under the New Covenant, enjoying the full rights of Zion.

A summary forecast

Furthermore, we recognize that we are fully prequalified to receive **an invitation** to Lamb's Marriage. At this time, our DNA will be upgraded, and we will then transfer to our new galaxy as an interstellar civilization.
- 4) After the Messianic Age, we will be transported to our galactic home in perfected bodies. Theoretically and speculatively, we will inhabit a brand-new system with twenty-four planets, each of which will be occupied in time. Step outside and gaze up at the night sky to find your future home. Inspirational, but unlikely anyone will see the location. NASA's Webb telescope may provide a focal point for searching for all-star systems formed over the past two thousand years.
- 5) The Earth and our current galaxy will be consumed by a black hole, never to be seen again.
