

# **A Very Brief Moment of Reflection**

**June 7, 2022**

## **A reminder**

The Judahite's presentations are primarily for the **144k** who bring forth the Firstfruits. The 144k has working assignments given by the Holy Spirit to function as the light of salvation via the Executive Body of Israel. According to the Edenic Judicial Decree, the priority task is to cut the heels of the Serpent's descendants.

Because the Holy Spirit has sealed the 144k, the entire Congregation of Israel has yet to become Firstfruits. For Gentile Christians of all races who have been **baptized** and honestly believe in Yeshua as the Son of God, Yahawah, can ride the coat-tails of the 144k and become Firstfruits.

## **The Month of May 2022**

The Feast of Weeks, indeed, has displayed resolutions in keeping with the material expectations stipulated on the day that the Elohim scheduled the observances thousands of years ago.

Since 2017, purposeful biblical events have unfolded, enabling the Congregation to gain consciousness about the Feast Days. As an estimate, to be generous, about 5% of African Americans knew about the required criterion for observing the Feast Days before departing America after four hundred years per Abrahamic Covenant. Just this fact alone shows the amount of work necessary to raise the level of consciousness. Understandable because the Mosaic Crises erased tribal affiliations. Consider that the majority of African Americans have European last names.

Methodologically, through the Holy Spirit, The Judahite has provided rich content to the Feast Days. The American Congregation of Israel stands in sharp contrast to those Jews and Hebrew Israelites' observance of the Feast Days. The American Congregation of Israel means the Executive Body of Israel.

Indeed, The Judahite's representation of the appointed Americanized Feast Days will continue to stand in isolation from others, yet at the same time, pulling the Firstfruits into the New Covenant.

The current period that we are going through is part of the purification process. We cannot enter the Lands of Promise without some degree of purification; hence, the sealing of the 144k.

Our current exodus schedule allows us, the Executive Body of Israel or the 144k, to hit the ground running once we enter the Lands of Promise. A point of clarity: the new civic leaders would have sufficiently shed the old iniquities to the degree of not being confused about the purification operations, weeding out those who do not belong part of the Commonwealth of Israel.

Do not be confused and impatient! A large quantity of preparatory work is now in operation for the exilic return that is no different from the Forty Years wandering in the wilderness and the Babylonian exilic return. This time around, the required work is being done before re-entry instead of waiting and doing the necessary work on the backend.

The spiritual mindset must be sufficiently elevated for the new civic leaders to perform the construction work for a new social system known as the Stone Kingdom.

### **The Feast of Weeks' Methodology**

- 1) May 6 signified the theme of Pentecost. The time for the Congregation to plant itself in the Lands of Promise.
- 2) May 27 provides the tent under which we clarify our obligations to implement the stipulations noted in February driven by May 6 Proclamation.
- 3) May 28 came as a mixed day hosting a prophetic division separate from the arithmetical schema division configuring in real-time events on specific dates. Remember, May 27 came as a prophetic date in 2020 and 2021. Today it is a standardized date.**
- 4) May 29 holds its credentials as the Court of Heaven's approval to authorize all means to uphold May 27 New Covenant.
- 5) May 30 combines May 27 and May 29 into an Action Plan.
- 6) May 31 establishes the **List of Orders** that incorporates MAY 28.

## Forms of Communication

The host of heaven has no limitations on forms of communication. **May 28 came as a mixed day hosting a prophetic division separate from the arithmetical schema division configuring real-time events on specific dates.**

The Judahite operates within the Arithmetical Schema Division at specific times to receive real time communications from the Archangel.

Sometimes The Judahite gives dates particular to the schema division. To be clear, The Judahite has given dates and will continue to do so that **do not originate** from the Arithmetical Schema Division.

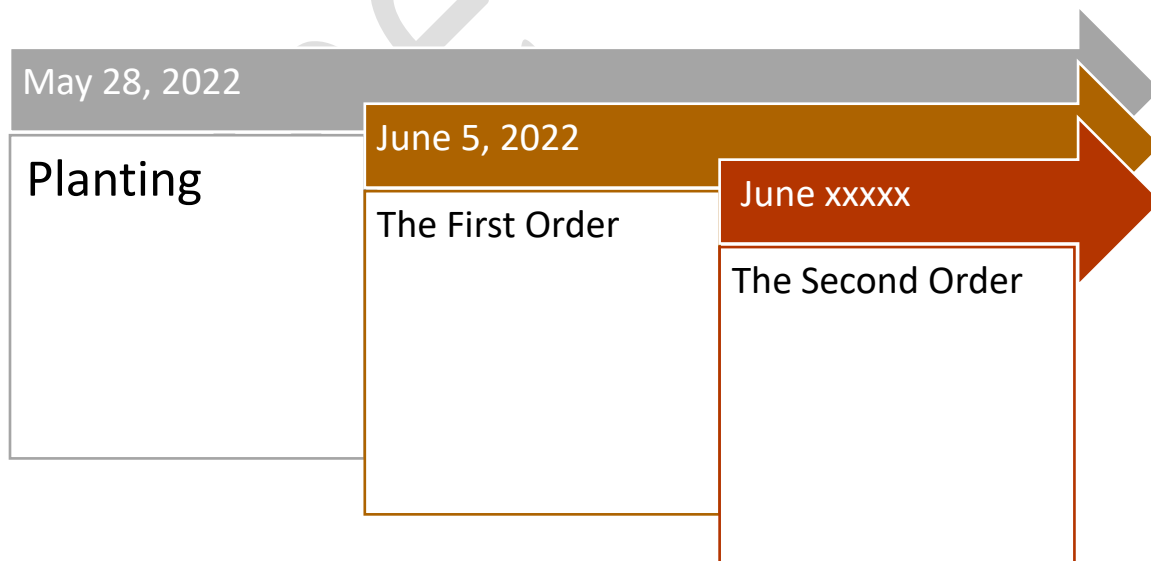
## **May 28 gave June 5 as a watch date.**

The Judahite did not intend to publish the prophetic date on June 5 because it ran close to the Arithmetical Schema date. No need to create any confusion.

### **The Holy Spirit deemed the publication of June 5.**

The Holy Spirit gave the date to a particular person and arranged for The Judahite to hear the disclosure date. The person spoke authoritatively about June 5, which was so striking.

Only The Judahite and the Holy Spirit knew of May 28's dates. Depending on other unfolding events, the other dates might be revealed via the same person to avoid confusion. Overall, all dates will be disclosed according to the will of the Holy Spirit when considering the dates' source.
