

Calendar Updates

Received From the Second Heaven Court on April 1 & 2, 2024

For April, May, and June 2024

A quick review of one way to view the calendar dates.

1. Always count the same numbers. For example, 21 is counted seven times in April.
2. 21 represents a) fighting, b) rebellion, c) separation (opposition to Authority and Rules), d) argument, etc. In Daniel 10:2-3, the principality over Babylon held Gabriel for 21 days in a legal court proceeding before the Magistrate at the Second Heaven Court. After Michael arrives to clear up Judah's invested authority in the end-time days, Gabriel continues his journey to meet Daniel.
3. The representation of 7. From past presentations, we know 7 represents a) completion, b) a new start, c) the Sabbath, and d) divine perfection. The **divine** creation of Earth took seven days or seven thousand years.
4. Thus, we have the significance 7 and 21 and their magnification.
5. After seeing the circumstances of 7X 21, the next step is to see the operational movement of 10 to complete an understanding of 21/7.
6. 10 represents a) completion, b) perfection (as in 7), c) responsibility (the Ten Commandments), and d) the first digital unit system (either weight or measurement).
There are many examples of biblical numbers. For example, the angels of the LORD gave an oath that if only ten righteous people existed in Sodom and Gomorrah, destruction would be averted. Ten disasters came upon Egypt. Ten tribes of Israel rebelled against Judah, resulting in the Northern Kingdom called Israel. Three tribes were composed of the Southern Kingdom called Judah. Isaiah to Hezekiah, per his request, the sundial would be turned back ten steps (degrees) Isa 38:7-8. Daniel and his Three Associates were tested for ten days to determine their daily dietary meals. They passed the test by being much healthier than those who ate the King's meat. Pagan meat offered to the King's gods was a no-no.
7. Finally, 21 is amplified seven times. Thus, in 21/7, 10 is operational to bring about perfection, a resolution, as an act of responsibility.

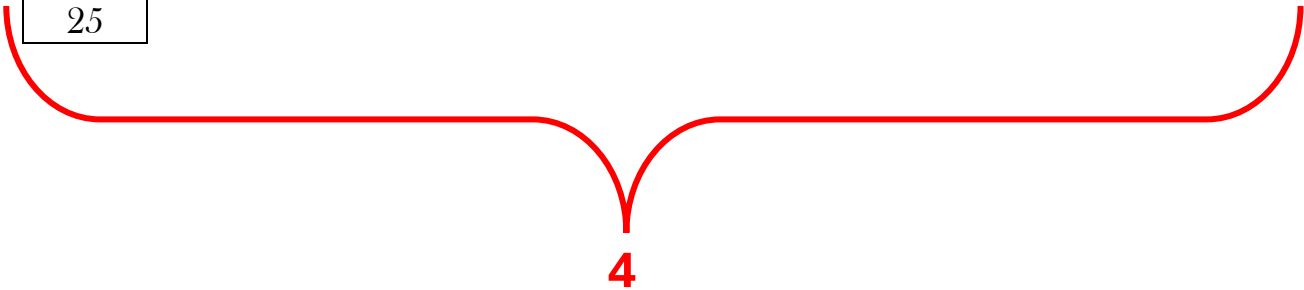
