Introduction

What an unusual introduction to calendar updates to start quoting the Scriptures.

The calendar dates are for Judah and Israel to study related Scriptures while actively advancing the Commonwealth of Israel transitioning during its many phases. As a historical context, the calendar dates are for us to know how the Angel is shepherding work-in-progress to ensure Judah receives his deeded land of inheritance and the Ten Tribes receive their monetary assets under the Abrahamic Covenant.

As a historical note, the generational Israelites who grew up in Egypt conversed with Moses on all basic needs humans seek to satisfy. Although the LORD easily meet their daily needs, on the one hand, the Israelites continued to regularize the Egyptian culture in daily living as it clouded their view to see that they existed as a new sovereign nation, no longer under pharaoh’s jurisdiction.

Before leaving Egypt, the Israelites were promised a better life than the life in Egypt; such a territorial ideal of nationhood gave them time to make plans. They had time to visualize cultivating an agricultural industry around the abundance of milk and honey. Instead of planning for a brighter future, they spent time reforming the Egyptian culture suitable for wilderness compatibility by making idols, a misplaced royalty to the power and might of their God, Yahawah.

Being influenced by the exilic contrary spirit of yesteryears, currently, the Israelites are in different phases and stages of transitioning to the Lands of Promise; the devil cannot stop progress. Still, the Ten Tribes underestimated Satan's principle of distraction to push the Israelites away from the essential task of making the best use of their skills to evolve the commonwealth of Israel.

Generally, the Israelites knew of their forty years stay in the wilderness before accomplishing their ideal nationhood. Likewise, American Judah knew about his 400-year stay in Egypt, marking the exiled fourth generation and the return to the Promised Land of our foreparents. Such is an inspirational expectation for many, yet the current social conditions suggest an impossible dream. Since July 2019, the Israelites believed that the Mosaic Curses should have been lifted, but the social behavior indicates nothing has changed; instead, the same racial complaints have turned up the sound volume tone of racial injustice.

Generally known, the Ten Tribes of Israel must overthrow the Mosaic psychological Curses, which is easier said than done. The Mosaic courses are not theoretical, for they must be negated systematically in each person's life by living the new psychology, no longer restrained by the specifics of the old Curses.

Tribal Families

Over the years, The Judahite has given notice to Judah and the Ten Tribes to discontinue using political names such as Negro, black, African American, African, etc. , because they have the purpose of limiting one's spiritual growth, as underlined by the Mosaic Curses.

The qualitatively different meaning is that Judah's jurisdiction restriction would expire at the end of 400 years, 2019. Thus, there is no basis for Judah to unite with people who have opposed political agendas. In the age of electronics and social media platforms, racism is used to reinforce the internalization of blackness. For as long as people prioritize discussions and social behavior around past social injustices as an excuse for lack of progress, falling short of their goals or having their personal achievement taken away, they run low on positive energy to think about biblical prophecy of a better tomorrow.

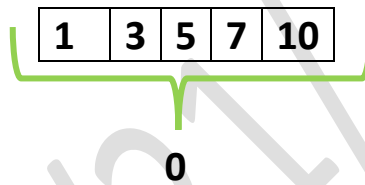
