## **Social Disintegration started on December 6, 2017**

In today's world, many people cannot make any sense of the discordance seen on all levels of society. There are different perspectives and opinions about discordance's intensity. Although there are some overlaps of opinions, The Judahite's perspective stands out from the rest. Regardless of how chaotic, the significant changes are in Congregation's mental, psychological, and spiritual preparation for departing Egypt-America. To substantiate, some of the milestone biblical dates have been reached, i.e., 400 years per Abrahamic Covenant.

Being true to the social laws of historical materialism in the construction of our society, the chaotic opinions, though subjective, express the decomposition of society, which is the systematic breakdown of how society was constructed hundreds of years ago. In a word, we are looking at the breakdown of the interdependence of the old social order simultaneously as the new grow independently per Covenants and statutory prophecy.

Consider some of the everyday realities.

### **REALITY I**

#### **Affirmative Action Programs in Higher Levels of Education**

**One.** The recent Supreme Court Ruling against Minority Admission to Colleges and Universities. Many believe the Ruling signals the end of Affirmative Action across all industries.

The core issue of Affirmative Action is easy to understand. The ex-enfranchised blacks' history in America is one of disenfranchisement on all levels of society; therefore, to offset history's wrong, the government removed barriers to allow Blacks to enter the doors of opportunities. Of course, once inside, one stands on their feet.

The U.S. Supreme Court Ruling, on June 29, 2023, on Affirmative Action Admission to higher education has caused increased anxiety among blacks. The American public is still in an uproar over the decision. Colleges and universities have started deleting their clauses regarding affirmative action.

Upon a closer study of the Ruling, the substance of the Ruling might be better than the symbolism suggests.

Another U.S. Supreme Court Ruling struck down President Biden Order's to forgive students' college loans days ago. The Student Loan Program was a financial trap designed to tie low-income students to their low social classes for the rest of their lives. With the ever-rising high cost of living, high-paying **jobs would be** available for some students to pay off the fraudulent loans.

**Two.** There is no question that Affirmative Action in education has enabled many blacks to enter their professional fields; otherwise, employment doors would have been closed. Yet, many black students graduate from college with degrees and cannot find jobs. Such is a fact of life.

Those who enter the corporate world find many roadblocks to climbing the corporate ladder to the top, and only a few make it.

**Three.** Harvard is in the top ten most prestigious universities in America. Like old established universities, Harvard has endowments in the hundreds of millions, if not a billion dollars. Likewise, well-established colleges; therefore, they have an obligation, on the one hand, to admit students whose families make annual contributions to the endowment. On the other hand, universities and colleges admit those students who are likely to have employment with good-paying jobs so that they would contribute to the endowments. With a pool of money, universities and colleges have a long and prosperous future.

Despite the Supreme Court Ruling, Blacks and Latinos filed a suit against Harvard.

- “The complaint, alleging widespread violations of Title VI of the Civil Rights Act of 1964, was filed with the U.S. Department of Education’s (DOE) Office for Civil Rights (OCR),”

### **The 1963 March on Washington, D.C. came as a milestone in America’s Social Revolution.**

The March attempted to build on the legacy of Black Reconstruction and Juneteenth’s aspirations, protection of labor rights, and labor contracts. The Black Reconstruction demands are enduring, for they do not change regardless of who comes to city, state, and national governmental power. Black Reconstruction’s aspirations remain independent of the political party’s policies.

As before the 1963 March, as after the 1963 March, the social and economic conditions of blacks were urgent, the government had to act.

From the demands and public discussions, a confusing narrative emerged and has so remained to this day. The assertion: more government funding is needed to cover a wide range of social programs to close the gap between whites and blacks in educational achievement. From the 1960s onward, black students competing against white students became a pseudo-statistical science in the interest of the political economy of racism—wherein money goes to the victimizers and victims.

Remember, the enslaved people received corporal punishment if caught trying to read and write for hundreds of years.

### **Blacks’ Demand for Education has always been a primary demand Since the 1860s.**

As citizens, blacks pay taxes and expect to see a return of tax dollars to improve their community and education. There is nothing unusual to expect what other racial groups expect and receive.

Since state legislative bodies did not allocate required funding for black schools, then, as a political tactic, blacks demanded school integration.

### **Judah returns to his roots in education.**

As a teachable moment, The Judahite sees the Supreme Court's Ruling as an instrument in consciousness-raising among the Ten Tribes and Judah. As far as impeding blacks' social progress, Affirmative Action **will not** have a negative impact. For the Congregation, it is good, very good. But the Black Gentiles react differently to being left out.

Judah-Alabama built Tuskegee Institute. No one told the black citizens to build a school for training blacks in trade skills and evolve a different level of education for professions to match the growing needs of the black community.

Black nations worldwide came to Tuskegee to learn its mystery and sought financial assistance to build their model of Tuskegee. Booker T. Washington did what he could to organize black schools across America. He was a good administrator. The need was great. Still, Washington had to stay within his limited budget.

Washington would have achieved more important things if not assassinated.

Henry Ford offered to give him his own department at the Ford plant in Michigan if he joined the team. He declined the offer; however, Caver became a consultant to Henry Ford, and some of his research applied to the auto industry.

Relative levels of education and how education is applied. Caver saved the South by working with all farmers to make the transition from the cotton industry to cash crop farming. We all enjoy his research today in the foods we eat.

### **President Kennedy established the standard for integrated education in 1963.**

George Wallace stood in front Admission Office door at the University of Alabama to block black students from attending. Governor Wallace acted for political reasons to prevent black and white students from mixing. Governor Wallace did not oppose black scholarship and academic achievement among blacks. He believed in separate but equal. So did Judah, but blacks, by design, received outdated textbooks and inadequate facilities. The Governor should have said how he normalized separate but equal between the races.

The Morrill Acts of 1862 gave hundreds of thousands of federal lands to states to build institutions of higher education, known as the land-grant. Additionally, the federal government allocated operations funding for colleges and universities. On the state level, under the Land-Grant Act, segregated education took root in America. For the most part, whites profited from free education and the transgenerational Land-Grant Education Act.

President Kennedy was driven by social morality, not just education rights. He deputized the Alabama National Guards to remove the Governor from blocking the door to higher education. Kennedy's position: anyone seeking a university-level education should be able to walk through the doors. His diction and action to remove the Governor illustrated Americans' moral values, yet the overriding concern as the President was to ensure America would have an ongoing educated workforce for an evolving economy to make America strong. Hence, the passage of the Civil Rights Bill of 1964, which he signed into law.

### **Education Summary**

Judah must return to his education system by leaving white universities and colleges because Jacob's tithing-blessings have expired. Even with a college degree, its merits will not command work opportunities because very few employers would be hiring. Comparatively, the record shows blacks never got that much from affirmative action programs.

Judah and the Ten Tribes should consider the symbolic revocation of affirmative action a blessing in disguise. Therefore, attention and energy must be placed on securing a place in the Commonwealth of Israel.

Remember, you will be satisfied if you put time and effort into **planning job opportunities in the Commonwealth.**

### **Reality II Housing**

According to some reports, housing evictions are up 40% for blacks. On the other hand, regardless of race, homelessness is up across the board nationwide.

Decades ago, The Judahite was out in California seeking venture capital funding. People made over one hundred thousand dollars a year sleeping in their automobiles. The reason is apparent. They could not afford to pay rent because the cost of living was too high.

The housing problem is relatively easy to sort out, though there is no solution. Consider,

- a. People are working, but their income cannot cover their cost of living.
- b. The property owners set rental prices. Why is rent so high? Contributor factors are increased property taxes. Bringing properties up to code, the high cost of repairs, insurance, and greed (charge as much as people are willing to pay).
- c. In some markets, monthly rent reflects people making over 200,000 a year.
- d. Homeownership is only an option for some. Cash payment to fund a mortgage require 30% and up. Say, if one purchases a house for \$400,000, cash of 30% is required as a downpayment. In other words, \$120,000 upfront.
- e. It is more challenging to construct more housing when people need assistance to make monthly payments. To understand the complexity of housing financing, the first question for investors is how I get a return on investment.

Obtaining tax credits for housing can be complicated for housing developers. There are many federal, state, city, and county hoops to jump through. At some point down the line, corruption comes into play. Considering the various interests in government housing construction, only a few real estate developers get involved with government programs.

- f. Finding employment with wages matching the cost of living is a big problem.
- g. Mental and health problems force people on the streets.
- h. Lastly, some people wish to be homeless. They don't want to be accountable to any rules and regulations.

A summary point. Housing needs are not an equation of supply and demand. To rephrase, housing needs and homeless never triggered the construction of apartment units and single-family housing construction to meet housing shortages.

Private interest combined with government policy and regulations determines housing construction.

The images below are from California, though the same images can be seen across America. There is no indication when the housing crisis will decrease because the federal government has yet to announce, as starters, 100 billion dollars for housing funding.
