Covenant means agreement. The Elohim establishes agreements, and through them, the Congregation of Israel agrees to what they say they would do.

The Children of Israel are the only people on Earth that have established agreements with Yahawha. However, the righteous Gentiles are guaranteed redemption through genetics, just like the Israelites, but Jacob and his descendants were selected to make the priestly covenant at Mt. Sinai with Yahawah. Everyone in the assembly heard the voice of Elohim reading the Ten Commandments and then agreed to embrace them. To seal the Covenant, Moses sprinkled blood on the body.

A.D. 70 officially liquidated Mt. Sinai's Covenant. The Southern Kingdom of Judah ended.

- *For this reason, Christ is the mediator of a new covenant, that those who are called may receive the promised eternal inheritance—now that he has died as a ransom to set them free from the sins committed under the first covenant.* Hebrew 9:15

In a degree of similarity, the first Covenant with the Congregation took place after they departed Egypt and when into the wilderness on the way to the Promised Land. No! We cannot mechanically duplicate the environment of Mt. Sinai because we cannot regress to immaturity. However, a New Covenant has been made and preserved through the qualifying material conditions of the Man-child. Revelation 12 certifies the qualifying material conditions of the New Covenant.

- *And those He predestined, He also called; those He called, He also justified; those He justified, He also glorified.* Romans 8:30

The Man-child automatically assumes Christ's death, resurrection, and ascension predicated on the Man-child's developmental maturity to receive his second coming. The concept of the Man-child embodies the precondition of the executive body of Israel in Exile back in the homeland governing the Commonwealth of Israel.

- *For finding fault with them, he saith, Behold, the days come, saith the Lord, when I will make a new covenant with the house of Israel and with the house of Judah.* Hebrews 8:8

Judah's Covenant is different from the Ten Tribes.

The Judahite has presented a small sample of the importance of understanding Yeshua's Covenants. At hand, Yeshua's Mission Statement and Soundwave25 have been discussed in different presentations. Still, the provisions and clauses have continued to unfold through the Feast of Weeks or the Harvest Feasts.

The Second Heaven is saying do not put the horse before the cart. The Congregation must grow into consciousness in order to sustain its ongoing evolutionary progression and systematic succession.

Now a Case Study of 27 trillion dollars.

The Judahite has discussed the subject before. The takeaway is validating a historical process of how the dollar amount came to be.

In brief:

- One. Father Abraham was born on February 27.
- Two. The 400-year Covenant has provisions for the Ten Tribes and Judah to leave Egypt With return on capital investment in the social system of capitalism related to Judah and in all forms of equity related to the Ten Tribes.
- Three. In correlation, a remnant of Judah of Sierra Leon provided in part capital, the unsuspended moon that Joshua froze as the time when fighting would continue with the Amorite, and The Judahite, who emerged within the concept of the Man-child to mature with the appointed Feast days.
- Four. On the exact timeline of Angkor Thom, Judah's history was written in Asia at the Temple that Joseph constructed. The Judahite obtained ALL the coordinates from the Temple to know where one of the significant fights would occur in America.
- Five. Springing from Sierra Leon Judah, The Judahite made his introduction into the U.S. legal system. For example, a one-hundred-dollar bill was mistaken as a fake. **WATCH WHAT THE SPIRIT DID.**
At the bank, 1) the police was called, who could not say with 100 % certainty. 2) He took the banknote to the Federal Bank in Minneapolis. The Judahite saw the officer leave the Bank. At this point, it should be noted that they knew the banknote was not fake. If so, The Judahite would have been in jail. Still, they wanted to know if the serial numbers were valid. 3) The only way to find out was to send it to the U.S. Treasury Department in Washington, DC. It came back. **GOOD!**
- Six. The Judahite had to wage legalistic fights in Europe, Africa, and the USA against the Amorites on different fronts.
- Seven. Soundwave25 came. Yeshua announced his visit to complete his Mission Statement.
- Eight. In 2019, the Magistrate of Heaven lifted Judah's 400 years of jurisdictional restrictions. Days later, a lady from tribal Naphtali was suffocated. Later George Floyd was suffocated, as his manner of death caused a national and international reaction.
- Nine. There is a historical index of fake money. Two files with different outcomes. Prophecy gives us a multi-dimensionality to understand the undercurrent. Out of fear of public whiplash, the city gave Floyd's family over 27 million dollars to settle the case. In perspective, black men are commonly killed through the instrumentality of the criminal justice system for one reason or another, legally or illegally, even if an officer is wearing a bodycam. Your attention is drawn to the fact that the awakening process would take place in Issachar.

Ten. So, with all the underpinning related to the Four above, the city prophetically settled the case for over 27 million dollars.

Eleven. The Judahite used the same prophetic underpinnings to arrive at 27 trillion dollars as the takeaway. Furthermore, 27 trillion is already secured.
