### Introduction

Part III is coming. In Part II, the presentation discloses the basis for building a solid foundational understanding of the evolutionary progression to where Judah-Africa is today.

The future holds radically different approaches to the past and presence social systems. The Executive Body of Israel in Exile hopes to bring along as many affiliated groups as possible while knowing many will not be part of the quantum leap due to their hatred toward employing the necessary use of productive time without taking shortcuts.

The Executive Body of Israel in Exile is putting into place the arrangement to enable Judah-Africa's to take the quantum leap, long desired, but without knowledge.

The world wants substantive discussions on when France will abandon its imperialistic system in Africa and allow the people's aspirational hope of self-determination to take root without further conspiratorial attempts to overthrow hope.

The world rejects boilerplate commentary on overturning the election results. Tribal Judah rejects such objection to the rise of military rule in Africa as forever a dead issue, considering the ongoing disputes over the 2020 U.S. presidential election.

### Re-examining the relative concept of democracy.

The American Revolution planted the conceptual seed of democracy years before the French Revolution. The American *reactionary democracy* of freedom and liberty differs from the French in that Ephraim's system of governance influenced Europeans' colonial America.

The Judahite holds to the view that development is fundamentally uneven. Even if everyone starts development simultaneously in different locations worldwide, social development will proceed by natural resources, or the lack thereof, combined with the quality and diversity of skills. Hence, the saying makes do with what you have.

So, after considering environmental and social determinants, the following question to be answered is how work will be organized and how collective wealth will be distributed. Social classes of society naturally form around how society organizes work for the general good of the community.

As a rule, landownership pre-determines how work will be organized and the percentage each class can claim to sustain daily life. The class with the most significant percentage form armed forces to maintain the structural percentage allocation.

Innately, people know to survive and enjoy life, they must depend on all groups or classes independent of their will; personal likes or dislikes are suppressed for the greater good to stay and enjoy life. Even so, throughout history, social classes have been fighting to claim their share of generated social wealth. The fighting is seen everywhere, i.e., labor strikes, costs of living adjustment, vacation pay, tax reductions etc.

In brief, the historical uniqueness of each nation owns its contribution to its country's natural resources. When combined with the quality and diversity of skills, the determinants, a society has an economic system.

### The American Revolutionary War Against the British Monarchy

The origin of America's democracy can be traced back before 1776. The fundamental kernel within the American democracy is Ephraim's code of consensus. In North America, before the Europeans came, tribal Ephraim used the **practice of consensus as a code** to govern.

From 1776 to 1860, the European-Americans opposed the principles of monarchism. Thus, as an accurate definition, the 1776 Constitution portrays a *reactionary class democracy*. Bearing in mind the rallying cry that drove the American Revolution: taxation without representation. The Remembering monarch wanted to keep 90% of colonial wealth and leave colonial America impoverished.

When comparing the American colony's protest reaction to the Crown over taxation, the newly revolutionary government did not seek input from enslaved Judah on how much it wished to be exploited; therefore, to enslaved Judah, there was little to no difference between the revolutionary government and the British Crown.

### Clemency for the Enslaved Judah, The Proclamation Model

For the record, some native Americans (the ten tribes of Israel) fought to support Britain. Ephraim was planted in America three thousand years ago. Yes, they were color people. The Freemen, sometimes confusing, were never in chain bondage. Who were the Freemen at this time in history? They arrived in North America as workers on merchant ships and indentured servants from Britain.

To defeat colonial America, the Crown issued a proclamation giving freedom to the enslaved if they would fight for the Royal Army. Some of the enslaved did so for example, the Freemen, along with the enslaved, received promises of rewards to own land and better social treatment.

#### Lincoln issued his Proclamation.

In 1860, Britain supported the South and slavery. What a changed position! But why? Capitalist slavery proved to be beneficial to England's economy as envisioned by King James I's trading policy with his American colony.

The Proclamation needed to be much earlier to have made its intended effect because it did not impact the predetermined outcome.

### Jefferson Davis ordered enslaved black men to enlist as soldiers.

As a review, the enslaved worked in teams in support of the Confederate Army. By March of 1865, President Davis ordered enslaved blacks to enlist in the Confederate Army as soldiers. Too late, Judah's general labor strike effectively ended the American Civil War.

After Black Reconstruction in 1870, Judah returned to slavery in the form of sharecropping and tenant farming in the overall system of working without little to no pay.

Unlike <u>class-oriented reactionary democracy</u> as displayed in the U.S. Constitution of 1776 to 1860, Black Reconstruction defined its form of democracy differently as proactive democracy. How so, Black Reconstruction, from 1866 to 1870, allowed blacks and whites state representatives to vote input in the way they desired to live and under the laws of their making. In state houses across the South, participatory democracy, in its early conceptual evolution, was the legislative mechanism allowing all people fair protection under the law for the good of their states.

With the Voter Rights Act of 1965 and the Civil Rights Act of 1964, Judah's participatory democracy evolved until reaching a quantitative state marked by the years 2017, 2019, and 2020. The quantitative growth gave way to Judahtocracy in 2020.

### Judah's Contribution to Capitalism and his percentage claim its Global wealth.

Judah's invested labor contributed to capitalism, that is, the accumulation of capital, the golden egg that the goose laid. With the accumulation of capital combined with Jacob's tithing blessing, America became the representative reality of Nebuchadnezzar's tree dream for regenerating the Babylonian global tree of economic prosperity worldwide.

To be mindful, America is a country that practices the economic laws of capitalism. In most countries, capital dominates labor, a fundamental rule of capitalism. The **profit motive** of capital overrides all concerns of labor rights to a secure future.

Truly, Judah wants to collect his return on his investment in the social system of capitalism. Nat Turner, the Asherite, illustrated Judah's global banking character vis-a-vis black oil=black money. Consider the interconnection: Judah's West Asia enslavement harmonized with his enslavement in North America, Texas; it follows, therefore, enslaved Judah's financial international character is represented by black money as illustrated by the Asherite's death ministry.

As stated correctly, Judah and the Executive Body of Israel in Exile are not seeking reparation. Judah demands and will receive a return on his labor investment in the accumulation of capital that engendered the social system of capitalism. Not just from America but from all economies worldwide that practice capitalism and make use of imperialism, which the Man-child stands against as the red dragon emperor.

Often overlooked, King Solomon's riches and intellectual property accelerated the worldwide social system of capitalism. 

Strange as it might sound, France's national policy is a pre-determined paradigm for federal officials to adopt and act within the parameters. Thus, there is no need for different personalities officials, regardless of historical time, to formulate new programmatic objectives to confront the country's challenges. France's worldview is to perpetuate Death and Hell by preserving the status quo.

### French psychology is Self-conflicting.

The French Revolution gave the world the definition of Freedom and Liberty. The monarchs of Europe became a hindrance to human progress. The Jesuits completely understood their mission to open the gate to a new world order to educate the masses, allowing them to discover the many facets of God's materialism in the sciences to improve humanity's quality of life.

Tribal Dan renounced his association with House Jacob. Since then, Gentile Dan has divided into the following sectors: One. He manages the baking industry. Central banking represents its global head as the octopus with fingers networking through all major international financial and banking corporations. Two. Religion. They are best known as the Black Pope or the Jesuits due to their black attire. ### Consider France's historical features:

- a) King Solomon's intellectual assets were taken to France by the Knights Templars.
- b) The Templars and Freemasons used Solomon's intellectual assets to start the era of building the cathedrals of Europe.
- c) Napoleon ruled all of Europe as the de facto supreme ruler. Even Russia almost became Napoleon's subjects. The Pope encouraged resistance as viewed as undermining French authority.
- d) Napoleon sent his general Berthier to Rome on February 10, 1798, to proclaim a Roman Republic and demanded the Pope to renounce his temporal authority. Pius II refused and taken to France, where he died in prison in 1799.
- e) At Notre Dame de Paris, Napoleon crowned himself Emperor Napoleon 1 on December 2, 1804. He took the crown from the hands of Pope Pius VII and placed it on his head, an act to substantiate the pontiff's authority will never subordinate his earthly authority.


- f) The French battle at Waterloo resulted in Napoleon's last war. The Anglo-allied and Prussian armies won on July 8, 1815.
- g) Killing two birds with one stone. The Jesuits and the Freemasons gave Napoleon incorrect military intelligence, knowing he could not escape defeat. As planned, information about the *pending victor* at Waterloo and the *actual victor* would push the stock prices **up and down**. Everyone knew that if France won, Napoleon would have total authority over England and Europe. Through the Rothschilds' information channel, they were the first to see the victor and played the stock market, accordingly, giving them the controlling share in the Bank of England. Days later, news from the battlefield reached England.

### The Danite Rothschilds knew and fully understood 2:20 ratio. Controlling national currency vs. owning national currency.

By 1815, Nathan Mayer Rothschild controlled the Bank of England and boldly declared, "I care not what puppet is placed upon the throne of England to rule the Empire on which the sun never sets. The man who controls Britain's money supply controls the British Empire, and I control the British money supply." This became the Rothschild family's mantra – control the world by controlling the world's money supply.

- h.) France in the Americas. France owned a third of North America. Napoleon had plans to defeat England and forced them from North America, but Haiti and Toussaint Louverture changed his plans. The Levi of Haiti defeated Napoleon's army, and subsequently, France was forced to give its landholding to America, what is known as the Louisiana Purchase.
- i.) Haiti is another case study of the Pale Horse's Death and Hell. Haiti was forced to compensate France for its losses. The reasoning is that Haiti no longer being a slave colony—an investment loss. Indeed, wherever France goes to colonize and eventually be forced from the native lands, it institutes an imperialistic system of perpetual financial degradation. Haiti is a cauldron of endless Death and Hell. Look at Haiti today; it is a living Hell—a breakdown in civil society.

j.) The Rothchild Bank of France triggered the American Civil War. Because the white oligarch class of the South did not understand the mathematics involved in international trading and bank financing, they used different forcible tools to intensify labor to increase production cotton quotas to cover interest rates on bank loans. Yet, indirectly, the bankers depressed market prices on cotton in England to continue the South indebtedness to international bankers. The southern oligarch figured the answer was setting higher production quotas, wrong! They were fighting a losing battle that led to the American Civil War.




Having triggered the Civil War, the French's second-phased plan included creating a base in Mexico from which to give support to the Confederate with the aim of becoming part of the reconstructed South and reclaim its landholding in America. France is good at re-snaking; that is, to loosen its hold only to re-gripe much tighter.

The Battle of Puebla is a Mexican celebration in defeat of French in May 1862. General Nepoleon III led the French Army. On May 5, Mexicans celebrate Cinco de Mayo primarily in America because the defeat is credited to the spiritualism in freedom and liberty as defined by tribal Judah, not by France's archetype of liberty as illustrated by the capture and death of Toussaint Louverture. Napoleon threw Haiti's constitution in the trash. Toussiant's constitution for Haiti mirrored France. The point: the apocalyptic Horse Riders TAKES away PEACE.

Often, Americans associate Cinco de Mayo with Mexico's Independence Day over Spain. An incorrect association, history shows the Treaty of Cordoba on August 24, 1821, recognizes Mexico's independence.

### France's Monetary System

Americans are typically ignorant about Europe's former colonial monetary systems. Even so, there is no need to feel embarrassed, though Europeans have long viewed Americans as geopolitically ignorant. One factor that contributes to international ignorance is that the U.S. Dollar is the global reserved currency or the standard by which global currencies rise and fall in valuation in the exchange of goods and services. Moreover, each day, the bullion prices are announced in London to the world.



America is an imperial power. In origin, America was a British colony and transitioned directly into an imperial power without becoming a colonial power. The contrasting differences, therefore, shed light on neo-colonialism's effective, managerial administrative division of imperialism. In a word, neo-colonialism is a form of imperialism but is not scalable to the level of Chinese

imperialism. Still, the same principles embedded in Chinese imperialism are in all divisional forms of imperialism.

At hand, the CFA franc is a zone currency for fourteen sub-Saharan countries. The above charts are the geographical depictions of two monetary corporations formed with one purpose in mind. The economic levels of activities are uneven for financial manipulation. Now, consider the two central banks, one in each zone linked to France's currency, called the Franch franc. To repeat, the CFA franc is tied to the Franch franc, a global currency. As such, the currency relationships are manipulated to balance the Franch franc to avoid total disequilibrium within 2:20. In other words, France can always steal from WAEMU to pay CAFMC. Or France can steal from both depending on how well the French banking and financial industries are doing.

The two zones are, on the one hand, Benin, Burkina Faso, Cote D' Ivoire, Guinea-Bissau, Mali, Niger, Senegal, and Togo belong to the West African Economic and Monetary Union, or WAEMU. On the other hand, Cameroon, Central African Republic, Chad, Republic of Congo, Equatorial Guinea, and Gabon belong to the Central African Economic and Monetary Union or CAFMC.

The EURO intended to replace the French franc, as with all European currencies, having the EURO as the one currency for all of Europe. There appear to be unsolvable problems with eliminating national currencies.

Regardless, the CFA franc is now tied to the EURO. For the most part, this is terrible news. Naturally, for those not into financed economics, understanding the financial system of monetary valuation and devaluation is challenging. Fundamentally, what one must realize is that the entire financial system rests on 2:20, of which the banking, the financial industry, and the credit system constantly manipulate the ratio through fraudulent means. The national tax system encourages fraud because all business entities must manage their businesses so as not to overextend credit and not hold lots of inventory; hoping the Feds' interest rates would work in their favor; the rate of inflation (the cost of doing business) may foretell bankruptcy. Honestly, complicity is involved in not reaching 2:20.

Each infrastructure is schematized to operate autonomously, independently, and integrated holistically. Effective currency management is vital to all national economies with no exception. It is common to flow national economies with fake currency. Some countries know the culprit, and some do not. It is common for fake commodities to enter the national economy. Commercial warfare never ends because Daniel's 2:20 financial ratio cannot be changed.

# Interoperability within the two primary financial infrastructures to Accommodate traditional and Neo-imperialistic banking transactions.

### Transactional form ONE.

- (a) Neo-colonial banking permits politicians, military leaders, and businesspeople to place millions of dollars on the currency conveyor belt from their national states to Europe's global private banking network. Otherwise, currency cannot leave the country without permission nor enter the country.
- **(b)** No one can control the objective side of life, though people attempt to do so. On point, global changes, due to many factors, adversely affect the neo-colonialist and imperialists' plans. They have in place plans to address the subjective side of which they can best manage. When necessary, the neo-colonialist security office (NSO) gives money to those already conditioned to overthrow the established regimes—a coup and, next, a counter-coup. This action is called go-to-money because it is distributed to the pregualified to carry out NSO's instructions.
- **(c)** Historical records show nearly two hundred planned coups in sub-Saharan countries. Such is a notice to all regimes: be aware because your replacement day is coming. The coup plotters usually want the same position to enrich themselves. Changing places, in and out of power, is not necessarily a serious problem if the outgoing doesn't attempt to change the game's rules to undermine the neo-colonialist interest. Thus, the musical chair continues to rotate, knowing the occupying chair will someday be occupied by someone else.
- (d) Safe deposit options. People with large sums of money hire professionals to transport their money, like Brinks. Or they can arrange their own transport services. In contrast, Brinks operations in the U.S.A. are relatively simple: pick up and drop off currency. In neo-colonial countries, the situation is more complex. In a nutshell, everyone in government is looking for the opportunity to take, using any loophole, as pre-sanctioned by the neo-colonialists for effective administration to prevent a serious threat to their structure of extracting mineral wealth. For a more precise understanding, Brinks will be substituted for a fictitious company called INKS, a professional company like Brinks, but INKS operates in sub-Saharan with banking capabilities. For a conceptualized understanding, think of INKS as a mobile ATM. Like all ATMs, many attempts have been made to break inside to take the cash, triggering a system to spray the banknotes. Likewise, INKS can spray one's banknotes to make it harder for a person to remove the dye if it falls into the wrong hands. Theft can occur in homes, offices, banks, airports, and any point while in transit. Depending on the intentions of the safe depositor, the proper security marking will be applied.

**(f)** In third-world countries, high-worth individuals do not put money into a local bank account, say, 500,000 dollars, out of safety concerns. These are the options:

- 1. Put a security mark on the banknotes and keep the money in one's house or any place.
- 2. One can personally remove the marking or request professional service.
- 3. The professionals are called technicians or engineers, whose training takes place in European countries in the latest equipment and methods for high-quality results in removing security markings.
- 4. Again, a private party can do the work without professionals. While professionals represent banking and financial institutions, caution should always be used.
- 5. When transferring one's currency internationally, professional services must do the necessary paperwork.

From a different perspective of neo-colonial lordship, if living in a francophone country, placing a phone call to a neighboring state, say, to a relative five feet away, the call is first routed to France. Thus, France is always in the loop.

### Transactional form TWO.

The United States of America does not imitate the financial infrastructure of neo-colonial powers of Europe or the imperialistic powers of the East.

As a reminder, America is an imperial power, not a former colonial power. Still, U.S. banknotes, like all other currencies, involve many different security systems to prevent in-transit theft or to make it harder for thieves to cash in.

So much on the criminal side, but not to forget, the neo-colonialist financial infrastructure is designed for their commercial transactions and global trading, AND not for catering to the standard, everyday domestic transitions geared to the general population.

### The larger picture

Everyday millions and billions of dollars are in transit worldwide for different purposes. There are other security systems, of which banknote marking is one among many.

Money laundering is a political term, though used legally for self-serving interest. For example, say, every five to six years, British lawmakers pass laws covering various reporting requirements to ensure non-money laundering. There are ways to get around the law because the laws have specific targets.

For example, the aim is to trap billions of dollars coming in from Africa yearly through trade. In African trading, the transactions are not complicated—the purchasing of raw materials and multinational companies' operational imports and exports. International banking departments are not law illiterate. In the case of omission, the motive is to legally trap and take money coming in from sub-Saharan Africa in the tens of billions of dollars. Still, for whatever reason, when the documents cannot be shown, the account is frozen by bank regulators. Just as planned.

The legislative body is manipulative out of self-interest. The funds are remixed into the budget for foreign assistance and other usage. What a conspiratorial racket!

### Transactional form THREE.

**D**onor nations sometimes, depending on the project, give cash in tens of millions of dollars. As planned covertly, the money is siphoned off and distributed to those intended. Say, for example, if a former colonial state donates cash, the money is taken in a conspiracy, in part or whole, and distributed. Some money returns to the donor nation in one form or another. The scapegoat is always on African leaders. For the record, all donor countries are subject to engage in the closed-loop donor aid program.

- (j) The closed-loop donor mechanism allows political and military leaders to take as much money as possible for personal use. However, as planned, the funds will be recouped either legally trapped or confiscated in an untraceable financial network of trapped doors. The cycle repeats in each round of donor funding.
- (k) The closed-loop donor mechanism allows the imperialistic security officers to best allocate the distribution without and with reporting to regulatory agencies within donor countries.
- (l) America's military shipped 12 billion dollars to Iraq is another example of the closed-loop donor mechanism allows the imperialistic security officers to best allocate the distribution without and with reporting to regulatory agencies within donor and host countries.

### The United States of America's involvement in Iraq Is a case study depicting the closed-loop donor mechanism.

As planned, the money disappeared without little to no accountability. What amount of money returned to U.S. banks and military defense? How much entered Europeans' global private banking system? Indeed, the accounting picture is chaotic, yet controlled disbursing for concealed purposes. Is this called money laundering?

The U.S. Government's action fits the definition of money laundering, billions of dollars are **real money**, not "chicken scratch". Again, money laundering is a political code and can be used by governmental officials for political reasons vs. criminal operations.

### Transactional form FOUR.

Often, Judah and the Ten Tribes forget that it was Daniel and his three executive managers who birth the Babylonia banking-weight-measuring system for the four Gentiles' social systems by giving the financial ratio 2:20. All commercial systems use 2:20 unconsciously, the invisible ratio. However, when mismanaged business operations, the results are bankruptcy or going out of business. Moreover, when a country goes beyond 2:20, an internal social crisis appears. Britain, France, and many other countries are now in a deepening internal social crisis. They are waiting for Judah and the Ten Tribes to push them over into total collapse.

To manage the ratio, fraud and defrauding must be incorporated into the business model. Unethical business practices give longevity to companies.

The United Nations has a long history of acting criminally. It appears to have operational criminalized armed units and institutional criminal practice. For example, transporting large sums of money to assigned destinations like the U.S. Military's 12 billion shipment to Iraq.

Over the years, complaints have been made against the UN troops' criminal acts committed in Africa. Recently, legal action has been filed against the U.N. for having taken 100 million dollars from Nigeria's Women Affairs Dept.

It becomes easy to see that high-level conspiratorial monetary acts are institutional, not in the category of street crime.

### Transactional form FIVE.

This form focuses on inside financial schemes to defraud. It is common for bank employees to rob their banks and financial institutions through electronic means. The focus herein is on senior-level managers working in a conspiracy.

### **Summary**

The neo-colonialists or neo-imperialists possess many financial and economic tools to sustain instability. Because America is an imperial power, not a colonial one, there is no need to design a multi-level financial security system for controlled instability. In contrast, imperialistic America and China operate by assigning their economic hitmen to cause national indebtedness with long-range projections that affect all aspects of the economy and social life in one way or another.

At various times after 1885, Francophone countries have sought ways to move beyond France's neo-colonial system to allow the masses self-determination, implementing initiatives that promise sustainability. Guinea made the first attempt to gain independence from France and succeeded in 1958. Out of reaction, the French sabotaged the economy.

French Gabon hosted the African American Summit in 1993, at which time the government offered dual citizenship to African Americans. What a welcoming gesture of family unity! After Gabon, other countries slowly announced dual citizenship with stipulations. Overall, national leaders were reluctant to commit to dual citizenship for one reason or another. However, the bottom line is fear of disturbing their beneficial positions within neo-colonial administration. One theory for reluctance out of fear that some African Americans might be part of the CIA, not knowing the ones who pushed the speculation were CIA working for the British. The CIA is everywhere and is known to be the leading covert agency eliminating African leaders.

The dual citizenship movement should have and could have taken off in the late 1990s and 2005, which was the optimum period. Today, there are attempts to revive the movement, but institutionalized underpinning needs to be reinstated for sustainability to take root.

Generally, Americans are on the move and will continue to relocate to different parts of the world, particularly in Central and South America, for a better environmental life.

Knowing the psychology of African Americans, they select Africa due to idealistic cultural affiliation. The relocation movement has attracted about 95% of African Americans without lots of money; they are average and are not motivated by dual citizenship. Although most should be considered gems, the social structure in those countries cannot accommodate the skills. In short, the imperialistic structure prevents the productive use of their skills for social enrichment.

The optimum time for African Americans to return and take root was in the late 1990s when critical mass was institutional. For example, the African American Summits attracted the caliber of people who managed major universities in America, agricultural scientists, professors, leading physicians, CEOs running profitable companies, and many other fields for an advanced technological society. These people were willing to graph onto existing African institutions had they seen national leaders exhibiting a visionary future.

Only a fool will seek social degression, going back under an oppressive social structure like the Black Codes without any chance of coming up with the necessary investment capital for foundational building blocks.

On balance, The Judahite has witnessed the invisible hand of evil many times to scramble positive initiatives and thinking to cause ineffectiveness, thus preventing building blocks that would support sustainable development. Now, consider had African governments resolved to allow African Americans to root their initiatives in the late 1990s and 2005, the dual citizenship movement of today would be bringing many intellectual and technological gifts to counter imperialism.

Still, dual citizenship served as an inspirational hope for a better future. Still, African Americans needed more on the commercial scale to offset the business models of nationals from different countries due to their long history in Africa.

Often at international conferences during the 1990s, Ghana became a case study of a failed state. Ghana had a ten-year head start on the Asian Tigers, yet the Asian Tigers' economic growth overtook Ghana, compelling Ghana to seek assistance from the Tigers. What is most remarkable is that Ghana's financial priorities have remained the same due in part to not knowing the practical building blocks for actualizing a societal revolutionary vision. Ghana has the mentality of always going back to reinvent the wheel for an unnecessary self-accolade.

The Judahite sought to put African leaders in the best of light, which meant giving them credit if they improved the living standards <u>of the masses</u>. That is the measuring stick, not personalities per se, as they come and go.

### Despite respectable plans put forth over the years, they yield no sustainability.

Many respectable economic plans with remarkable results, in part, are temporary achievements. However, national leaders' implementation plans, sooner or later, run into inherited constraints. Neo-imperialism is a powerful global system that can wear down and overturn any well-intended economic plan. Out of reaction, some African leaders see China's imperialism as the best escape option. There is a materialistic basis for African leaders to embrace China's imperialism because it is an open door through which to see their image of progress regardless of associated problems.

However, they don't understand the working definition of imperialism. Imperialism is imperialism with the **pre-defined financial objective to debilitate** a country or countries. As another example, Nigeria's loan debt to China is now 4.73 billion, according to the latest IMF Regional Economic Outlook on Sub-Saharan Africa.

In summary, the character of imperialism has two operational faces, Mr. Jekyll and Mr. Hyde. Or the means justify the ends. The heads of government make decisions good and bad that incorporate self-interest. Whether the West is evil or the East is good, each country must measure its overall societal progress by sustainability relative to their own past societal progression.

### The Congo contributed to the American Model's originality.

The Judahite evolved consciousness when seeing different countries' national business models in operations across Africa. Upon an examination, The Judahite concluded those business models would not work for African Americans, though they are effective in producing profits.

The Congo allowed The Judahite an opportunity to work out the American model. It is a repeating cycle; foreign aid is given again under the pretext of goodwill.

Judah; Reuben; Gad; Asher; Naphtali; Manasseh; Simeon; Levi; Issachar; Zebulun; Joseph; Benjamin.

Being called by one's biblical identity adds to each person's prophetic endowment—a future of cultural enrichment. The Mosaic Curses have been very effective; therefore, regaining consciousness is a work-in-process. The Bible gives historical markers to Judah as to when consciousness would be restored. For example,

Jeremiah's Seventy Years prophecy.

- Supernatural Soundwave25 signaled the continuation of Yeshua's Mission Statement to restore sight to the spiritually blind and to release the captive from bondage.
- The Year of Jubilee
- The 400-year expiration date occurred in 2019, according to the Abrahamic Covenant.

Since 2019, in one way or another, the Israelites have moved in disassociation from the Gentiles in search of their tribal membership. Have you reconnected to your family affiliate? Or, are you still calling yourself black, African American, African, Haitian, or by names of different nationalities? Select your tribal name now!

Slowly, as Judah and the ten tribes discover their biblical identities, automatically, they practice and adopt biblical PRECEPTS, leading to separation from non-Israelites. Tribal members possess a different moral standard, no longer attached to all aspects of moral decadence in popular culture. In the main, people return to the standard of social etiquette that existed from the 1950s backward. Proverbs and Psalms and the Golden Rule were our social guardrails. Today, people have lost their moral compass.

As a distinction, there is a difference between separation and social isolation. As such, in the interest of the end-times re-gathering of Judah and the Ten Tribes, moral separation becomes one of the markers for asserting claims of tribal affiliations. Everyone will take notice once the social guardrails have been re-erected.

For the twelve tribes, democracy <u>belongs to the OLD order of society</u>. # Previewing Judah's history when returning from America to Africa. The embarkation to the Americas and transported to the four corners of the world.

The Back-to-Africa movements had stated reasons and hidden motives for sending blacks back to Africa. The best way to understand the evolutionary progression of the movement is in stages; that is, what was the threat at that moment in history and the projected threat. The final phase of the movement was driven by the idealistic hope of a better tomorrow, a place of peace.

As always, the day's politics always come with fictional imaginary attachments. For the record, there was never serious intent to relocate the enslaved back to Africa because the Europeans had not fully explored western frontier, and Texas was in much demand for slave labor, having advanced skills for continued civil infrastructure building. Although never at the forefront, the Back to Africa movement was driven by imperialistic motives. Libera became a success through the same hard labor that formed the Americas.

As a political issue, the Freedmen were a bad influence on the enslaved, as they desired a taste of freedom just like the Freedmen. The answer to the potential problem was shipping Freedmen to different locations worldwide, and in so doing, the colonialists multiplied colonialization.

America had a bright future, as told by Jacob. Many enslaved people made many inventions, enabling the economy to grow by leaps and bounds. Migrants came by the millions, and those migrants who had a strong desire to contribute to a strong economy piggybacked off existing inventions and created more inventions.

America reached critical mass; it became an environment of commercial inventiveness. The agricultural industry provided colonial America and the American States with the best of food than other countries in Europe and elsewhere. Tobacco and whiskey were the best in the world.

As said before, slave plantations were like small cities and towns; they were self-sufficient, manufacturing onsite tools.

Generally known, capitalism always requires free and cheap labor; therefore, those with imperialistic motives saw African American colonies in Africa as qualitatively different from European colonialization. The American imperialists needed an educated ruling class to govern their own state instead of employing unproductive administrators in faraway lands.

At that time, Egland was the only place to obtain a higher level of education. After 1870, the American educational system leapfrogged over England because of the Land Grant initiatives affording Europeans free education. Just the opposite regarding Tuskegee. Yet, the college became a beacon for the ex-enslaved illiterate.

### Liberia

The African Americans worked through many complex problems to establish Liberia, though they had a model of their own creation from which to emulate—the US Constitution of 1776. In time, Liberia established an imperialistic trading relationship with America, the Firestone Rubber Empire. Firestone out of Ohio became the largest employer in Liberia and the leading manufacturer of auto tires in America.

As always, the asked question, who gains the most out of imperialistic trading relationships? The answer is the same: imperialistic capitalists. Even so, there is no need to dwell on the inadequacies of the dominated. Imperialism is imperialism. On the other hand, the only way to gain from imperialism is to legally structure the relationship. As in the case of Liberia, the government retained legal authority over Firestone, a plus!

**Negatively,** national leaders needed to possess skilled knowledge to time phase Firestone investments into an economic plus. It takes the diversity of educational knowledge and experimentation to chart a sub-industry from the primary industries of imperialism to serve the developmental growth of the nation. Often, leaders and their people reveal their own commercial inadequacy by blaming those who take advantage of them.

At one time or another, each African country claimed a bright moment of success—still, the question of how to sustain commercial evolution outside the neo-imperialistic banking and financial industries. No African country has an answer. The world is in prophetic motion, for the 400 years have expired per the Abrahamic Covenant.

Consider many European countries currently are in deep economic crisis. Even in America, there are states now in decline due to increased poverty, lack of industry, poor educational systems, crime, illicit drug use, and the wide gap between high-income and low-income. Also, not to omit, there is a spiritual component to the decline of states, cities, and countries.

With a little common sense, how in the world do African leaders think that they can outrun and outtalk their destinies? The masses of Africans are sick of the perpetual hyperbole of a better future. Look at the masses of people departing Africa, risking their lives, hoping for a better future. The mass migration tells the story in a nutshell.

### Sierra Leone

Sierra Leone's formation as an African state occurred through several historical incidents related to the anti-Trans-Atlantic Slave Trade. Additionally, some of the founding members fought in the American Revolutionary War as ex-slaves of George Washington.

The enslaved people received Lord Dunmore's declaration to fight for the Crown of England against the breakaway colonies in exchange for their freedom. From 1775-1776, the recruits in the tens of thousands became part of the Ethiopia Regiment, a black regiment.

A British company known as the Sierra Leone Company was formed around 1792 to accept the ex-slaves. From 1808, they started to arrive, and in 1896 Sierra Leone became a British Protectorate.

Britain ended its legal slavery in 1834, but other European states continued exacting enslaved people, compelling the British Navy to intercept slave ships. The intercepted ships came from Angola, from the port of Benin, and were forced to unload at Sierra Leone. The enslaved people arrived in 1619 at Jamestown, North America, came from Angola. Thus, with relative certainty, the Sierra Leonean transplants were mostly from tribal Judah.

Prophetically, Sierra Leone is organically related to America. Making a conjecture: it is well established that many melanated people were in North America before the Europeans arrived. Indeed, they were native Americans because they were translocated three thousand years ago from Egypt. Some Native Americans were enslaved and shipped to different parts of the world before the Europeans' arrival and during the Europeans' colonial period.

It was common for merchant ships to raid the Atlantic coast of America and take captives to Europe to sell. Those Freemen who fought for the Crown along with the enslaved were a mixture of Judah and the Ten Tribes.

As a result of Britain's defeat, the Ethiopian Regiment disbanded and relocated to safety in the British colonies in the Americas and later to Sierra Leone. The defeat set the organic condition for the conceptual relationship between Judah-America and Judah-Africa.

Neo-imperialist England sought to model Sierra Leone along the imperialistic model of France and America. As such, they would get a better return on investment. The transplanted states would have to fend for themselves. England made an agreement with Sierra Leone wherein they would give military protection in exchange for trade with high-priced imports and a percentage on mining natural resources. Although unknown to many, foreign aid to Sierra Leone comes back as a corporate dividend.

Canada is an example, a mixture of French and British neo-imperialism.

### Judah-America has a track record of his interaction with Indigenous people of Africa.

Unlike before, prophetic Judah makes an imprint in stepping toward the Commonwealth of Israel. He is coming to regather remnants of tribal Judah. He is coming with a narrow focus to establish Judahtocracy concerning time-valued resources. The Executive of Israel is not coming to compromise or to negotiate. Why would Judah want to go back thousands of years to revisit the same issues currently facing the masses, having the same proposed answers?

What does the future of Africa look like? E-commerce and the rise of electronic imperialism will force African states into a combined two systems. One part of Africa will exist as a permeant, impoverished state of dependency under the hegemony of electronic imperialism. The other part of Africa will vanish, and the indigenous population will either be assimilated with foreign nationalities or become extinct as non-productive members of society. Time doesn't wait for those without a visionary attachment to the Stone Kingdom, a planetary pre-defined social system with no end.

At each stage of history, African leaders give the same inspirational talk of a bright future only to fall backward by taking the same course of action, not realizing that they are the problem.

The astronomical human and technological resources required to put Judah-Africa on the correct course, a complete break from the OLD, in a relatively short period, don't exist in Africa or Europe.

To avoid a misstatement, The Judahite makes his assertions, the trajectory on current **social trends** leading to the **combined two systems** within the next thirty years.
