

Substantial Meaning of Juneteenth Vs. Symbolic imaginary

Two Constitutions Exist

The American Constitution of 1776 is familiar to all Americans. The Constitution is defected in its design construction. Why? Fundamentally, Dan/Jesuits/Freemasons vs. Edomites/Idumeans wrote the Constitution, expressing ideological conflict.

The Preamble to the Constitution of 1776 introduces anti-monarchical rulership and anti-nobility. The Boston Tea Party came as the preamble to the new American nation—taxation without representation.

How in the world could economists, bankers, etc., not know that there is no money tree? Yet, they fell for a quick-get-rich cryptocurrency scheme promoted by a con woman who disappeared with the money. For the record, she was coached by those attached to the global elite.

Wholesale stealing or defrauding is built into the system of capitalism and imperialism. The Judahite understands Marxist economics, where the fundamentals are applied. But the major leap in knowledge came when studying empirical cycles substantiates defrauding as a built-in mechanism to address the problem of long waits for the circulation cycle of capital's conversion into liquidity after the goods become commodities.

Given the anarchistic nature of capitalism, manufacturers produce commodities without knowing when all the products will be sold. At some point, the economic system collapses because all clever manipulations cannot make all parties complete through loss recovering, causing disequilibrium—a perpetual financial reality. As a summary point, the criminality of fraud and defrauding, the essential core of political economy, operating in all aspects of the economy, cannot maintain the 2:20 ratio artificially.

Imperialism

Marx worked out his economic theories while working for the East Indian Company. In a collaborative relationship with Manasseh. As a rule, no one could challenge; however, many contributed to his words. His works became the theoretical cornerstone of capitalism.

America emerged as monopolistic capitalism, but it had to give way to the evolving maturity of imperialism. Why?

The things are relatively low cost to produce with very high mark up.

Thanks to advanced algebra, China can work with multi-level matrixes, which best characterizes centralized globalism. Under the CCP centralized policy, the contradiction between

labor and capital counterbalance within an integrated policy matrix warns off the unpredictable winds of market pressures that disrupt, i.e., inflation and high-interest rates.
