Eliminating Diversity, Equity, and Inclusion (DEI)

There are two ways to interpret the submerged Hornet at the bottom of the Red Sea. First, the sign serves as a divine parallel declaration that the Red Sea is the graveyard of Pharaoh's army due to its attempt to reclaim the Israelites' free labor by returning them to Egypt.

As Moses foretold, the Israelites would return to Egypt not on foot but by ship in a different era. Now, after serving 400 years in Egypt and America, the Red Sea stands as a historical landmark for returning home by ship. The Red Sea is the perfect symbol for the exilic return, as it harmonizes with the two pathways from Egypt and Egypt/America to the Promised Land.

The tow tractor represents the current unstable Gentiles' war plans to defeat the Houthis and Iran, using the hornet's definition, in contrast to the biblical hornet's modality.
