Dear Mr. President:

**Subject: Authorization Letter for Commissioning U.S. Armed Forces Transportation Services, including airplanes and ships, for the Gaza Reconstruction Project (GRP). Your support is invaluable and deeply appreciated.**

In The Judahite's presentation entitled Prophetic Endorsement for President Trump's Authorization Letter, the discussion gives a prophetic perspective of your two-term presidency with Judah's forecasted authority and now actual authority per the Judahtocracy inauguration on January 20, 2025. This authority extends beyond your current term and is crucial for successfully executing the Gaza Reconstruction Project.

Having been appointed similarly to King Cyrus, Mr. President, you have served as the beacon for the planetary event of Judah's return to his ancestral homeland through the Abrahamic Transitional Movement. Your vital role in this movement has facilitated the Gaza Reconstruction Project by recognizing Judah's prophetic authority over Israel in 2017.

Once Gaza's reconstruction begins, the first phase of the Messianic era will start and continue for the next thousand years. This project holds great significance.

The elements of the Letter of Authorization for using U.S. Armed Forces airplanes and ships are outlined below. These elements include the specific types and quantities of aircraft and vessels needed and the duration and scope of their use, as detailed in the presentation titled "Prophetic Endorsement for President Trump's Authorization Letter." With their surplus of aircraft and cargo ships, the U.S. Armed Forces are uniquely positioned to support the GRP effectively.

- I. The Gaza Reconstruction Project (GRP), a private organization, requests a Letter of Authorization from President Trump to use aircraft and other materials for the reconstruction effort. This request is made under Article 1, Section 8 of the U.S. Constitution, which empowers the President to issue a Letter of Authorization to private groups and individuals. We remain particularly aware of the President's foreign policy approach regarding Gaza, which identifies HAMAS as an adversary of America. We believe this authorization will significantly contribute to advancing the Abrahamic transition movement.
- II. Alongside Article 1, Section 8 of the U.S. Constitution, GRP is entitled to monetary funding based on a) the administration's policies regarding the Middle East, b) the spirit of change apparent in the recent presidential Executive Orders, and c) the current American foreign policy focused on asserting control over Gaza for the prophetic interests of tribal Judah.
- III. The Letter of Authorization must be issued within the Second Heaven Court Calendar Dates of March 2025. Over the years, the Calendar Dates published by Second Heaven as operational dates have consistently shown the stated operations, validating enforcement for predicted operational events to advance the Abrahamic Transitional Movement.

The Letter of Authorization is the most effective request requiring minimal effort; however, a better method under presidential powers may be available to achieve the same goal of authorizing the use of aircraft and cargo ships for GRP through an alternative presidential mechanism.
