## July 4, 2025, marks 249 years since America's rise and its current decline.

July 4, 2025, isn't just a usual day of hot dogs, parades, sports, park barbecues, and fireworks; it also marks 249 years since the birth of the American Republic in 1776, a meaningful milestone.

### What is the significance of 249 years?

Firstly, EZRACH defines 249. Secondly, ALOGOS provides its definition of 249.

In other words, 249 means ezech in Hebrew, and 249 means logos in Greek. Thus, the prophetic meaning of July 4 holds dual significance, as it celebrates the birth of the American Republic while ironically indicating its decline.

Researching the 249 years, Strong's Concordance, H249, shows that the Hebrew word "ezrach" means "native-born."

Without question, the idea of American democracy is based on the ten civilized tribes of Israel, known as the Native Americans. They were brought to North America by Joseph, the ruler of the Egyptian Empire, over three thousand years ago.

"Native-born" refers to those who are under the Abrahamic Covenant. Alternatively, 249 falls within the fourth generation—an oath of restoration or liberation; with the expectation that Judah receives a return on his labor investment regarding the accumulation of capital. The Ten Tribes of Israel can expect equity contributions derived from their services in the growth of capitalism and imperialism. Thus, 249 is an accounting ledger qualifier.

Understanding your tribal family enhances your insight into end-times prophecy. Many social and economic labels have been assigned to Judah and the Israelites, but it's important to release the outdated labels. Prophetically, Judah and the Ten Tribes must embrace their biblical identities by excluding, for example, blacks, Africans, African-Americans, Hebrews (covering all of Abraham's descendants), African-British, and so-on. We are the Children of Israel, chosen by God.

Always stay clear-headed. Those who aren't part of any patriarchal families can choose whichever label they prefer. The Israelites should, when necessary, identify themselves by their tribal family name. During the upcoming 2026 first-wave exodus, it will be required to refer to yourself by your patriarchal family name.

Knowing one's tribal family provides a significant advantage because it helps distinguish between Israelites and non-Israelites in the necessary ways of worshiping the Most High God. Indeed, the distinction must be made for cultural and moral reasons, as outlined in the Covenant. Gentiles are not excluded from worshiping the Most High God, nor are they excluded from Christ's grace.

The Israelites must establish themselves as being the blessing in the Messianic era to become a blessing for all, except for the Serpent's descendants.

We read from Genesis 15:13:

- *Then He said to Abram: "Know for certain that your descendants will be strangers in a land that is not theirs, and they will serve them, and they will afflict them four hundred years."*

Because of prophecies, the Israelites accept the concept of predestination not mechanically, but as outcomes or features of a process.

July 7, 2019, marks the end of Judah's 400-year constitutional jurisdictional restriction. Therefore, the events of July 4, 2025, and July 7, 2025, symbolize the final phase of the American Empire and the acceleration of the American exodus. First, as foretold, the nations and the social system of capitalism are now being punished according to Babylon's demise. Simultaneously, Judah and the Ten Tribes must continue preparing to identify monetary assets for transferring them to the homeland as part of the four hundred-year accounts settlement.

Secondly, ALOGOS defines 249.

In Strong's Greek Concordance, G249 is called *alogos*, which means "irrational" or "unreasonable." Moreover, "it describes something or someone lacking reason or logic, often in the sense of being brutish or lacking sound moral judgment."

"Alogos"249 highlights the effects of Jacob's tithing blessing evaporating, now causing the collapse of our social system and government. July 4, or 249, marks a moment of duality: on one side, irrationality reflects society's system breakdown and regression. On the other side, Judah and the Israelites prepare for the Messianic era as their guiding future.

Many people reminisce about the bygone years and seek to recreate them. Being separated from the Messianic era, they do not realize that the past they long for will never return. In fact, they cannot understand that their golden age in history will never come back, never to be seen again!

The Stone Kingdom is the future.

Back to the date of origin, this marks the day when Judah was constitutionally placed under jurisdictional restriction by becoming a political pawn in the U.S. Congress. Indeed, Judah was The three-fifths compromise was constitutionally incorporated into the U.S. Congress through voting shares allocated to the Southern states. Since the South was an agricultural region with a smaller voting population than the North, Congressional members agreed to count every five enslaved people as equal to one white man. Therefore, 3/5 became the official name for the apportionment formula used in voting on legislation.

It was effective in managing voting on and passing legislation, preventing one party from outvoting the other, and ensuring that laws were enacted with the interests of a united Republic in mind. While 1877 (the Tilden-Hayes Compromise) ended the 3/5 congressional formula, the Gentleman's Agreement became a congressional practice in 1877 between Southern Dixiecrats and Northerners and started to decline after the passage of the 1965 Voting Rights Act.

However, the Gentleman's Agreement ended during the Vietnam War era when the Southern Oligarchs, representing old Southern wealth, were voted out of Congress. The white business class, which emerged after 1865 as a distinct socioeconomic group and developed its own economic identity, fought as a separate class to protect its interests, different from the southern oligarchy.

During the hundred years of the Black Code Laws, the white business class gained economic resources through illegal means to grow and expand, thanks to the Atlanta Compromise of 1895, in which Judah would not demand legal rights in exchange for stopping racial brutality.

Historically accurate, the Vietnam War is viewed as America's Second Civil War, sparked by Judah leading draft resistance against the Vietnam War, though it expanded to include opposition to all imperialistic wars in third-world countries until the U.S. Government recognizes Judah's right to self-determination under the United Nations' Convention and grants first-class citizenship rights to Judah and the Ten Tribes of Israel. Until then, Judah's rallying cry remains: Hell no, we won't go to war!

The 249-year prophecy signals a period of societal disintegration, which should be understood in conjunction with other judgmental themes that share overlapping emphasis. The 249th year is linked to Jeremiah 50:25. Nevertheless, the Judahite received full confirmation, 100%, that Revelation 7:3 has been fulfilled in the sealing of God's servants, not his prophets or priests.

We are currently in a period when the four angels are carrying out their designated punishment on the land, as shown by 249 flash floods. Although these floods are widespread across the country, they are especially significant for Texas because they symbolize the removal of the spiritual root that is offensive to Judah's rising spirit, as seen in his cosmic butterfly.

## **Communication Protocol July 4, 2025.**

On July 4, 2025, the Judahite's bathroom and closet experienced supernatural flooding with no external water source to explain where it came from. This isn't a new phenomenon, as water puddles have appeared in different parts of the apartment over the years, often matching specific messages. The Judahite quickly understood the sign and its meaning on July 4.

As before, the signs relate to historical events, milestones, and future punishment. The 249 flash floods uniquely washed away trees, buildings, and negative thoughts, disrupted community lifestyles, and forced government systems to adapt within the scope of Jeremiah 50:25 to remove obstacles to Judah's Relocation Transitional Movement.

Texas has a history of facing unprecedented natural disasters rooted in Judah's enslavement. While chattel slavery as a system is understood, individual masters had a range of treatment toward Judah to express their own spiritual personalities. An economic system in which whites, blacks, and Native Americans were slave masters.

Judah is a blessing for everyone, as outlined in the Bible. Only a few people understood the ongoing mistreatment of Judah by the Serpent's descendants as part of a continuous spiritual battle, starting in the Garden of Eden. Like in all conflicts, the warring sides seek allies; some Gentile whites were drawn into the conflict on the Serpent's side, which led them to destroy the very source of prosperity—the goose that laid the golden egg. Nevertheless, God's plan for enslaved Judah could not be stopped, as He provided the cosmic butterfly sign to symbolize continued growth.

Judah claims territorial rights in Alabama and Texas because of his prophetic missions to promote constitutional democratic rights in Alabama (1964 Civil Rights Act) and for the nation, and in Texas to support the international oil and energy industries, as exemplified by the Petro-dollar, as Nat Turner's prototypes illustrated. In other words, Texas is Judah's international commercial gateway.

Juneteenth was an undercurrent in the flash flooding on July 4. It was no coincidence that the flash flooding first showed its biblical devastation in Texas.

The Judahite discussed the significance of Texas in a previous conversation. In short, on June 19, 1865, enslaved Judah received the Emancipation Proclamation in Galveston, Texas, two years after President Lincoln issued it. Since then, Judah has remembered that day, which has become a state holiday.

On June 19, 2021, Juneteenth became a national holiday when President Joe Biden signed it into law. On both historic dates, the cosmic butterfly appeared as a sign of Judah's stages of evolutionary maturity, which marked the Leavened Bread doctrine or the Feast of Leavened Bread. Attributed to Juneteenth, Texas is seen as a subgroup within the larger 249-Flash Flooding Weaponry. As a result, 249-Texas, a specific category, faced God's wrath quickly because the opposing forces are the steadfast anti-cosmic butterfly metamorphosis of Judah's spiritual transformation. ## **249-Texas adds another formidable weapon of wrath to its list of judgments.**

**Just as Texas's flash flooding was used on July 4, opposition forces will also become targets of a few heavenly weapons and vanish quickly, never to be seen again.**

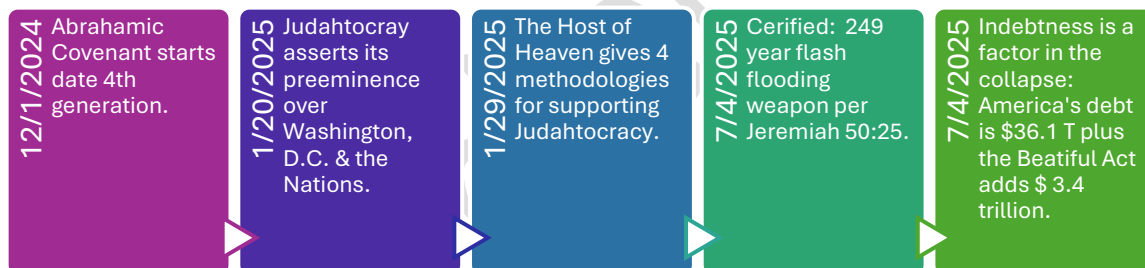
**Why did the 249-flash flooding weapon inspire such divine fear in so many people?**

While true, the U.S. Capitol Building is a symbol of the nation, Judahtocracy, on the other hand, is destined to become a planetary system. Therefore, Judahtocracy, synonymous with the Stone Kingdom, is a social system without end.

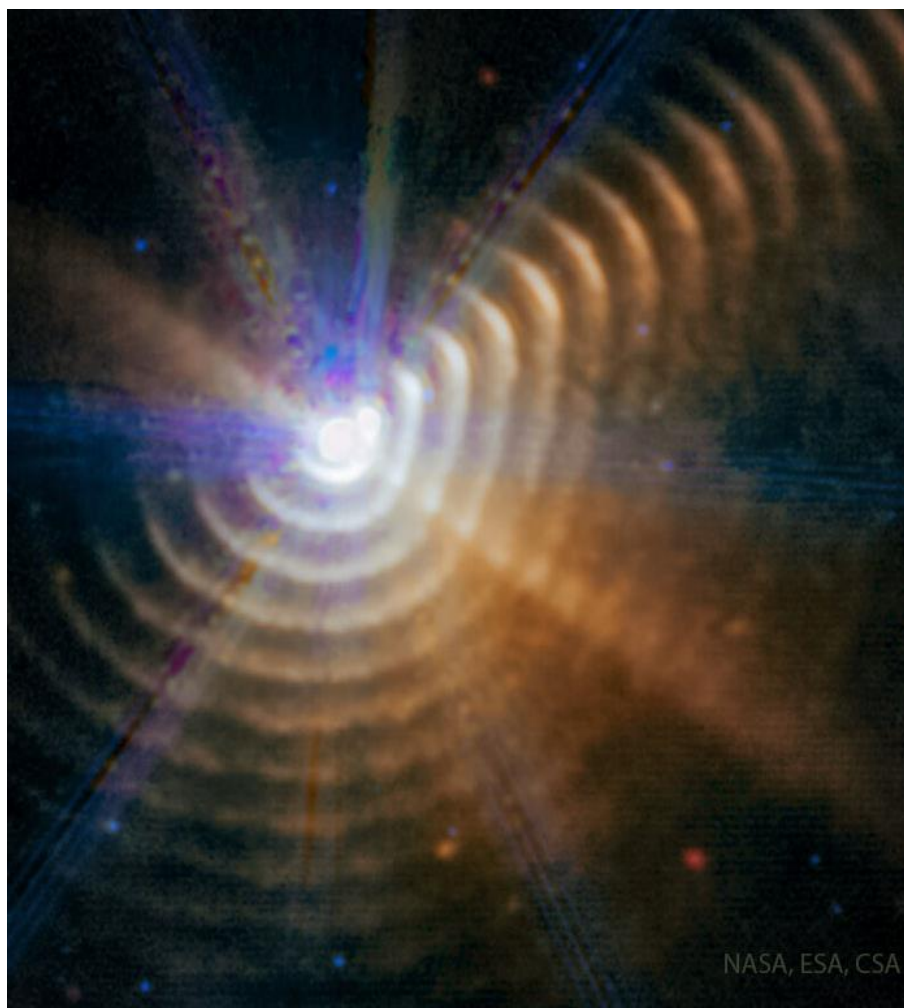
So, on January 20, 2025, the U.S. Capitol Building stood as a reminder of Judah's ongoing growth since his efforts in building the Capitol.

As a foundation, Isaiah 19:19 provides Judah with the blueprint for social progress within American democracy after the passage of the 1965 Voting Rights Act. As a result, Judah has moved from being enslaved during the construction of the District of Columbia, including the Capitol, to now being spiritually mature enough to take control of the declining American Empire.

As of December 1, 2024, the Ten Tribes and Judah are currently unfolding in direct relation to the Abrahamic Covenant article of the Fourth Generation, which predicts the punishment of America and the United Kingdom, forming the Babylonian Empire of the West. The Judahite has notified them of their own cup of devastation, supported by all the prophetic milestones since 2017.

Prophetically, on January 20, 2025, the U.S. President was inaugurated at the U.S. Capitol as the forty-seventh President of the United States. During the inauguration, unaware of anything except the Judahite, the heavenly host watched, listened, and took notes. To sum up, (1) the Blackhawk helicopter collided with a passenger airliner, (2) a fighter jet crashed in San Diego, (3) the passenger airliner traveling from Minneapolis to Toronto crashed and landed upside down, indicating a reversed set of rules for Judah to use in governing his former oppressors and those who belong to the den of liars and the house of perverts. And (4) a U.S. aircraft carrier collided with a merchant vessel in Egypt's transit canal.

The four incidents propelled by the methodologies are particular to asserting Judahtocracy legitimacy. The Host of Heaven's authoritative power is vast and will continue to be prophetically seen under statutes and heaven's judicious decrees worldwide.

Since the first four illustrative methods of deconstruction were introduced, these approaches have been used repeatedly. The benefit of understanding the 4-Judicratic approaches is that no need to emphasize their importance each time an incident occurs. America's debt is \$36.1 trillion. The Big Beautiful Act, signed into law on July 4, 2025, will add \$3.4 trillion to the national debt over the next ten years, and interest will continue to accrue.

### **Indebtedness is crucial for managing credit and tax systems.**

Indebtedness is an important regulatory financial tool that supports the credit and tax systems. While the statement might sound idiotic, debt is a necessary economic evil. It is easy to understand the interplay of credit, taxes, and debt. Every day, working families realize that when you earn more money, higher taxes follow, and to avoid paying more to the government, they often make purchases for tax write-offs. Acting on two fronts, while tax write-offs help, the rising cost of living creates an income shortfall: hence, the need for more credit or borrowing. Some people have ten or more credit cards. They rely on credit cards to make ends meet.

The capitalist system is built on killing, stealing, and moral corruption. In fact, the Son of God revealed to us the three ways the devil operates: "to kill, steal, and destroy."

Standing in contrast to debt, the Israelites' Commonwealth of Labor will replace the commercial debt system, thereby removing the incentive to commit fraud.

## The importance of historical figures: the Protagonist (Judah) and the Antagonist (Gentile Dan).

### The Torah prohibits making interest loans within tribal nations.

The Torah forbids interest-debt because it functions as a regulatory tool of indebtedness and a mechanism of oppression.

Judah has gained awareness of his labor power over the past 400 years; Dan's financial and banking industries no longer influence how labor's value is determined or how profits are maximized. The antagonist, Dan, is no longer a factor in future planning.

The Israelites' Commonwealth of Labor will evolve into a flexible system where anyone can join at any time and place on Earth to contribute to meaningful work based on skills. Need skills? No problem.

There will always be a demand for labor because labor will never again transform into variable capital under capitalistic production.

## Understanding the transitional step, from the Tabernacle to Temple-Banking

The LORD entrusted the blueprints for the Tabernacle to Bezalel, a tribal member of Judah, and to Oholiab, a tribal member of Dan. Each was given specific skills and a division of labor to build the Tabernacle. Exodus 26:1-4. Oholiab took on the role of interior decorator. Dan learned the importance of both open and closed forms of communication, which he would later develop as a technique to govern nations in general, and specifically, all the tribal governments of Israel.

### Dan's Profile

To most students of history, Dan has been hard to pin down. What's notable about him is that he moves around, vanishes, and reappears in different historical eras, each time with a unique persona. It's to Dan's credit that he is best seen in motion, like a sidewinder snake. Dan has always stayed true to his ideological skills, which are subversion and deception.

Dan discovered the secret of debt from the Torah, which forbids interest to be levied upon any tribal member of the Congregation of Israel.

On the other hand, the Israelites could lend with interest to the Gentiles, both righteous and descendants of the Serpent. Moses instructed the Israelites to be the lenders, never the borrowers, in their business dealings with the Gentiles and with the Serpent's descendants.

It can be argued that with divine knowledge and skills in interior design systems, craftsmanship in gold processing, and the ability to lend money at interest, Dan was motivated to become a Gentile because he could, and indeed did, amass wealth for himself and government officials by using branches of national governments and/or kingdoms. Dan consistently operates at the executive level of organizations, where he can effectively leverage his policies and programs.

Unlike Dan, Judah continued observing the Year of Jubilee, as outlined in Leviticus 25:8-17. Every seven years, debts are forgiven, and land is returned to its original owners. Judah ceased this practice after AD 70 when he went into prophetic exile for over two thousand years.

### **Daniel provided us with a model that exemplifies Dan's traits.**

Daniel modeled Dan's conspiratorial operational strategy that would persist until the end of the Gentiles' Age.

Daniel twice opposed the conspirators' efforts against Judah's restoration. First, he appeared before King Belshazzar of Babylon to interpret the handwriting on the wall. Later, during King Darius of the Medes' reign, Daniel challenged the conspirators who plotted to throw him into the lion's den to kill him; afterward, they continued their scheme of corruption by taking money meant for rebuilding the Temple.

Often overlooked as a prototype, the conspirators and their families were thrown to the lions once their conspiracy was exposed. Indeed, an active model of divine justice until the fourth kingdom's end of days.

It must be stressed that under the decrees of Nebuchadnezzar and King Darius, anyone who offended the God of Daniel and his three leadership officials—Hananiah, Mishael, and Azariah—would face punishment, which could include being turned into a dung heap. Therefore, the fear of self-incrimination has consistently haunted conspirators throughout history. For self-preservation, they operate in secrecy—the true power behind all those who are publicly visible.

For self-preservation, Gentile Dan always operates within the highest levels of government and society's institutions, which provide him cover for his subversive activities aimed at influencing the core institutions in line with his ideological mandate to manage society.

To avoid confusion, the tribal people of Dan may or may not have a physical presence on site; however, Dan's strategic policies, which allocate tens of billions of dollars in grant money annually, influence decisions either directly or indirectly through funding. Numerous financial institutions, such as the World Bank and the International Monetary Fund (IMF), finance applications from national governments worldwide under a set of restrictions established by the Bretton Woods System. Additionally, funding is supported by global industry leaders and the Association of Investment Bankers. Even in America, charitable foundations distribute tens of billions of dollars in grants each year. The recipients are those whose programs best align with Dan's overall goals.

**Money exchanges within the Temple foreshadowed the Church of Rome's financial dealings and the Gentile Danites' transactions involving enslaved Judah (symbolic Mt. Zion).**

Metaphorically, Christ pursued Dan, the Jesuits, and the alliance involving the Edomites (Vatican/Holy See) and the Hamites (Arab slave traders), who created the global slave market to buy and sell Judah across different parts of the world. Judah is represented as embodying the doctrinal feast of Tabernacle. Christ threw them out of his Temple.

**Gentile Dan is a knowledgeable history student and understands Daniel's framework model regarding the Gentiles' four social systems on Earth.**

Indeed, Daniel offers us a framework to understand the chaos and irrationality we witness and experience daily as society gradually nears the end of Gentiles' rule on Earth. Instead of disappearing overnight, systems of capitalism and imperialism will fade into obscurity. However, most of us expect a significant one-time event—that will cripple the entire system—known as the Day of the LORD. This includes, but is not limited to, the Death Angel on the night of the Exodus, which killed millions in Egypt.

Daniel stated that under King Nebuchadnezzar, Babylon would be the head of gold, and that later kingdoms or social systems would be less valuable, since the monetary system is designed to follow a cycle of growth and decline.

Paradoxically, gold devaluation—mixing other metals with gold to create an alloy that lowers its value—extends the period during which capital products can circulate and be exchanged in the market between buyers and sellers before they must be converted into liquid money or currency.

Extended capital value or credit-capital allows manufacturers to produce and sell their products into the credit supply chain until the products are sold. At the point of sale, when the goods or products are sold, the manufacturers then receive payment for the goods sold. In theory, the cycle then begins again.

Daniel and his three executive managers demonstrated their theoretical model of capital devaluation and circulation by generating monetary wealth for the Persian Empire, estimated to be over \$500 billion, during its decline to Alexander the Great. These financial resources fully supported the construction and operation of Alexandria, Egypt's city, which was a major wonder of the ancient world—a global center of knowledge.

### **Purchasing Power.**

Purchasing power is another way to understand how capital moves and its exchange cycle. Hypothetically, one ounce of gold once exchanged for four pickup trucks; now, one ounce of gold only buys one pickup truck. Yet, the devaluation allows millions more people to purchase pickup trucks because more and more individuals work in factories to produce various parts for the truck. Yes, economics is a paradox.

We recognize Karl Marx, a Danaite, for his writings summarizing Daniel's financial model and introducing a conceptual theory of capitalism. However, it was Lenin who created a framework for understanding imperialism through his efforts to advance a higher level of algebra. The Danites partner with China, which promotes imperialism, and now China is the second-largest economy in the world. Biblically, the snake controls the dragon.

Daniel demonstrates the 2:20 prophetic ratio, where two parts gold to twenty units of measure symbolize Judah's efforts for future economic systems. If any financial or banking systems try to exceed the 2:20 ratio, an imbalance occurs, as reflected in the cyclical patterns of rising inflation and recession (economic contraction), both domestically and worldwide.

This invisible ratio constantly drives capitalism and imperialism to struggle with maintaining stability in the financial and banking sectors, preventing disruptions in currency devaluation during transactions throughout the economy. Of course, there is a perpetual cycle of disequilibrium, as seen in corporate buyouts, bankruptcies, going-out-of-business postings, and company downsizing.

## Summary

The passage of the **Big Beautiful Bill** into law, like all bills that aim to raise the congressional debt ceiling, risks causing an inevitable economic collapse without irreversible solutions.
