## Getting off to a fast start

Whenever the Chaldeans are mentioned, the thinking goes back to ancient times. Thus no one sees the relevancy of the Chaldeans in today's world. Regardless, today's judgment finger points to the Chaldeans.

Due to the terrible judgment facing the Chaldeans in 2022, the LORD's Visionary anatomy unmistakably identifies the Chaldeans' character of today.

- I. The Chaldean is an ideological paradigm of legal origin to steal and kill. It is rooted in King Nebuchadnezzar's Decrees that gave **legal protection** to Daniel and his three executive managers and their God. According to the King's Decrees, anyone found insulting Daniel or his God would be killed and his property destroyed.
- II. Daniel, acting as the magistrate judge, tried King Belshazzar of Babylon, Nebuchadnezzar's son, and executed him according to the Law of Babylon and the Consent Decree made between the LORD and King Nebuchadnezzar.
- III. King Darius received the keys to the city of Babylon from Daniel after the Babylonian Empire went down in defeat. Having Darius' trust, Daniel and his three executive managers became the executive managers over the Persian Empire. Daniel continued his banking policy under the Medes and Persian Empire. The generated wealth was staggering beyond comprehension. The Chaldeans truly believed a magic money tree existed, and they had every intention of getting their share--a problem. Daniel would not go along and would report their corruption to King Darius.
- IV. Being very sophisticated, the Chaldeans allied the sheriffs, presidents, governmental officials, legal counselors, and law enforcement officials throughout the Kingdom to work around the Decrees. Today's national governance systems are an archetype of the Babylonian and Persian.
- V. Daniel as the magistrate judge delivered his Recommendation and Order to King Nebuchadnezzar:  
*"My lord, the dream be to them that hate you, and the interpretation thereof to your enemies."* Daniel 4:19
- VI. In a conspiracy hatched up by the Chaldeans, Daniel was sentenced to the lion's den because he did not participate in the Chaldeans' corruption system. Because the lions could not kill Daniel, the conspiracy became known, and all involved were sentenced to the lion's den with their families.  
King Darius's Order gives insight into the Chaldeans. Perpetually, operating in a conspiracy, family and professional associates always form the core of institutionalized corruption.

- VII. The Chaldeans' paradigmatic ideology evolved out of self-protection by encouraging all to become stealers and murders. In such a manner, when caught, the legal system would slap everyone on the wrist, always better than death.

## Part One

Habakkuk issued a complaint against Judah because of his corruption and injustice. Habakkuk asked the LORD how long and what is going to take to chastise Judah. The LORD gave Habakkuk a two-part answer. And the second part, He told Habakkuk to wait for an answer; he would get back to him on the question.

### Section one

In your days, you will see among the heathen wonder marvelously what will become of Judah. Hab <sup>1:6</sup> *For, lo, I raise up the Chaldeans, that bitter and hasty nation, which shall march through the breadth of the land, to possess the dwelling places that are not theirs.* The Chaldeans were known for their third-degree brutality without any hesitation. Habakkuk asked why use a barbaric nation to chastise Judah, fully recognizing the court order against Judah was final.

The Discourse continued. *"O LORD my God, mine Holy One? Will we all die? Your eyes are pure and can see evil and iniquity. Those who deal treacherously against men more upright than the wicked should not be punish. The treacherous regard men as fishes of the sea, as the creeping things. 'They take up all of them with the angle, they catch them in their net, and gather them in their drag: therefore, they rejoice and are glad."*

There is no need to continue discussing the detailed account of Judah because history offers large volumes about the Babylonian Captivity, substantiating the foretold history given to Habakkuk.

### Section Two

Habakkuk prepared himself to discuss the judicial merits with the LORD involving the use of Chaldeans as an instrument in the Consent Decree with imposed limitation to deal with the unrighteous and time expiration.

- "I will stand upon my guard post and fix my foot upon the tower: and I will watch, to see what will be said to me, and what answer I will get to my complaint." Hab 2:1

<sup>2:2</sup> "And the LORD answered me, and said, Write the vision, and make it plain upon tables, that he may run that readeth it. <sup>2:3</sup> **For the vision is yet for an appointed time**, but at the end it shall speak, and not lie: though it tarry, wait for it; because it will surely come, it will not tarry. <sup>2:4</sup> Notice his arrogance, the unbelieving— he has no inward uprightness — but the righteous will live in his faith."

### Habakkuk and the LORD reached the Consent Decree on three Woes:

<sup>2:9</sup> Woe to him that coveteth an evil covetousness to his house, that he may set his nest on high, that he may be delivered from the power of evil! <sup>2:10</sup> Thou hast consulted shame to thy house by cutting off many people, and hast sinned against thy soul.

- <sup>2:11</sup> **For the stone shall cry out of the wall, and the beam out of the timber shall answer it.**

For those who might be displeased, this usually is the case. Habakkuk ends his discourse on the instruction of silence, emphasizing the Consent Decree is for a future time with a time limitation to bring the Chaldeans to the task. A thousand years into the future.

- Hab 2:20 But the LORD is in his holy temple: let all the earth keep silence before him.

## January 2022

On January 8, 2022, the High Court took Judicial Notice of its own Consent Decree.

- <sup>2:3</sup> **For the vision is yet for an appointed time**, but at the end it shall speak, and not lie: though it tarry, wait for it; because it will surely come, it will not tarry. <sup>2:4</sup> Notice his arrogance, the unbelieving— he has no inward uprightness — but the righteous will live in his faith."

Upon Notice with The Judahite, the High Court assigned **January 13, 2022**, as the date for revisiting the Order.

In timely preparation for January 13, The Judahite reviewed Habakkuk's prayer acknowledging Judah's wicked deeds had been met as the precondition for addressing the Chaldeans' evil deeds.

As seen, Israel and Judah no longer exercise productivity within the jurisdiction of Israel, a daily reality for thousands of years since AD 70. Therefore, the doors are now opened to review the Consent Decree Order involving the Chaldeans' fate per Jeremiah.

## January 13, 2022

On January 13, 2022, the sky became the signboard, upholding the TIME required per stipulation in the Consent Decree.

Observing the early morning sky, a cloud row and rows formed different configurations appearing and disappearing in seconds. They were not contrails, though facsimile of contrails because they were miraculous. While on display, a spider appeared on the wall as a sign for The Judahite.

Why on the wall? An analytical interpretation follows. The Chaldeans were instructed to follow Jeremiah's orders on demolishing the Temple. All would have instantaneously died, if the Chaldeans acted like hoodlums, ransacking the Temple.
