

Judahcracy Reclaims from Dan Mosaic Formula: Seven Financial and Economic Tenets for Success.

Cautiously, The Judahite opens this presentation with politics, knowing the dynamics of the 2024 state and federal elections will add unnecessary weight to their importance in relation to the rise Judahcracy. This presentation is not about traditional politics regarding the two major parties.

Looking back

Tribal Judah has always been driven by self-determination (Genesis 28:68) yet is aware of being an integral part of the United States of America. There is nothing monopolistic about Judah doing for self. All arriving racial groups in America sought their ethnic communities for assistance in all aspects of daily life, including investment opportunities.

As members of their respective ethnic groups, proactive individuals sought better employment training, and higher levels of education resulted in higher income levels. Their new material conditions automatically compelled them to shed many aspects of their customs and traditions when they entered the American middle and upper-class society.

The present commands the future. Having acquired new social stability, the immigrants started to build generational wealth that gave family members a head-start on life's journey.

Many proactive individuals obtained legally and illegally the necessary capital to start businesses. Searching for investment and operational capital is never-ending and doesn't guarantee long-term success. Still, acquiring the necessary forms of variable capital is a predeterminant for achieving success.

A problem-need creates its own answer.

The stock market came into creation due to the need for financial capital to multiply itself. The stock markets are forms of gambling casinos where the risks and rewards are shared. Due to good management, many companies grew into economic pillars where they funded their growth and expansion without seeking bank loans.

There is nothing magical about success. Someone must devote time and effort to creating design plans or concepts. Even the Devil must work to deceive people. Overall, like-minded people, as a rule, come together and endorse a plan of action. Next, they look for investors or find ways, legally and illegally, to finance their goal to make money.

American Plutocracy

Since the founding day of America, three fundamental world outlooks have driven America's

future. (1) The Freemasons promoted the New Atlantis; (2) Manifest Destiny is a European's nationalistic sentiment for using all means to justify taking the Ten Tribes of Israel's land; (3) Judah's prophetic worldview is based on (a) Joseph's having relocated a percentage of the twelve tribes to North America, (b) the Mosaic Curses related to Ephraim and Judah, (c) Daniel foretells when the global tree of economic prosperity would regrow during Judah's enslavement, and (d) under the Abrahamic Covenant's clause about the 400 years of social oppression and economic exploitation.

As an ancient people, the Congregation of Israel, despite spiritual and psychological servitude, believes their stay in North America is transitory. Thus, Judah's worldview endures longer than the others because their premises mistake the relativity for the absolute.

Tribal Dan

Tribal Dan has been and continues to be, for political purposes, an on-and-off switch. For the record, tribal Dan is divided into different classifications, the Gentile, and the original family of Jacob.

Gentile Dan has played a significant role in world history, particularly in building the American Empire. (1) Gentile Dan operates within the global central bank system. (2) Dan/the Jesuit co-share leadership with **the office** of the Pope, Edomite (Esau), and (3) share ideological views with the Freemasons. Dan the snake moves in locomotion according to his three design formations.

Tribal Dan has a long history of acting subversively to undermine the Congregation of Israel's doctrinal integrity. The Bible foretold about the antagonistic relationship between Dan and Judah in the story of Samson and the story of Daniel in the lion's den.

Judah would always stand opposed to Dan's conduct of ill-repute. For example, Judah jumped Samson/Dan on his way home to bring his parents to his Philistine-style wedding. God gave Samson the strength to kill the Lion/Judah. (See the reasoning for Daniel's placement in the lion's den.)

After gathering his parents for travel, they went down to Philistine. While on the way, Samson told his parents to continue walking while he had to do something. Samson entered the bushes and saw his killed lion with vast amounts of honey running out of its mouth. Samson got a handful of love and shared it with his parents.

Pure golden honey symbolizes Judah's preserving love for the LORD's commandments. Pure love, without threats, is why Lion/Judah jumped Samson/Dan so that he continue enjoying all the sweet things of life under the LAW.

Two pathways of destinies. Dan likes to act contrary to God's commands by twisting the Word of God. As with Samson, Dan turned his back to God after receiving the supernatural gifts of physical strength. The misused spiritual gift led to his suicide. Ironically, in death, the misuse maintained the LORD's prescribed statute.

Dan's subversive world outlook applies to anyone seeking to undermine Elohim's commandments and statutes. Countless people are hell-bent on disregarding the Scriptures by going their own way in the company of others as they have lots of entertaining fun.

Dan the Gentile.

The LORD directly downloaded secret knowledge to Dan regarding his assigned task and to Judah his assigned task in the Tabernacle's construction.

Dan used the knowledge at the right historical moment to serve his personal goals in separation from Judah. In time, history assigned Dan to form banking temples for financial interest enslavement.

Operational guidelines Dan uses.

- *And the LORD will make you **the head and not the tail**; you shall **be above only**, and not be beneath, if you heed the commandments of the LORD your God, which I command you today, and are careful to observe them. Deut. 28:13*
- *When the LORD your God blesses you as He has promised, you **will lend to many nations** but borrow from none; you will **rule over many nations** but be ruled by none. Deuteronomy 15:6*

Recapping

- One: you will be the head and not the tail.*
Two: you will always occupy the advantageous position in contracts dealings.
Three: you will lend to many nations.
Four: you will borrow from anyone.
Five: you will rule over many nations.
Six: no nation will rule you.
Seven: and carefully follow the commandments of the LORD your God.

Tribal Manasseh of India retained Daniel's banking methods from the Persian and Babylonia Empires because Manasseh was part of those Empires.

Later, Karl Marx, the son of a Jewish Rabbi, worked out the mathematical science of Political Economy for the capitalistic social system. Only Gentile Dan understood Marx's economics, while others only understood factional parts. Thus, the Gentiles' lack of understanding gave banking Dan the advantage to construct capitalism's financial infrastructure based entirely on the Mosaic Formula: Seven Financial and Economic Tenets for Success.

Instructionally, Dan birthed Monopolistic Capitalism, which has evolved into imperialism, having the form of global corporate fascism.

3/5's Constitutionality and the Biblical equation of its face value.

Out of historical necessity for the U.S. Congress to establish a voting mechanism for legislative governance, the 3/5 compromise became the reality. The explanation: Say, five enslaved persons equate to one white man. Constitutionally, being half-animal (chattel), and half-human, Judah became intrinsically interwoven with congressional voting.

U.S. Supreme Ruling on Dred Scott outlines Judah's jurisprudence on ownership labor rights as an instrument belonging to the master regardless of location. Dred Scott's ruling, per Judah's jurisprudence, always has subject matter jurisdiction in state and federal courts of law.

Tribal Judah could not escape his inextricable constitutional role to co-develop with the American Empire while evolving to become the master of his instrumentality, his own jurisprudence.

Later, after 1871, the Global Central Bank System replaced the U.S. Constitution of July 4, 1776. Under THE UNITED STATE OR "THE CONSTITUTION OF THE UNITED STATES OF AMERICA of 1871, Judah finally became the master of his instrumentality (working for himself and continuing to create inventions). Judah and the Ten Tribes expressed their desires and interest in governmental protection like everyone else when allowed to vote.

The Problem.

Under the old constitution of 1776, 3/5 property ownership was non-convertible. Had the 3/5 allowed convertibility after the Civil War, Judah's pan-private property jurisprudence would have preserved its integrity. Per subject matter jurisdiction, the plantation owners received compensation for their emancipated enslaved workers. What about the 3/5 political doctrine? Judah was promised by the government forty acres and a mule to enable a head-start for reconstructing a new life, but the promise was never honored. A tiny percent of enslaved soldiers with arms went and took their forty acres and a mule as promised.

“THE CONSTITUTION OF THE UNITED STATES OF AMERICA OR THE UNITED STATES of 1871 allowed Judah’s jurisprudence to become a working reality to a certain degree. Capitalism had reached a stage wherein workers could sell their labor power as a commodity. Good news, but it would be many decades before tenant farming would fade away and wage slavery destitution.

The Downside of Electoral Politics

Since 1965, the graph chart shows black participation in local and national elections, in general, did not drop sharply. Painfully clear, electing a black face to public office doesn’t automatically derive expected outcomes. Still, people should run for public office if desired, but structural changes are impossible.

Black politicians must inform black voters that they can do only so much about making structural adjustments to society. On the other hand, they should say, “We have some flexibility when it comes to improving community safety and social life.” Going back to the late 1960s, the black community has pinned hope on black officials only to be disappointed.

Since the 1980s, blacks have become more realistic in outcome voting. In general, Obama’s presidency cemented their ambivalence. For example, Obama’s presidency was a milestone in America’s history.

The Black Community tactically misread the timing of their historical moment when they voted for Obama.

In brief, the Obama election campaign had the character of a **social movement**. He could speak along the rim of social philosophy, enabling him to separate himself from other politicians. The black community expected so much from his presidency. Contrary to the right-wing misinformation, the black community was not seeking increased public assistance.

The black community was looking for a new set of economic policy initiatives. Factually, his Administration did not have to spend additional money on the black community. He could have funded an effort through his executive departments to unite the black community to work out a self-help agenda and establish protective policies around their endeavors.

His failure, in part, is due to a lack of understanding of historical governmental policy dynamics attributable to black social movements. A few presidents before him fully understood black social movements and **supported crafted** legislation to address aspects of the black agenda for the good of the nation. Obama grew up in Asia and Hawaii, which partly accounts for his lack of black experience.

There is a significant difference between living enslaved people’s lives and empathizing with social injustice. The homosexual rights movement in its early days compared their discrimination to blacks. What? Civil Rights mixed in with LGBTQ. Judah continues to fight such linkage as a national policy.

The fundamental difference in the quest for social rights, regardless of impulse, is that Judah and the Ten Tribes' pursuit of human rights, not civil rights, are given and taken under the Abrahamic Four Hundred Years Covenant and the Mosaic articles of Blessings and Curses.

At any rate, once Obama entered the White House, he distanced himself from his social philosophy as a mass political mobilization ploy. Why? His social philosophy of individualism held nothing sustainable.

Obama's own words:

"I have a special responsibility to look out for the interests of every American. That's my job as president of THE UNITED STATES. And I wake up every morning trying to promote the kinds of policies that are going to make the biggest difference for the most number of people so that they can live out their American dream."

Obama failure to deliver something impactful to the black community caused the younger black voters to start voting Republican, what now appears to be a trend. The proof is in the putty. For example, the Republicans in the last election took over the House of Representatives, which should not have occurred given the general political atmosphere in American politics.

Pope Francis checks President Obama.

Most significantly, "Pope Francis assumed command of the U.S. military by declaring war on Obama via Attorney. The Pope claims civil authority over the United States of America." The Pope was motivated to restore the U.S. Constitution of 1776, the organic constitution. Pope Francis is a Jesuit, and as such, he always embraces its creed and codes over and against the Vatican's office or the Papacy.

As a tell-tell sign, Pope Francis convened the Court of Ages to oppose Obama. For the Pope to play his **Ace of Spades**, a dark force had to be behind Obama, not visible.

Having discussed the Jesuit's history in previous presentations, The Judahite gives a few words of clarification. A section of tribal Dan formed the Jesuits, a clandestine and intelligent organization to advance the teachings of Jesus. The Jesuit maintains its independence, yet at the service of the Pope, if they agree on the mission. The Jesuits seen in black robes are only a narrow view of the entire organization. To avoid misunderstanding, a percentage of Danites still consist of members. However, those who embrace its creed and codes are Jesuits, not Danites.

They stand second to none when combining the Pope/Vatican with the Jesuit's intelligent organizations. Genesis 49:17-18 gives insight on Dan/Gentile's action in the latter days.

- "Let Dan be a snake in the way, a serpent in the path, that biteth the horse's heels that his rider may fall backward. I will look for thy salvation, O Lord."

As an example of latter-day events, Pope Francis, the Jesuit, portrayed Dan biting the heel of the charging horse, causing the rider to fall backward. As with all presidents, Obama stands **under** the authority of an unseen global power.

Judahcratic rulership embodies the Executive Body of Israel in Exile.

The Judahite understands the workings of politics and is indifferent to party politics. Yet, he understands the need to vote self-interest instead of party. Isaiah 19:19 has been faithfully upheld and promoted for holding social oppression in check; otherwise, nothing would stop the desire to eliminate Judah and the Ten Tribes.

Now, about voting for the U.S. President, usually, the global elite selects the candidate that would become the next U.S. President. To run a successful presidential campaign requires nearly a billion dollars. Only people in the corporate world can fork over tens of millions of dollars.

The most popular votes don't elect the president. The electoral college selects the president, a mechanism deeply rooted in the **Rights of Nobility**.

The rise of Judahcracy relegates the two-party politics to the lowest level of insignificance because Jacob's tithing-blessing has expired, and there is no more sourced water.



COVID-19, The Global Pandemic.
The Congregation has yet to be fully appreciated the Pandemic
In their favor, as in the pre-exodus.

Back in December 2019, The Judahite received unexplainable signs during December. The characters represented great magnitude.

In brief, COVID-19 prepared the Congregation to see massive judgment on the biblical scale seen in ancient Egypt.

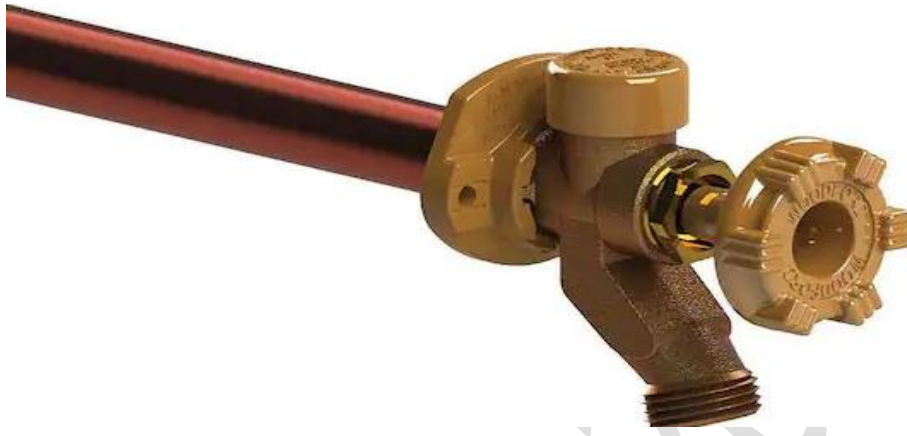
Jacob's Tithing-blessing to the Gentiles has expired.

The March on Washington 1963

Sixty years today, August 28, 2023, a time to look back and forward.

As the correct perspective, the 1963 march is a resultant of one hundred years of the Black Code Laws used for reconstructing the South. After the Civil War, three different reconstructionist plans emerged. A. The overall national reconstruction to reorganize the states under the thirteen Amendment in the interest of international bankers. B. The South came to the realization that it no longer had influence to control the legislative agenda in Congress. The South was in desperate need of capital and loans. To reconstruct the southern oligarchy, they ratified the 13th Amendment and agreed to unfavorable terms of bank loans. C. Black Reconstructionist put forth a radical legislative policy to include both black and white in the New South. Its legacy is public education.

The Compromise of 1877 put an end to Black Reconstruction, killing the democratic character of the New South.

During the next one hundred years, the southern white business class came into its own primarily by black capital's subsidization, providing the critical mass for the self-definition of white supremacists. The Judahite has always presented presentations free of emotionalism because its misdirect from the intended objectives to learn. On point, lynching blacks marked the stage when the white business class consolidated its control over Judah and the Ten Tribes. As an auxiliary to the southern white business class is sexism of political economy. Not one of the cause of action for lynching had evidence of justification. As such, consider the Mosaic Curses.

Despite social oppression and economic exploitation, Judah's bedrock remains contract enforcement and fairness in employment.

A summary point of the historic March on Washington the largest in the nation's history up until that time.

- One. The democratic March had no impact on the U.S. Senate or Senators, as they upheld the 3/5 rule, or spirit of 3/5.
- Two. President John Kennedy understood the 3/5 moral spirit of 1776 was outdated, anathema to representative government.
- Three. Kennedy's proposed 1964 Civil Rights Bill requiring bi-partisan support for passage. Comprehensively, the bill guarantees equal rights protection. Essentially, the bill calls for deconstructing the Black Code Laws and reversing the Compromise of 1877.
- Four. After Dr. King's rally speech, President Kennedy invited the leaders to the White House to assure them of his commitment to racial equality. Dr. King's speech
- Five. As a significant person to Judah's bedrock grievance was Walter Reuther of the United Automobile Workers (UAW). Unity in strength. Union organizing in the South assured fair wages and adjustments to the cost of living.
- Six. In major southern cities, Judah pushed to unionize. Additionally, boycotts became an effective front-line tool to address black grievances. Corporations expanded their planets and operations in the South with the political proviso of fair treatment to all employees.

Dr. King's I Have a Dream speech captures the spirit of the March.

Now is the time to reveal what he saw through multiple prophetic lens.

Finally

Was Dr. King's speech I Have a Dream about Social Integration?

No! The prevailing social liberal view in the 1960s promoted social integration. Emphatically, the black community did not prioritize social integration. As a basic historical fact, enslaved Judah has always had a working relationship with his master in commerce. So, what is new and different? Living in one's own community was cherished.

The only problem then and now is protection and providing necessary civil infrastructure. The Black community saw nothing wrong with separate but equal. The Problem: separate but unequal in education and tax revenue spending on community improvements. The states should have shared federal tax dollars fairly.

As a growing nation, a few whites could see down the road twenty and fifty years and realize America could lose its competitive edge if human resources continued to be underdeveloped. Two workable options: social integration was one option of which most whites opposed. Another option is that the federal government could have formed a national body to ensure separate communities are given a fair proportion of state and federal tax dollars.

At any rate, being a visionary, Dr. King gave a judahcratic dictum about the rise in Judahcracy. He pointed out that skin color should not determine righteousness; the person's character should be the yardstick for judging people.

His death signaled the rise of Judahcracy, for he had nothing else to contribute to The United States government of 1877.

Like Moses, the LORD allowed Dr. King to look over the river Jordan to see the Lands of Promise and Joshua. Like Moses, he was joyful:

Mine eyes have seen the glory of the coming of the Lord

He is trampling out the vintage where the grapes of wrath are stored

He hath loosed the fateful lightning of His terrible swift sword

His truth is marching on !

The Death of President John Kennedy, the Civil Rights Act of 1964, and the Texas President Johnson.

There is endless speculation regarding the assassination of President Kennedy. As a correct perspective regarding the rise of Judah and the destiny course of Judahcracy, President Kennedy was killed due to his pending plan to remove the central banking system from America. Also, death befell President Lincoln when he planned to make the Greenback the national currency, thereby replacing the idea of central banking. The international bankers and the Jesuits put him into their crosshairs.

As an unintended consequence of his death, Johnson became the U.S. President and continued pushing where Kennedy left off. The Texan did lots of arm-twisting in the U.S. Congress to push through the Civil Rights Act of 1964 and the Voter Rights Act of 1965. Johnson had lots of dirt on Congress members, allowing him to push through the Judahcratic Acts.

A teachable moment. Only people from schools of advanced knowledge about global history know that social development has a historical law of materialism that must be followed. Per se, a great mind has little to nothing to do with the social rules of action. In other words, ideas and plans **divorced** from history end up in the trash, as are countless worthless plans for the world's future.

Daniel gave us an Image Statue depicting the Gentiles' four social systems. He outlined the milestones and events of how one will blend into the other and how one social system will transform into the other. Johnson became great because he understood historical patterns. And the prophetic relationship between Texas and Alabama.

Tribal Judah has two operating states. Alabama is the domestic home state, and Texas is the national and international staging state. There is a functionality overlap between the two conditions.

Texas has played a significant role in the Judahcracy's evolutionary development.
