Part I

Africa's Destiny

Introduction

This presentation embeds different topical angles as they exist as realities. The approach focuses on the underlying spiritual/religious driving the Hamites and Shemites to travel in diverse directions. Some aspects of African history will remain the same, at least in the foreseeable future. In a topical angular discussion, a concise summary tells why.

The Judahite did not prioritize saving Hamitic Africans, only the tribe of Judah and true worshipers of Israel's God, Yahawah. For example, Ethiopia is a Hamitic Christian country covered under the New Testament when baptized per the Apostle's Tradition.

The Judahite has found the calculus and will move strategically to fashion a new people per the policies of the Executive Body of Israel in Exile.

Part I presentation lends toward disciplinary people, respective of their fields, for further technical studying with the aim of application. Part II provides the strategic scope of operations.

Africa has different predestined roads to travel. Unlike America, Joseph established Ephraim's colonies in the Americas while he co-rule Egypt.

Africa's destiny has different roads. The Judahite throws into the garbage can several misconceptions favorable to Judah's policy positions on engaging a particular African sector.

There are many theories and perspectives on Africa; therefore, this presentation deals with historical and theological issues as audit trails to ensure workable unified policy positions for the Congregation. The aim is to weed out those in the Congregation who like to look backward and focus on the past without little relevance to the present and future.

Because Africa is a location of confusion and separation, this presentation uses the Scriptures as guidelines for policy guidance and legislative initiatives. No! The policy objective is not to save all of Africa but rather re-unite with the true worshipers, the biblical pre-selected, to combine with the Commonwealth of Israel in exile.

- *"From beyond the rivers of Ethiopia, shall my suppliants the children of my dispersed people bring me an offering."* Zephaniah 3:10

This presentation is mindful of the Second Heaven Principality, whose jurisdiction covers Africa and whose role is to act antithetical On Demands against Mt. Zion's governance.

From Daniel, we learned of the different Principalities' jurisdictional authority—for example, one over Babylon, Grecian, and Rome. Gabriel did not highlight Africa because the universal **principality covers the world** and operates at the sublevel of particularity.

Ham knew this fact when he saw Noah uncovered and left Noah's tent to inform his brothers. Ham had the spiritual insight to see the universality of Eve and Canaan being the particularity. In each kingdom and social system, the universal character is seen and known to be anti-righteous and pro-wicked.

In Moses' time, Moses and Arron give us the archetype for On-Demand Antithetical Principality. Continuing from Moses, Yeshua's temptation in the wilderness defines divine fulfillment of purpose within the Son of God's doctrinal philosophy represented by Arron's staff over governments and the Bronze Serpent for those spiritually misguided by the Egyptian's religious schools.

In the larger picture covering all Principalities, The Judahite returns to the Edenic Judicial Decree that outlines Yeshua's First and Second coming, foretelling the resolution of each stage. In the Second coming, the Serpent's descendants will become immobilized, no longer able to deceive through lies and spiritual defrauding.

Canaan is an Index to the Post-Flood Sexual Eugenics.

**Noah walks us back to the exchange between
The Serpent and Eve through the Curse of Canaan.**

After the deluge, the Elohim blessed Noah's three sons and commanded them to re-populate the earth. Genesis chapter ten gives us the Table of Nations from the three brothers' families. Moreover, the book of Jubilees records the geographical divisions worked out among the three brothers and approved by Noah.

Many postulate that Africa is assigned to Ham, Europe & parts of Asia are assigned to Japhet, and the Middle East & parts of Asia are allocated to Shem. Not so hard and fast, says The Judahite, the geographical locations of the three brothers overlay each other as seen in different historical eras.

Consider the LORD has moved large populations over thousands of years from one place to the other, and in many cases, family member groups per the three brothers' nationalities have been erased from the earth or assimilated into more prominent families. Thus, by looking at the results, absoluteness was never the purpose, only relativity to evolving the Gentiles' social systems.

The LORD's Curse Agents:

Famine, prolonged draughts, wars, earthquakes, diseases, natural disasters, and areas that cannot sustain viable economic activities due to the ground being saturated with innocent blood.

In different parts of the world, religious philosophies hold the curse of Ham is justified. For

the record, Noah cursed Canaan, not Ham. The LORD blessed all three brothers, therefore, either Shem, Ham, or Japheth could be cursed. So, why do people say Ham was cursed? The logical conclusion to justify misusing darker-skinned people.

That aside, we all must realize scriptural interpretation is an evolving cognitive movement from a single topic to the general and from a border subject to a single issue. Many scriptural revelations come at different stages of history once all the necessary predecessors have been placed conceptually.

The story about Ham/Canaan/Noah is an allegory about what happened in the Garden of Eden. In the Garden, Adam and Eve lacked clothing and sexual desires. When the Serpent approached Eve, he logically argued why she should take the fruit and eat, as she would become intellectual and know about the many subjects only known to Elohim.

Judging from the LORD's instruction not to take the fruit from the tree and eat, it is reasonable to assume the two strands of DNA molecules would unlock, allowing the Serpent to insert his genes into humanity. Remember, Adam and Eve were created without biological reproduction.

Eve went to Adam and said I reached out, took the forbidden fruit, and ate part of it. Now, you should eat part of it.

Now, let's consider the technicality of the exchanges. Adam never had a thought about reaching out and taking the forbidden fruit. The LORD gave the instructions to Adam before Eve's creation. Knowing this fact, the Serpent caught Eve at the right time when she stood before the tree and spoke to her about the excellent enlightenment that awaited her if she ate the fruit. Eve was not spiritually developed, as she was engrossed by the Serpent's disputation against Elohim's death warning by eating the fruit.

Look. Eve was willing to take the risk of physical death for mental enlightenment. After eating the fruit, two different pathways emerged as they continually exist. Regardless of gender, the path of human logic over and against a divine decree has the destination of spiritual deprivation. Two. The pathway of obedience to sacred orders in which one's spiritual needs are not in want.

Regardless of the reason, Adam listened to Eve. The New Testament establishes the criterion, for when in doubt, test the Spirit.

Criterion: what to do when in Spiritual Doubt

Beloved, believe not every spirit, but prove the spirits, whether they are of God: because many false prophets are gone out into the world. 1 John 4:1

Adam explained to the LORD why he took the fruit in an affirmative defense. In a word, Adam would never have touched the fruit had it not been for Eve. Though Adam ate the fruit, his gene was not corrupted because he had no desire to override Elohim's decree, unlike Eve.

Still, they saw each other nakedness. Innocent as babies, they were created non-sexually and could see contrasting differences between the spiritual and earthly realms.

Lessons from the pre-flood.

Noah was in his tent unclothed after a hard-working day. His grapes, full of spiritual joy, overpowered him into a blissful state. For the record, no one gave an account of Noah committing a sinful act publicly. There is no account of Noah disrespecting his sons or wife. What is the problem?

Precisely, the problem is within those who have invented associated problems of Noah sleeping unclothed. Truly, the issue of perception is internal to the genes. Indeed, the implied perception is part of one's world outlook, constantly sexualizing everything, as seen in movies and all forms of marketing products and services.

The Narrative

Like Adam, being in the divine spirit, Noah did not need clothing because he had no sin to confess.

Hence, holy nakedness is the essence of the allegory. The wine spirit created a heavenly bliss, allowing Noah to return to the Garden of Eden. When Noah awoke, he saw the clothing that Elohim made for him around his body, the implication of a Spiritual SIN.

In Genesis 9:22, Ham entered his father's tent and came outside to inform his brothers. Nothing in the text says Ham went out and made fun of his father. Ham went out to alert his brothers not to come into the tent out of respect.

When Noah awoke, he saw what Canaan did to him. Remember, Noah, like Adam, was in the divine spirit, whether natural or induced by the wine spirit; the garment made by Elohim symbolizes a spiritual sin that had been committed. Through Eve, the gene mixing opened the door to evil, leading to the flood.

The Bible gives us a twist to the story. It is unknown when Canaan entered the tent, if he was around in the area, or at what age. Still, with a little **common sense**, if a sexual act had been committed, Noah would have known at the first contact gesture. Thus, there is no logic to such an idea of physical contact. Hence, an allegory.

Remember, the flood directly resulted from Eve being spiritually defrauded, resulting in evil 24/7. In the post-flood world, Canaan is the archetype of unrestrained sexual sin due to the Serpent injecting Eve with his genes. The Serpent's gene is programmed logic to bring about spiritual degradation, opening the doors to all imagination of non-stop wickedness.

Moses understood the LORD's Order for all the Canaanites to be killed upon entering the land of Canaan. Having failed the Order, the Israelites were expelled from the land of milk and honey—a repeat of the Garden of Eden on account of the Serpent's seed.

The IDEAL Canaan, The Serpent of Eugenics.

- f. In the post-flood world, Noah exposes the Serpent's character traits, always hiding in the shallows to take advantage of innocence regardless of gender. In spiritual warfare, always be aware of sexual perverts and those promoting the Serpent's gene. (Concealed cameras in bathrooms. Many concealed cameras in women's private spaces have been discovered and reported. Even in toilets on airplanes.)
- g. Canaan appeared as the vehicle to bring spiritual degradation to the family of Shem. For this reason, Canaan's eugenics must always be oppressed (LGBTQ). Because no one stood to check Adam's seed mixing with the Serpent's descendants, the consequences led to the flood—perpetual acts of evil with the intent to re-arrange the original molecules in all biological entities.
- h. Canaan is assigned to function as an economic subcomponent to Shem rather than a personal maidservant.

We learn from Noah's condemnation of Canaan that the Serpent of Eugenics has an agenda to recreate the pre-flood era through temptation, using many clever, seductive forms. The annual multi-billion-dollar beauty industry appeals to sight sensations, not reasonings and spiritual precepts.

Consider Noah reaffirmed the Edenic Judicial Decree in the post-flood age assigned for the Serpent's descendants to crawl on their bellies for having spiritually defrauded Eve through charming. With no intentions of being cruel, the Serpent's descendants are prescribed to the highest control of ACCOUNTABILITY in their endeavors to slow down another global catastrophe. Thus, Canaan operates as a servant of servants to Shem, which denotes an Inter-divisional relationship between the Israelites and Japhetites to manage the Canaanites effectively.

The Serpent's eugenics must always be contained to prevent another global catastrophe. Sadly, yet with purpose, western laws have removed the constraints on spiritual eugenics. Consider the movement of Pansexuality and the growing industry of trans-humanism. Based on trends, people would have come around psychologically within the next fifteen years to accept new forms of hybrids, trans-humanism, as in the days of Noah.

^{9:25} Then he said: “Cursed *be* Canaan; A servant of servants He shall be to his brethren.”

- ^{9:26} And he said, Blessed be the LORD, the God of Shem; And let Canaan be his servant.
- ^{9:27} May God expand the territory of Japheth; May his descendants live with the people of Shem! Canaan will be the slave of Japheth."

Ham Sons

And the sons of Ham; Cush, and Mizraim, and Phut, and Canaan. Genesis 10:6

Some of Canaan’s family members lived in the eastern Mediterranean. When the global famine hit, Canaan’s family groups came into the deeded Land given to Abraham’s descendants during Israel’s stay in Egypt four hundred and thirty years.

- ^{10:15} And Canaan begat Zidon his firstborn, and Heth; and the Jebusite, and the Amorite, and the Gergashite; and the Hivite, and the Arkite, and the Sinite; the Arvadite, the Zemarite, and the Hamathite; and afterward the families of the Canaanite were spread abroad. And the border of the Canaanites was from Sidon as you go toward Gerar, as far as Gaza; then as you go toward Sodom, Gomorrah, Admah, and Zeboim, as far as Lasha.

The family of Canaan lived in different locations. For example, during Joshua’s conquest of Canaan, 95% of the Canaanites migrated in different directions. For example, some migrated across North Africa, some went to the Eastern side of the Mediterranean, some stayed on the Western coast of the Mediterranean, and others went to the East. In short, the LORD scattered Canaanite families in different parts of the world.

The Israelites did not harmonize their actions with the LORD’s Command.

The LORD commanded Moses to remove all inhabitants from the Land of Canaan. The LORD did not say to allow a small percentage to stay, and women & children. The LORD gave no exceptions.

Deception is the cause of Joshua setting the precedent of compromising the conquest that resulted in some of the Canaanites staying in the Land.

The Failed Consequences: the Israelites could not manage the Canaanites and their gods.

The race of Shem is large and includes Jacob and the Israelites. Noah gave a qualifier to the God of Shem, his righteous bloodline to exclusion of other family groups. Likewise, Japheth’s righteous bloodline to the exclusion of the unrighteous groups of his family.

Elohim's Decree given to Moses and Joshua to remove all inhabitants from the land of Canaan did not stipulate exceptional clauses. The LORD warns, if not done, he would remove the Israelites from the Land. Truly, the Israelites were removed from their homeland because the Land became spiritually contaminated. The lifestyles of evil and ungodly behavior took root.

Noah's Mandate

A long, topsy-turvy relationship between the Israelites and the Canaanites, even today.

- a. Outside the territorial lands of the Israelites, the Canaanites' assigned servitude was performed at arm's length, that is, divisional administration between two governmental agencies.
- b. Under the mandate, the Israelites established a historical tradition of co-ruling national governments with the Japhetites and other Shemites without any tribal ties to the Children of Israel.
- c. Within their national sovereignties, the Canaanites, regardless of their cultural identity or original region, had to follow the laws of the federate governments co-ruled by the Israelites.
- d. Under sovereign citizenship, they had to support the laws of federal governments and, in turn, the policy interests of Israel and Judah.
- e. Often overlooked, the Canaanites and other Hamitic families were pushed out of the Near Eastern Lands and went elsewhere. Over thousands of years, they adopted different cultural identities yet, maintain disdain for the Israelites today because of their dynamic, futuristic history.

The Hamites' Religion Roots

And the sons of Ham; Cush, and Mizraim, and Phut, and Canaan. Genesis 10:6

- And the sons of **Cush**: Seba, and Havilah, and Sabtah, and **Raamah**, and Sabtecha. The sons of **Raamah**; Sheba, and Dedan. Genesis 10:7
Cush had a son named Nimrod, who became the world's first great conqueror.
Genesis 10:8

The Cush Empire

The Cush Empire covered **Arabia** and southern **Iraq**. So much for the static view of Hamites confined to Africa. Over time Cush's son Nimrod expanded his father's kingdom.

- *And the beginning of his kingdom was Babel, and Erech, and Accad, and Calneh, in the land of Shinar.*

Biblically, Nimrod established his kingdom in Mesopotamia, where ancient Babylon, the Chaldees, and ancient Assyria arose. Nimrod built the city of Babel and later the Tower of Babel in defiance of Elohim's order for the people to spread out to cover the earth. No need to fight over land.

Nimrod's city Babel was constructed with the intent to escape for safety in case of another flood. Nimrod hunted here and there for pre-flood knowledge about the deities of Sumer to incorporate into his empire.

Another misconception:

Mesopotamia and Egypt shared many social and religious belief systems.

To dispel another misconception, cross-pollination of religious beliefs from Egypt to Mesopotamia was common. The Babylonians and the Assyrians were known for their knowledge of astrology and astronomy.

Enoch's prophetic book of human history, its origin and end, was well known and read pre- and post-flood. With knowledge of another end-time catastrophe followed by the coming Righteous One to rule, Nimrod grew angrier and bitter knowing what the LORD did and planning to do.

Such an attitude expresses the wicked spirit of the Serpent to further man's intellectual quest to rearrange circumstances for answers to Elohim's Spiritual Orders.

As the mighty hunter before the LORD, Nimrod saw one universal language change into many diverse languages within seconds while constructing his Tower of Babel, bringing it to a halt. Timely, ensuring everyone was on the same historical page, the Holy Spirit changed the human language from one speech to many languages in a second to demonstrate to Nimrod and the people how delusional they were in their quest. Eventually, the wind blew the Tower down.

Noach's Mandate
Israel & Japheth's Co-regency Accreditation

The Canaanites were assigned to operate continuously at the lowest levels of social authority, being "a servant of servants." Such is Israel's Sanctioned Template accredited to Shem and Japheth to remove any questions about privileged management.

Joseph used **Israel's Sanctioned Template** when he became Co-regent over the Egyptian Empire; Daniel used **Israel's Sanctioned Template** when he became one of the three kings to rule the Babylonian Empire. Again, Daniel used **Israel's Sanctioned Template** as the Co-regent over the Medes/Persian Empire. Queen Esther and Mordecai, Benjamites, used **Israel's Sanctioned Template** in their Co-regency over the Persian Empire; Eusebius, from the tribe of Asher, used **Israel's Sanctioned Template** in his co-regency with Emperor Constantine.

King James (Asherite) VI of Scotland used **Israel's Sanctioned Template** in Co-regency with King James (Asherite) I of Britain.

The American Empire

Constitutionally, Judah's 3/5 legislative instrument was the surety given to Judah to guide legislative policies in the federal assembly (he built the Capital City and the Federal Capitol building), not as the co-monarch as in the past.

The evolved Judahtocracy will end the Canaanites' social eugenics. The Executive Body of Israel in Exile will time-phase the Canaanites out of existence, both black and white, thus marking the end of Israel's Sanctioned Template to manage Canaan's descendants.

Ezekiel and Daniel, the light for Israel and Judah in their era of historical darkness.

At a time of mental darkness when Israel and Judah were exiled, Daniel gives a distilled review of Israel and Judah's wickedness in his chapter 9 prayer—still, the LORD promised their return home.

Daniel gives us a futuristic view of Judah's historical stages of maturity in correlation with the Amorites' last-phased degree to their iniquity's expiration date. Daniel and his Associates gave a financial ratio of 2:20 to the Gentiles for operational growth during their fourth and last social system on the earth. A barrier (2:20) that will never allow the Gentiles to surmount. The financial plan will disintegrate upon reaching non-functionality in repeated attempts to restore economic balance.

At hand, the only way to override 2:20, foretold by John, is by rolling out the electronic mark of the Beast to control and manage people's finances. As John indicated, rich and poor people will receive or deny purchase approval from the pre-programmed electronic system, Revelation 13:17.

Three Executive Managers, Shadrach, Meshach, and Abed-nego, of the Babylonian Empire and Daniel certified the 2:20 ratio for the Gentiles' operational financial expansion with nothing beyond 2:20.

The interplay of prophecy. Shadrach, Meshach, Abed-nego, and Daniel received Nebuchadnezzar's reconstructed dream and its interpretation simultaneously. As a team, they established the foundation upon which the LORD's plan would initiate the countdown sequence for the Stone Kingdom.

Due to Daniel's interpretation of the King's dream, the King elevated Daniel in his court by placing him above all classes of national-state astrologists, fortunetellers, Chaldeans, and prognosticators **then and in the future.**

They did not like it and sought ways to break free from Daniel and his God of divine knowledge. In short, they want ways to distract and mislead for personal gain.

- *The king answered Daniel, and said, "Truly your God is the God of gods, the Lord of kings, and a revealer of secrets, since you could reveal this secret."*
- *Then the king promoted Daniel and gave him many great gifts; and he made him ruler over the whole province of Babylon, and **chief administrator over all the wise men of Babylon.** 2,48*
- *Also, Daniel petitioned the king, and he set Shadrach, Meshach, and Abed-Nego over the affairs of the province of Babylon; but Daniel sat in the gate of the king. 2,49*

The three Executive Managers kept the law of Moses by refusing to fall down and worship the illustrative image depicting God's concept of the four Gentiles' social systems. The King called the three Executive Managers before him to explain their refusal to worship his statue. They said without hesitation in their voices that they could not worship an image of their creation, for they would be the instrument in creating the super-Babylonian state pre-determined by their God, Yahawah.

The Man Statue Allegory

Judah and the Ten Tribes will refuse any futile attempts to save their creation's disintegrated systems of capitalism and imperialism. The financial ratio, 2:20, is impossible to change. The global systems will crash and burn because Jacob's Tithing-blessing given to the Gentiles has expired. Judah is now refusing to accept from the Gentiles favorable financial terms and conditions designed to support the current systems, portraying bowing down and worshiping their contributory systems of economic exploitation.

Several Chaldeans were roasted while making the furnace seven times hotter to roast the three Executive Managers. Again, the Chaldeans will burn in the stove as before with fire seven times hotter, directly attributed to pushing 2:20 to its functional maturity.

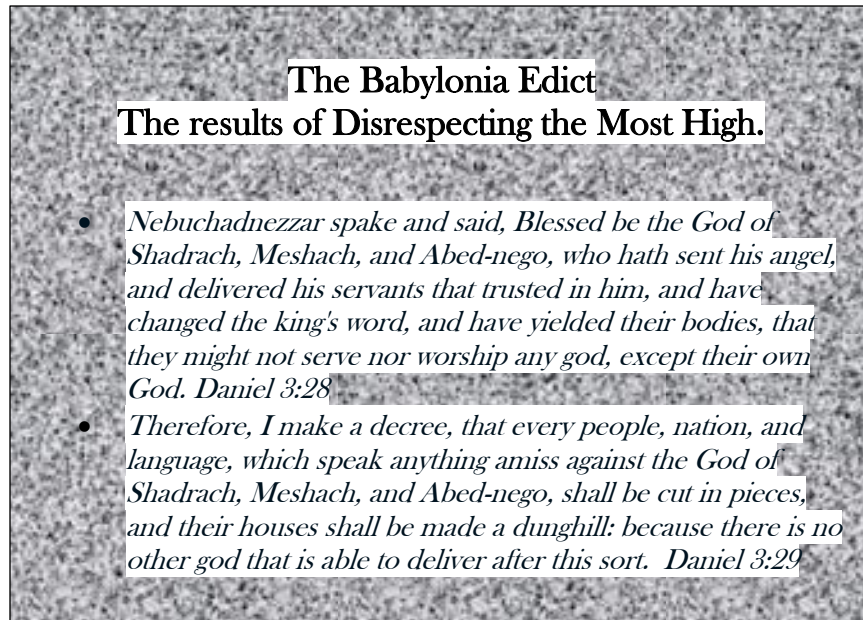


To realize Daniel's outline, King Nebuchadnezzar issued a global Edict in which he prescribed anyone, different languages and dialects, and nations disrespecting the **Judahites' God be cut into pieces, and their houses turned in dunghill (the preferred method)**.

In the modern world in which we live, say, 90% of people disregard the spiritual psychology of the Edict. The King saw with his eyes and felt the furnace heat when the three Executive Managers walked around within the furnace, singing and praying with another person. Compelled by the supernatural, the King's Edict covers Babylon's past and future.

Jeremiah tells what will happen in the land of the Chaldeans when Babylon falls. "Mystery Baylon," termed by John of Revelation, is the modern-day United Kingdom and America, functional entities like Babylon and the Chaldeans of old—one exists because of the other. The King of the Chaldeans committed a blasphemous act when drinking from the Jerusalem Temple's cups to his gods at the Chaldeans' global conference in Babylon.

Subsequently, the King of the Chaldeans was the first to experience the effects of the **Edict**:



When Daniel, the Magistrate, adjudicated the blasphemous act of the Chaldeans' King, he solidified the Edict's mechanism of litigation and execution. Such has been the model of King Darius of the Medes and Persians used to convict the Chaldean conspirators who had Daniel thrown into the lions' den. Queen Esther used the model on Haman, his sons, and a percentage of the Amalekites killed. The Judahite, an earthly Magistrate, uses the same statutory model combined with King Darius' Decree as the Judicious Closing: So, ORDERED.

Then king Darius wrote to all nations, tribes, and languages, who dwell in all the earth, saying, Peace be multiplied to you. This decree has been set forth by me in every dominion of my kingdom, that men tremble and fear before the God of Daniel: for he is the living and eternal God, and his kingdom shall not be destroyed, and his dominion is forever. He is the deliverer, and savior, doing signs and wonders in heaven, and in earth: who hath delivered Daniel out of the lions' den. (Daniel 6:25-27)

Three and Four have an eternal intrinsic value relationship.

Daniel became co-regent over the Babylon and Medes/ Persian Empires.

Sadly, mistaken to those of modern-day life, King Nebuchadnezzar's Edict is still operational. As an index to our times, the King said, we put three into the furnace with hands and feet tied, yet there is a fourth person. Many believe the fourth person was Yeshua. There are reasons to support the assertion. However, there is an embedded doctrine in the non-consuming fire. Indeed, the fourth person signals the fourth and final Gentiles' kingdom, a time when Israel and Judah will live under Yeshua's theocracy.

The LORD's Agents of Curse Caused the Cush Empire to Retrench.

"Sons of Raamah; Sheba, and Dedan." Genesis 10:7

Cush's Empire covered Arabia Peninsular and Southern Iraq during its expansion period. Due to the LORD's Curse Agents (see the box above), inhabitants of a region are forced to migrate in search of better surroundings.

The Arabian Peninsula is the historical homeland of Sheba, Dedan, the Ishmael family (Kedar), and the Midianites. As the Cushite Empire contracted, the Cushites' adopted the **name Ethiopia**, which became a name marker for the Cushite's capital region on the Western side of the Red Sea while retaining its Empire authority over Arabia.

The Cushites adopted the Israelite religion, as seen in the Ethiopian Bible. Ethiopia became the first Christian nation in Africa. In origin, Israel and Ethiopia's association goes back to when the Queen of Sheba came to King Solomon looking for answers and understanding on many complex questions. While in Jerusalem, the Holy Spirit arranged for the Queen to conceive a son with the King, who forever united the religious faith between the two nations.

A review: historical milestones that have influenced the Executive Body of Israel in Exile's Policy Guidelines.

Religion's impact on Africa.

Most of the Hamitic religions in Africa originated from the area of Mesopotamia.

The Cushite Empire was the first empire post-flood. Next came Nimrod's Empire. Remember, the Cushite Empire covered parts of East Africa, Arabia, and Southern Iraq. Historically, Arabia always had cultural and political ties with East Africa.

All major religions emerged from Mesopotamia. Abrahamic Faith, Pre-Islam, Judaism, and Catholicism. Apart from the Abrahamic religion, the rest have tenets rooted in the Sumerian Civilization. Nimrod, the mighty hunter before the LORD, sought to recreate the Sumerian religion.

Ham told his sons about the pre-flood history as the motivation for Nimrod to hunt for and collect a pantheon of deities to model the ancient Assyrian and Babylonia religious systems. Additionally, he took from the ancient Egyptians their religious systems.

Overall, Nimrod was inspired by the Sumerians to build the Tower of Babel to reach the heavens, and to go into space, for he wanted to follow the Sumerian gods who fell from the sky and space.

THE FALL OUT: the Tower of Babel's Sinister design separated the 3 Brothers and their Families.

- a.) The one world language existed long enough for all families of the Earth to know they are descendants of those who survived the flood and to teach future generations about the one supreme God through the writings of Enoch and those who survived the flood.
- b.) Once the history of the flood was submitted to the collective consciousness, the language changed per family group. Then, the LORD drove each group in different directions worldwide.
- c.) The Hebrew language galvanized the nation of Abraham and his descendants, who stayed in the Near East to cultivate their deeded Land.
- d.) Many families of Ham took to astro-religion.
- e.) Pre-Islam. Many descendants from the three brothers worshipped heavenly bodies.
- f.) Before Mt. Sinai, all religions varied from the Egyptian and Sumerian religious systems because they were most developed conceptually and coherent.
- g.) Joseph's Book of the Dead added to religious beliefs. The Book set rules to follow in a reward system: "do good and good would follow you."
- h.) Superseding the Book of the Dead, Moses received at Mt. Sania the Moral Code, the Ten Commandments for the nation of Israel to live by. The only people on the Earth that had an optimum System of Moral Codes that is valid transgenerationally.
- i.) The Israelites heard their God's voice reading to them the Ten Commandments. Not the voice of a man. The seventy-elders, plus Moses and Arron, had an inauguration meal in Second Heaven. The Children of Israel received their theological foundation, knowing who and what they believed in for blessings and salvation.

- j.) So many empty theories that sounded good but nothing of substance with sustainability to fashion a post-flood world. Hence, Solomon and the Queen. When she departed to return home, the Queen took doctrinal fulfillment of the LAW of Moses. Tribal groups were spiritually dry and wanted doctrine to guide their lives. They did not know what to look for but recognized spiritual meaning once they encountered it.
- k.) For the most part, a percentage of the Israelites remained hardcore through the ups and downs, and they stood as a moral light to the Gentiles.
- l.) Daniel appeared on the stage of world history when the Congregation of Israel had rejected their religion by chasing after deities that belonged to their surrounding neighbors. They imitated the heathens and could not distinguish between spiritually bankrupt practices and high-level civilized behavior befitting their **God of Greatness**. Hitting rock bottom, being expelled from their Land, and psychologically devastated, the Israelites needed time to examine what led them to disrespect their God.
- m.) Daniel and his three Executive Managers became God's servants. Before kings and the world, they validated God's power and authority over man and his governmental systems. The LORD established the Magistrate Court on the earth with the focus:
- 1) Litigate per the King's Edic and execute statutorily.
 - 2) Toward the end of each Four Gentiles' Kingdoms, validate the conspiratorial superstructure of the Chaldeans judicially. State the beginning stages of each Kingdom and condemn each conspirator and their institutionalized families. Next, by statutes, liquidate all conspirators.
 - 3) Adjudicate the Amorites at the end of their matured iniquity.
- For Judah, the LORD gave an outlined history of the Gentiles' kingdoms and the time when Israel would be restored per Jeremiah's Seventy Years prophecy.
- n.) Ezekiel came with a ministry allowing the exiles to see their future in which Yeshua would redeem them and return home from exile.
- o.) Judaism. Babylonian Talmud emerged during the Babylonia exile as commentary guidance that reflected a personalized interpretation of the Torah. Judaism is for the Gentile tribal Dan and a percentage of the Idumean. Judaism doesn't embrace Yeshua as the Son of God.
- p.) The essential Daniel and his three Executive Managers proved Judah is the substance of planetary social science. The Edict affirms the scientific fact.
- q.) Daniel gives the timeline for when the last Gentile Social System will fall and the rise of the Stone Social System that will have no end.
- r.) The Maccabees demonstrated their faith in God by not giving in to Hellenism under any condition, as the Second Heaven Magistrate told Elijah. Hellenism is a Canaanite's eugenics instrument, leading to self-destruction while having fun.
- s.) Yeshua arrives as the redeemer and gives us his New Testament.

Muhammadanism stands in contempt to Christianity

Islam, Judaism, and Catholicism use the Israelites' Holy Bible as their theoretical theology for fashioning their religious belief systems.

Comparatively, it took fourteen hundred years to write the Israelites' Holy Bible and twenty-three years to write the Quran. At the age of forty, Muhammad started writing the Quran given in dictation from Angel Gabriel and concluded in A.D. 632. He died at the age 61.

Did Gabriel dictate the Quran to Muhammad? Yet again consider that it took the Babylonian Talmud hundreds of years to write commentary through practical experience to conclude its cord theological presentation.

However, what can be said about Muhammad is that he took his wife's advice and went to Ethiopia to study doctrinal theology under the Kushites.

There is intellectual integrity to assert Muhammad embraced the Israelites' biblical doctrine. Yet, at a particular stage, Muhammad separated and grew into the precepts of Islam that are more befitting his personalized world outlook. Muhammad sought to combine Christianity with Islam, wherein Islam occupies the dominant position. For example, Muslims believe Muhammad ascended to heaven from the Dome of the Rock. If so, where did he go?

In contrast, Yeshua returned to his FATHER and now sits at his right hand. Muslims don't believe Yeshua is the Son of God. Thus, it is not known where he went to. Since God had only one Son, can it be said Muhammad went to the FATHER to assert Sonship? The Mountain of Transfiguration contradicts Muhammad. The Heavenly Father validated his Son; therefore, Muhammad is a False Prophet.

Who wrote the Quran?

The Catholic Church or the Church of Rome contributed to Reforming Islam. The Church of Rome secretly wrote the Quran as the doctrinal foundation for Arabs to personalize their religion by following the Quran's precepts. As noted, pre-Islam appeared during the ancient Assvrian Kingdom; thus, Muhammad is not the origin of Islam. However, he is associated with Reformed Islam as known today.

The Idumeans of Rome worked behind the scenes with the Arabs to bring down Constantinople, a Christian Kingdom. Having a great victory, the Muslims went on to conquer Europe.

Ethiopian Bible

The Cushite's canonized Bible includes all the Books in the Israelite's Holy Bible, the Apocrypha, and additional unknown books that compose the Ethiopian Bible.

Ethiopia serves as the scriptural repository for the Congregation of Israel.

- *But an angel of the Lord spake unto Philip, saying, Arise, and go toward the south unto the way that goeth down from Jerusalem unto Gaza: the same is desert. Acts 8:26*

The LORD instructed Apostle Philip where to meet the Ethiopian Eunuch to explain the book of Isaiah. As a procedural step, a person must first renounce their sins and then receive Holy Baptism. The Eunuch did so, another validation for people to seek spiritual salvation as instituted by John the Baptist. The Muslims' conquering sword can never be compared to Yeshua's Fire of Baptism.

As can be seen, it takes hundreds of years to construct a religious doctrinal system. People must grow into a system to claim it to embody doctrinal precepts. Regarding Mt. Sania, the LORD gave the constitutional parameters in the appointed Feast Days, but it took hundreds of years for the Israelites to evolve validated usefulness through precepts. A case in point, the Congregation's expulsion from their Land is a **precept validation**, for evil cannot stand in the presence of the LORD in association with the Covenant.

African-Judah attests to Yeshua's New Testament.

"...go toward the south unto the way that goeth down
from Jerusalem unto Gaza," the lonely road into the desert."

Philip's appointed location indicated the actual road marker escaping Judah would travel in AD 68-70 from Jerusalem to the wilderness for a thousand years. In parallel, Philip meets the Ethiopia Eunuch on the edge of the desert. He was reading from Isaiah. "*The place in the Scripture which he read was this: 'He was led as a sheep to the slaughter; And as a lamb before its shearer is silent, So He opened not His mouth.'*"

From Acts 8:26-40, The Judahite extrapolates the Eunuch from the tribe of Reuben reading Hebrew. Just like Simon of Cyrene, a Benjamite, traveled to Jerusalem as required by law for all Israelites to travel to Jerusalem during appointed days. Simon was there during Jesus' crucifixion.

In parallel, Daniel and his three Executive Managers were Eunuchs, a spiritual act to protect their bloodline. They, too, were over the state treasury to accumulate money to rebuild the Temple.

Moreover, the Israelites carved out their role in national government as the administrator of national treasuries under all central Gentiles' governments, considered Joseph of Egypt. In modern times, the Gentile Danites preserved the tradition, as in the Near East, Europe, America's IRS, and the Central Banking system.

Everything surrounding Jesus' mission on earth was strategic. No less, the Roman Soldier ordered Simon of Cyrene, Libya, to carry Jeshua's cross, a futuristic illustration of tribal Judah enslavement after A.D. 70. The Arab Slave Trade, over fourteen hundred years, Islamic caliphates claimed forty million tribal Judah's lives. Next, the Trans-Atlantic slave trade took ninety million.

These are estimates. There are methodologies for arriving at the Arab Islamic estimate. The estimate might be higher, but still, The Judahite supports the methodology. On the other hand, a different methodology applies to reach 90 million. The methodology has some biblical support when viewed in three parts. **A.** the capture stage; **B.** in transit deaths; **C.** labor death.

From The Judahite's perspective, the numbers are staggering. Even if the total comes to 200 million, the number doesn't carry much weight because over thirty million deaths are the threshold of moral consciousness. So, if there is any value in the estimates, they have prophetic significance. The point: what is the use of arguing beyond the Mosaic threshold of thirty million?

The practice of slavery before the Arabs and Europeans.

Long before the Arab and European slave traders, there were Slave Kingdoms that had an investment to preserve their culture. Slavery is part of African culture; however, when the

Arabs and Europeans came, the Slave Kingdom easily filled the supply pipeline to the Arabs and Europeans.

Terms Usage.

- ✓ **Africa.** Some consider Africa to mean the land of Ethiopia or the land of Cush. Still by others, the land of Ham. There is little value in discussing the name of the African continent. Real practical value, on the other hand, is in knowing and identifying tribal groups. For example, follow Ham's genealogy: "And the sons of Ham; Cush, and Mizraim, and Phut, and Canaan." Gen 10:6. Granted, one will find other tribal groups in addition to Ham's family and descendants.
- ✓ Biblical **Egypt**, in the spiritual context, means wilderness and bondage, based on astrology.
- ✓ Biblical **Ethiopia** means to seek grace and salvation from the God of Israel.
- ✓ **Egypt** is a model of duality that incorporates the astro-theological doctrine of SHEEP (Israel) and the personalization of God: "I Am." The dependency relationship between earthly and heavenly kingdoms.

Moses and Arron stood before the Pharaoh as Astro-theologians to impose heavenly imprinted authority over earthly governments seeking to perpetuate endless slavery over the SHEEP people or the children of Israel.

Moses and Arron's Model represents the TRUE GOD of Israel, moving and arranging the physics of Time and Space. A God that will always consume theoretical pretenders and an unsound understanding of the celestial mechanics of the universe.

Africa, and the Waves of Conquers.

The Muslims came as the first massive wave to spread Islam by converting cities, towns, and countries to Islam. The long-lasting effects and consequences after removing tribal Judah from Africa.

Africa has hosted pockets of tribal Judah (Levites, Benjamin, and Judah) since the Grecian era and the Roman Empire. Those Israelites in the wilderness of Africa missed out on practicing the Apostle Age's traditions and the fellowship in the Holy Communion because tribal Judah faced one calamity after another, constantly on the move—going deeper into the interior of Africa in the directions of South and West.

The Berlin Treaty Conference of 1884 through 1885

The Berlin Conference sealed the mental darkness of the continent. From 15 November 1884 through 26 February 1885, the European powers carved up Africa with assigned boundaries of national jurisdiction. Today, the boundaries have remained intact since the day of differentiation.

WWII devastated European economies and impacted all European colonies. If any of the colonies had plans to throw out the Europeans, WWII was the optimum time because they were all weak and had no money to rebuild their national economies. Out of mutual dependency, the countries had nowhere to go. On balance, only one country obtained a futuristic vision from the aspirations of Juddah-America, Ghana.

**Currently, African Countries are looking to China as an
Escape route from the Western's financial web only to be TRAP.**

Is Africa the land of the Canaanites? By looking at historical evidence, the answer, in part, is yes. Equally valid, different parts of the world are home to the Canaanites.

On the one hand, there is genuine support for Africa to progress. Americans have contributed lots of resources to assist Africa. On the other hand, the spiritual curse on Africa will not allow a quantum leap in societal development; to think and act so is delusional. The empirical evidence is solid as it pertains to the spiritual curse. There are endless initiatives and plans to upgrade Africa. Many grandiose plans have been disclosed, yet inspirational, but they are predestined to fall apart.

China is the promotor of such grandiose plans. Biblically, China is on even more unsolid ground of a secured future than the Africans. Look: the spiritually blind helping the spiritually blind without a walking stick away from the Commonwealth of Israel in Exile.

Considering the background, the evilness done in Africa is too great for countries of the North to implement their well-developed plans for a promising future without the biblical prescription that includes Judah-America as the answer to sustainable growth and a bright future.

Africa's Future cannot be discussed coherently without truly understanding The Principality over Africa.

Joseph, Moses, Arron, and Yeshua have given us the archetype for dealing with the office On Demand Antithetical Principality functioning relational to Israel's spiritual knowledge of Astro-Theology.

**Codes to assist in guiding Judah and the

- 1) The first rule for understanding Hamitic Africa is the Principality, whose function is to oppose to the Commonwealth of Israel whose Messianic people will govern the Stone Kingdom.
- 2) Secondly, the Berlin Conference Treaty of 1885 is still in force, affording Europeans jurisdictional authority to protect their financial and economic interests. Next, they relied on the banking sector of **tribal Dan, the Gentile**, to bankroll capital investment in all commercial Trans-Atlantic industries that resulted in the accumulation of capital as the foundation of capitalism—the fourth and final Gentiles' social system.
- 6) Again, unlike traditional patterns, the Arabs with massive armies came into Africa and

forced religious conversion either killed many people of Judah who did not submit with the option of enslavement on location or transported them to the Middle East, Indian Ocean Islands, and the subcontinent of India. Even to the Americas! To be remembered, the Arabs still have an invested interest in Africa's human resources that might or might not be apparent.

- 7) Though not fully understood, neo-colonialist and imperialistic market forces are operational throughout Africa.
- 8) The European powers cleverly manipulated religion and encouraged many heathenistic practices as a form of religious entertainment.
- 9) Not just the Hamites, all, indeed all, who are grounded in financial and economic activities in Africa are subject to On Demand **Antithetical** Principality. The On Demand Principality operates in real-time against the practical aspects of Zion's efforts to upgrade the remnant of **Judah-Africa**, the ones who fled Jerusalem in AD 68-70.

Judah-America: Ghana a case study for guidance

America's business community doesn't have the same trade approach toward Africa compared to European countries for obvious reasons. The Europeans have the view of African ownership. From The Judahite's experience, it took many years to realize that doing business in Africa incorporates the Europeans' authority per the Berlin Treaty of 1885.

Thanks to W.E. Du Bois, Kaiser Aluminum adjusted his investment plan to build the first heavy industrial plant in Africa, the 128-million smelter plant in Tema, Ghana.

Conflicting views caused the investment delay.

One view is guided by experience, and the other position asserts overly optimistic valuation of natural resources.

Kwame Nkrumah received lots of data in pre-proposal from England with government support for constructing the plant. On the other hand, Kaiser Aluminum saw problems within the British proposed plans. Nkrumah, a great Pan-African visionary, fell into the trap of overestimating the value of Ghana's natural resources, particularly bauxite.

While it is true that Africa has many natural resources, the same natural resources are found in different parts of the world with fewer or more deposits.

Kaiser Aluminum came with his research team and determined the bauxite deposits were not of a higher grade than believed. The discussions between Kaiser Aluminum and Nkrumah went on for years—off and on, never making any progress. Nkrumah was of the economic mindset given to him by the British. Kaiser Aluminum knew an entire infrastructure had to be created to accommodate Nkrumah’s envisioned plans. In short, it would take hundreds of millions of dollars to build his version of an industrialized base, starting at a primitive level of commerce, plus it would take decades to complete. **Where will the money come from?**

Putting each infrastructure component in place, the Volta Dam had to be constructed to make the Kaiser Aluminum investment possible. The Volta Dam was built between 1961 and 1965 with contributing funding from the United States, the United Kingdom/Britain, the International Bank for Reconstruction and Development of the World Bank, and the Ghanaian government.

As a summary point, the American business mindset prevailed as the approach to slow and steady economic growth, giving time for anticipated return on investment to accumulate for funding growth and development. There is no magic money tree.

The Judahite had the privilege of talking with the family that owns one of the ten top companies in America regarding Africa. His plans for creating an advanced mechanized farm industry was to manualize labor as much as possible to ensure employment for as many people as possible, an evolving approach. Like Kaiser Aluminum, **don’t try to go nine yards at once.**

Moreover, another example of the American mindset is that The Judahite submitted a proposal to develop Ghana’s salt industry. The Judahite went to Ghana with a leading expert in the salt industry. The Judahite could not believe what he suggested after touring the salt regions. “Import salt from South America to Ghana for processing and packaging, next sell, the salt to the oil industry.” It would be much cheaper. It did not make any sense. Yet, another indication of the American mindset to evolve. Over time, The Judahite saw value in the suggestion.

The American business class is not in the business to nursemaid Africa’s social problems. Frequently, African leaders minimize the requirements of investment capital. Yes, investment capital requires expansion and growth to achieve critical mass. For example, most foreign aid related to the host’s construction projects is performed by donor countries’ companies. After approving investment capital commitment, an investment schedule must be followed for return on investment. There is no time to mess around once into resource allocation, trying to redefine investment capital’s mission by introducing distracting ideas.

The American Mindset Regarding Africa

- ❖ The American business community separates itself from idealistic thinking to create economic engines (industries) to drive underdeveloped countries.
- ❖ The American mindset is taking the long route, knowing the objective will be reached, as all involved would enjoy increased prosperity for themselves and the population.

Nkrumah's Imperialistic Model

- ❖ Kwame Nkrumah did not see the plant's operations in producing aluminum because forces of imperialism overthrew him.
- ❖ Nkrumah became the model for African leaders, knowing they would be toppled and fade away if they transgressed Europe's financial policies.
- ❖ Nkrumah's enduring legacy is his shared worldview with Judah-America to enable the aluminum plant.

Closing remarks on the aluminum plant

The Judahite visited the smelting plant in Tema to offer value-added assets to the plant for an integrated value-added system. Being in a few commercial business associations in the U.S.A., The Judahite could marshal the necessary high-level technical resources for a practical futuristic business plan. As an enduring pattern, the On Demand Antithetical Principality came into play, and nothing became of the initiative, a graveyard of aspirations.

The Judahite learned years ago that favorable historical conditions must be present at the appointed times to transition relatively easily with all necessary resources to advance to the componentized revolutionary division in the social order of society.

Knowing the timing for transitional opening allows substantial societal resources to be transported with ease; otherwise, it would be next to impossible to galvanize and haul the necessary resources at low cost, regardless of pleas and urgent demands. When required historical conditions are absent, all immediate expectations must be placed on a shelf until the next opening.

The 1990s decade contributed to the formulation of Judah's business model for Africa as Judah America searched for ways to stabilize his economic holdings in the United States of America.

As always has been the case, Judah has been proactive, looking for ways to capture a relatively stable revenue income through self-initiatives. The economic tenet of America is rough individualism, self-assertiveness, and less reliance on government.

Hurricane Katrina was a wake-up call for all Americans to make primary plans for survival and have government aid as a secondary plan if it arrives. Many people understood the lesson and acted but still needed more resources to prepare better. Still, collectivism represents organizing strength. If you cannot do it alone, join others like-minded in a collective effort to survive.

The 1963 March on Washington came as a defining moment in America's history. Following the 1963 March, Judah and the Ten Tribes of Israel defined America through the passage of the Civil and Voter Rights Acts. Yet, the Mosaic Curses persisted but were legislatively manageable to hold evil foes in check.

There is no question that legislative laws enabled improvements in Judah and Israel, but they still fell short of full-time employment for several reasons. Manufacturing jobs continued shifting to China and other overseas manufacturing destinations; the immigration movement continued to absorb jobs on all levels; online purchasing continued to increase (less need for storefronts); non-stop expansion of warehousing and increased automation; the cost of living continued to rise; the government continued to run deficits.

As a known law of capitalism, there will never be 100% employment, and those working must work pro-long hours.

Professionals and non-professionals who know about international currencies and the purchasing power of the U.S. dollar obtained readings about what could happen to the US economy.

COVID-19 came as a reset button, forcing people to think about their lives, their future, and the pending collapse of the global economy, a global lockdown.

For those who have discernment know that we live in prophetic end-times.

Dr. Leon Sullivan became the man of the hour.

Dr. Sullivan and his organization, Opportunities Industrialization Center (OIC), was formed in 1964 to train and prepare African Americans for jobs. High unemployment has continued to run unchecked since the end of the Black Reconstruction Era.

In the decade of 1990s, Dr. Sullivan took thousands of black professionals in all disciplines to different African states to engage and to investigate opportunities. His movement was called the African-African-American Summit.

Out of his conferences arose a national and global debate on Africa. The organizers of the national debate knew the historical importance of it; therefore, the debates included all in the diaspora and on the continent. Millions of dollars went into organizing the multi-year discussions.

The discussions were open, with no agenda, until a consensus was reached on matters of importance. Then, the national committee distilled the data into an outline for structured input and adoption at the National Summit in February 2000 in Washington, D.C. .

What went wrong?

Policy Plan of Action for U.S.-Africa Relations in the 21st Century was a monumental milestone. Yet, the Africans on the continent treated the event like other events and forgot about it. To them, the Summit was just another conference to hear hopeful things, assuming someone or a U.S. Agency would take them by the hands, put money into their hands, and pushing them into action. Acting from decades' experience, not to be done! Not giving large sums of grant money, the Africans were not motivated to work out of self-interest.

Still, African states could have sent a delegation to each American state legislative body and lobbied for favorable policy, or they could have hired participants involved in organizing the Summit under contracts to lobby for them.

One step forward and three steps backward.

The Judahite has consistently observed from far and near that whenever there appears to be *positive traction involving African Americans inroads into the African markets*, setbacks occur in one form or another. Observing the pattern emerges, an invisible hand is orchestrating campaigns to discourage businesspeople from venturing into Africa. After a while, one gives up due to the many challenges and depleted resources.

For the record, there are a few stories of black Americans having achieved success, good! Don't become confused. Their success comes as they work brighter as if in America. But compared with China, Japan, American Multinational corporations, Canada, Italians, and many others, the black Americans' business model is insignificant. They do business around the world in business colonies, never alone. They can better ride out the ups and downs of international commerce. Thus, operating a localized business, regardless of global, is under a different set of codes than large- scale operations with applied tax codes.

After dealing with Africa, The Judite joined with others to work under the North American Free Trade Agreement (NAFTA). Time is money. Businesspeople don't throw away assets foolishly.

Dr. Sullivan's Contribution.
