A Milestone Date, January 19, 2023 The Cup of Wrath

The Magistrate of Heaven Passed down a Ruling upholding Jeremiah chapter 25 on January 19. The Ruling affirms the LORD's Declaration given to Jeremiah.

As a student of the Bible, like all students—even Daniel, The Judahite had to go back and read the Scriptures to examine what might have been overlooked or misunderstood when the expected times did not yield anticipated results. The Judahite will give two examples. The first one:

• And he said unto Abram, know of a surety that thy seed shall be a stranger in a land that is not theirs, and shall serve them; and they shall afflict them four hundred years. and, that nation, whom they shall serve, will I judge and <u>afterward</u> shall they come out with great substance. Genesis 15:13

The prevailing interpretation is that immediately after four hundred years, the day after, the nation will be judged **not so**. North America, Britain, and other European countries will be punished, and departure will occur.

Unlike the exodus of Egypt, no state armies are expected to be around to engage the temptation to chase after the Israelites. Another example:

And it shall come to pass, when seventy years <u>are accomplished</u>, that I will punish the king of Babylon, and that nation, saith the LORD, for their iniquity, and the land of the Chaldeans; and I will make it desolate forever. Jeremiah 25:12

Many assumed within a few weeks, the nations would be punished. Not so.

Therefore, after seventy years, the Magistrate issued the affirmative ruling in the seventh year to start the punishment's implementation.

What follows is a critical perspective of the Ruling-19J23.

Joshua gave the theater where the final phase of the war would take place with the Amorites.

• Then spake Joshua to the LORD in the day when the LORD delivered up the Amorites before the children of Israel; and he said in the sight of Israel, Sun, stand thou still upon Gibeon; and thou, Moon, in the valley of Aijalon. Joshua 10:12

When The Judahite assumed commandership over the final phase of the war, the moon moved in the sky for five hours. It disappeared before The Judahite's eyes because five hours of moonlight remained when Joshua commanded the moon and sun to hold their positions.

The sun returned to its original position upon Hezekiah's request to Isaiah. The sundial turned back by ten degrees, thus giving Hezekiah ten years of life. Adding ten years to his five years, the King had fifteen years to live before his death.

Under Joshua's command directive, The Judahite had fifteen years to wage active warfare with the Amorites.

In the early days of warfare, The Judahite understood the war's character and nature. As the steps of war unfolded over fifteen years, The Judahite had to formulate a different tactical operation in the deep waters of the international banking and financial industry.

The Judahite had no one to turn to for inside intelligence. The people he knew in Washington, DC, would have shared information had they possessed it. It became clear to The Judahite that American professionals needed to be more knowledgeable regarding the underpinnings of the global financial and banking industry. Yes, they knew the general technical aspects of banking and financing, but they needed to be more knowledgeable regarding the international power center that establishes monetary policies. Unlike nations of the East, the USA is not an exporting country. The small business class is not on the trade radar of international competition in any country.

Thus, The Judahite base of operation became Africa and central Europe, where the meat and potatoes of knowledge reside; London serves as the hub of international banking.

The Judahite took out a million-dollar loan to prosecute the war. Given the primary focus was on Africa and central Europe, The Judahite spent his time doing research in financial libraries to gather intelligence for fighting effectively.

Segue into the reason driving Jeremiah 25:15

- For thus saith the LORD, the God of Israel, unto me: Take the cup of the wine of this fury at my hand, and cause all the nations, to whom I send thee, to drink it.
- 25:30 Therefore, prophesy thou against them all these words, and say unto them, The LORD shall roar from on high, and utter his voice from his holy habitation; he shall mightily roar against his fold; he shall give a shout, as they that tread the grapes, against all the inhabitants of the earth.
- 25:31 A noise shall come even to the end of the earth; for the LORD hath a controversy with the nations, he will plead with all flesh; as for the wicked, he will give them to the sword, saith the LORD.

Then again, I lifted up mine eyes, and saw, and behold, a flying roll.

And he said to me: What seest thou? And I said: I see a volume flying: the length thereof is twenty cubits, and the breadth thereof ten cubits.

And he said to me: This is the curse that goeth forth over the face of the earth: for every thief shall be judged as is there written: and everyone that sweareth in like manner shall be judged by it.

"I am bringing this about," declares the LORD of the Heavenly Armies. "The curse will enter the house of the thief and the house of the one who lies in my name. The curse will remain in his house until that house has been completely destroyed, right down to its timber and stones." Zachariah 5:1-4

Then there will be a fourth empire, as strong as iron. Just as all things are broken to pieces and shattered by iron, so it will shatter and crush all the earlier empires. [The Red Dragon of Imperialism]

Daniel and his three managerial executives Effectively maintained the 1:1 ratio

History records the Babylonian empire and the Babylonian Super-state under the managerial authority of Daniel and his three executives, the Judahites. In contrast, the Persian Empire grew in wealth ten times more than the Babylonian Super-state, yet Babylon remains the head of gold. No, it is not military power or the huge Persian economy much mightier than the Babylonians. The monetary ratio is the key.

From the Persians, tribal Manasseh became the repository of the fractional reserve banking system, the concept that would evolve capitalism through Karl Marx.

Once the world replaced the gold standard as a currency reserve, the Petrodollar became the global standard. The idea is to find and maintain a universal equivalent to benchmark labor value. Look. Everything in human society is the creation of labor. To expand economic prosperity, the production and distribution of goods and services must be affordable to everyone, with a surplus for exports.

As always, monetary policies should not create imbalances that lead to social unrest. Although unintended in most cases, economic policies lead to social instability due to people being unable to meet basic needs to sustain everyday living.

There are many economic models for the overall growth of the economy and industries. The models might look impressive on paper, but they don't work in the actual world. The problem: everyone at the same time on all levels of society is in conflict to balance their finances. According to Marx's economic theory on the Circulation of Capital, the breakdown occurs when the capital cycle is elongated for its conversion into liquid capital (cash). There are countless reasons for causing the conversion delay in the natural world and human society.

The Just-in-time method emerged, though a partial solution, to avoid being caught holding lots of inventory. When looking at the overall flow of goods and manufacturing of goods, the problem persists.

Consider a simplification for why the problem persists. People's appetite menu can vary weekly, monthly, tri-monthly or yearly. Generally, people are born, evolve to the peak of their life, and downsize. People move or relocate for many reasons. Innovations in production impact the prices of goods. Also, the availability of parts and raw materials. Now, when considering all the changes and movement of life, the production of goods and services is impacted. Yet, the production of goods must be paid. There is no such time as limitless open credit and non-scheduled loans.

The answers to the circulation of capital are the mixture of defaults, fraud, and defrauding. In addition to the problems in the circulation of capital is the tax system that frustrates economic production. As a rule, the tax systems do more harm than good. Countless good businesses have been forced out of business.

The tax system is a business in and of itself. It is a creation for collecting money for bankers who allocate funds to the ruling elite that stands above all national governments.

Hundreds of years ago, closed-group economists understood Max's theory of the Circulation of Capital and institutionalized financial crime to maintain the social system. Otherwise, the 2:20 would be beyond the hands to manipulate artificial equilibrium within the economy.

Money laundering

 "Money laundering is the process of making illegally-gained proceeds (i.e. "dirty money") appear legal (i.e. "clean"). Typically, it involves three steps: placement, layering and integration. First, the illegitimate funds are furtively introduced into the legitimate financial system." Money laundering is a political device used artificially to restore financial equilibrium. For example, there are countless organizational thieves in the world. When a crime is committed, the police track down those who physically took the goods. Such is considered good police work. There is another level to the crime of theft. Say, once the goods are taken, the goods can be delivered or sold to someone without any knowledge of the crime. On the other hand, the goods can be given or sold to a person who knows about the crime. Which person should be charged? The frontline thieves' statement serves as the basis for the criminal charge.

Of course, there is guilt by association. Still, concrete evidence is needed on the specific. Investigators usually look at bank accounts and determine a crime had been committed without anyone reporting a theft. Without any evidence, drug money is assumed as a catch-all bucket for unproven crimes.

For the record, there is a small comparison between street crime and white-collar crime. Now with the Internet, the online environment is a good place for all kinds of crimes. Many people who are wicked use the craft of deception to victimize people. As a rule, what companies do in their storefront operations, they do online. Fraud is fraud.

The point: regardless of technology, wickedness adopts the new means for greater influential deceptions.

In 2012, HSBC Bank agreed to pay the Department of Justice 1.256 billion in anti-money laundering for floating 881 million dollars into the USA from Mexico.

There is no such thing as a money tree. There are problems embedded in this situation. First, illegal drug users in South America and Mexico don't have that kind of money to make that volume of purchase year in and year out; therefore, the assertion must be rejected without second thoughts because most of the economies in the Western Hemisphere are on the verge of collapse.

Once rejected, the question remains where did the 881 million dollars come from? No speculation will be offered herein. However, attention is given to the derived benefit of running the money through HSBC Banks in the USA. Without question, HSBC Bank is in biblical prophecy. In comparison, global banking groups have an equal assets ranking as HSBC but without particularity.

HSBC Bank is a Hong Kong bank formed by Britain during the Opium War with a ninety-nine years expiration lease agreement with China. Now that the lease expired, HSBC Bank is integrated into China's financial system while still holding leverage over Britain because the HSBC regional office is headquartered in London.

"a great tempest shall be raised up from the uttermost parts of the earth." Jeremiah associates HSBC Bank with China as "in the uttermost parts of the earth." Moreover, the Seventy years prophecy is linked to the fall of Babylon. The giveaway for identification purposes is the tempest shall raise, the Red Dragon.

Overall, countries, not the banks, that are interconnected with the banking and financial industry might or might not have acted intentionally wicked in the interest of bank capital and will have to answer for their deeds, according to Jeremiah's Chapter 25.
