Ephesians 5:8-9 *"For once you were darkness, but now in the Lord vou are light. Live as children of light—⁹for the fruit of light is found in all that is good and right and true." should.

As we enter Advent, a time of preparation for the coming of lesus, both at his birth and his second coming, I think especially of Jesus as the light of the world.

Are their times when that reflection is barely visible? Certainly, many times our hurts, selfishness, and struggles seem to cloud over that light and we only shine dimly.

Our daily lives should reflect lesus' good-It made me think that ness and grace: righteousness, integrity, kindness, gentleness, truth, sincerity,

forgiveness, acceptance, and inclusion. Our Christian lives should reflect lesus' love, humility, and patient should blossom into godly fruitfulness, reflecting the love of God, in the face of Christ Jesus our Lord.

In our baptisms, our union with Christ has brought us into the light of his grace and truth, and the fruit of the Spirit should be manifest in all we say and do. Let us fully accept Christ's invitation to walk in the light as he is in the light so that the fruit of his love will be reflected in all we are, say, and do.

Let us live our lives as children of light so that the light of the glorious gospel of grace may become a witness to the world that we are children of God and partakers of God's divine nature. CHURCH COUNCIL HIGHLIGHTS NOVEMBER 17, 2021

Council Meeting Highlights 17 November 2021

Your Council met Wednesday, November 17, 2021. Highlights include:

Learning Committee: Swamp will be hosting a "Fall Blessing" today. They will do pumpkin decorating, pumpkin bowling, playing fall bingo and other fun games.

Service Committee: They will again be doing the reverse advent calendar. The food donated will be used in our food bank.

Helping Hands: Our food bank has provided food to 19 families in November.

Had the pig stomach dinner...sold out of filled stomachs.

Youth Ministry: Will be making a Thanksgiving meals for families this year.

Today will have the in person youth meeting

December 5th will be their Christmas party.

They will shift their focus to the middle school class because the attendance is low in the high school class.

Pastor Scott will be reaching out to local Lutheran pastors to arrange a quarterly meet-up to get everyone involved and together to do activities.

Property: The new hot water heater has been installed.

They are working on getting heat back to the Pastor and secretary's office.

Scouts: Scouting for food was yesterday and that food will be used in our food bank.

Pastor will be meeting with them today.

Worship: Christmas eve we will have 2 services...4:30 and 7:30pm. The bell choir will be playing at the Reinholds Chapel on December 11 at 2pm.

December 12 there will be one service at 8:30 am. The congregational meeting will follow.

Also, December 12 will be the night of music. Contact Sue Kreitz if you want to participate. Cookies are needed for after the concert.

December 26 there will be one service with readings and carol singing.

Learning: Hanging of the greens will be held on December 5 with everyone invited to help decorate the church.

They made a recommendation to council to consider moving Sunday School to after the 8:00 service starting at 9:00 and moving the 9:00 service to 10:15 am. After a lengthy discussion it was decided to table this discussion until January Council meeting. Council welcomes feedback from the congregation on this matter.

Constitution: The Congregation Council will elect its officers and the president, vice president, and secretary shall be selected from the elected membership of the Congregation Council. If the financial secretary or cotreasurers are not selected from the elected membership of the Congregation Council, the financial secretary and co-treasurers shall have voice but not vote at the meetings of the Congregation Council.

The president, vice president, secretary, co-treasurers & financial secretary shall be elected by the Congregation Council by written ballot and shall serve for one year. The term shall begin on January I and end on December 31.

Stewardship/Social Media: They updated the website to the return of 2 services and are working on adding Pastor Brubaker to the site.

Working on improving coordination and accuracy of all information from Swamp. Pastor Brubaker will maintain oversight of all communications to assure accuracy and completeness.

Discussed splitting communications and stewardship function so stewardship can concentrate on stewardship and communications committee can provide a centralized coordination of all Swamp communication.

Other items discussed: Pastor Brubaker is planning for his installation here at Swamp. It will likely be in January in the afternoon, followed by a reception.

The COVID task force met and recommends that we follow the current protocols:

The policy of our church continues: For those who are fully vaccinated, wearing a mask indoors is optional. However, in light of continued high transmission of COVID disease in our area and

out of concern for our vulnerable neighbors, we strongly urge all people to wear a mask while inside the church. If you are not vaccinated, you are required to wear a mask while inside the church.

The budget was presented by the Finance Committee. It was discussed and approved with few changes by Council to present to the Congregation on December 12 at the annual Congregational meeting.

The nominees from Council to replace the outgoing members are: Deb Sweigert, Jen Weitzel, Alan Worley & Fritz Fichtner. They will be brought up at the congregation meeting for approval. I would be remiss if I didn't mention that the National League MVP is none other than the Phillies Bryce Harper. Stewardship Minute

- "The gifts of God for the people of God," the pastor announces, inviting parishioners to the Lord's Supper. The gift of the body and blood Christ keeps on giving; we give because of what we have been given. Instructing the Corinthians how they are to celebrate the Lord's Supper, the apostle Paul prefaced his remarks with this same paradigm for giving. "For I received from the Lord what I also handed on to you...." (I Corinthians 11:26) The implication should have been clear to them: "Give what you have so abundantly received." The Words of Institution followed immediately upon this preface.
- Luther made a similar connection. He faced his own dilemma of giving. In the medieval world, priests, nuns, and religious orders played a key role in relief of the poor. Priests dispensed alms to the poor; tables outside the cathedrals collected food and other goods for them; masses brought in money for them. Taking apart this elaborate welfare system raised the urgent question of relief of

the poor. Luther brought I Corinthians II to his defense. He commended to his own congregations the ancient practice of gathering food and material goods in the church and distributing them among the poor. Then, he noted, the sacrament was "properly used" and people "understood this fellowship...well."

- Luther took an additional step in his own version of welfare reform and created a new priesthood which would now be responsible for relief to the poor: "the priesthood What part does service play in your Christian life? What might it mean for you? What can it mean for your congregation? faith practices, faith lives continued of all believers." Convinced that there ought to be no beggars in Christendom, he counseled every village to become acquainted with the poor in its midst. After all, this is what the priest would have done.
- If we would include ourselves in the "priesthood of all believers," we must accept the duties and responsibilities of that calling. Empowered by the Body of Christ in the Lord's Supper, we move into the world in witness and service, giving what has first been given us. Think of the Offertory Prayer: "We offer with joy and thanksgiving what you have first given us — our selves, our time, and our possessions, signs of your gracious love." The prayer contains both the form of our giving (giving money, volunteering our time, sharing our talents) and the attitude which accompanies it (joy and thanksgiving). The faith practice of giving marks the Christian life of discipleship for Christians who are also priests.
