

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to 134 COLONNADE DR and Providence Firearms LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Providence Firearms LLC include 134 COLONNADE DR. The Providence Firearms LLC website is a Providence Firearms Products and Services site. By using the Providence Firearms LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Providence Firearms LLC may collect personally identifiable information, such as your:
