All On Line Sales must be paid in full, there are NO Laybys for On Line Sales.

Any items invoiced at discounted prices will revert to our standard list pricing if not paid for on or before the due date shown on the invoice.

17. Paid In Full Invoices & Cancellation of Paid In Full Invoices

- 1. Any paid in full purchase's cancelled shall be liable to a cancellation fee of 25% of the total purchase price which will be deducted from any refund payable on cancellation of the purchase for a re-stocking fee, this does NOT include back ordered items. Any refund due will only be valid for cancellations made within the specified period of 8 weeks from date of purchase. Once this time has passed an invoice cannot be refunded.
- 2. Administration charges \$50
- 3. Cancellations due to LEGAL PRECLUSION shall, on written official substantiation thereof, be refunded in FULL.
- 4. Goods partially or wholly paid for will be stored by us for a period of 16 weeks at no charge. Thereafter a storage fee of \$55 per month per firearm and \$55 per month per order will apply. Unclaimed goods or goods not purchased in accordance with these terms and conditions can be disposed of Adelaide Estate Firearms discretion after the said 16 weeks to recover storage and administration costs.
- 5. Property in any goods supplied by Adelaide Estate Firearms will not pass to the purchaser until such time as the goods have been paid for in full and all monies owed to Adelaide Estate Firearms are paid in full.

6. This Section Applies Only to Goods that have NOT been collected from the Store or Sent Out via Transport/Post.
