- 1. Call to Order RC called the meeting to order at 9:12am.
- 2. Public Comment None.
- 3. General Correspondence None.
- 4. Personnel TG nominated, as SCA's Middle School History Teacher, Stephen Palmer. SW moved to accept the nomination of Steven Palmer as SCA's Middle School History Teacher. MG seconded. 6-0. TG nominated, as SCA's Middle School English Teacher, Arlene Quaratiello. RB moved to accept the nomination of Arlene Quaratiello, as SCA's Middle School English Teacher. LA seconded. 6-0.
- 5. Facilities
  - a. Paving Project TG shared the interest of Newton Planning Board regarding the paving project. TG will attend the Newton Planning Board this evening. As government agencies, SCA and SAU17 use and betterment of the property are statutorily exempt.
  - b. Outdoor Grounds TG met with SAU17 and Seacoast Learning Collaborative to confirm the use of outdoor space during the school day. SCA will use the lower field, in its entirety, and will respect natural boundaries of the SLC space. SCA will also use the play area on the northern side of the building. Due to the proximity of this area to the road, the Kingston Health Officer recommends a perimeter fence for the safety of SCA's scholars. SAU17 will present this safety need, to erect a perimeter fence, to the Sanborn Regional School Board at their June 5th meeting.
  - c. Building TG shared an 8:00 am building status meeting each Monday at the schoolhouse with NPCM and Trident. TG reviewed the construction proposal and the need to align the work and costs. Trident will work to break out the scope and

cost of the work in the original building and the modular building. Discussion and options for the Fire Panel were made. LA moved TG and RC to work with NPCM and Trident in good faith, to enter into an agreement that is financially reasonable for SCA and that would start construction as soon as possible.
