- 1. Call to Order RC called the meeting to order at 6:03PM.
- 2. Public Comment None.
- 3. General Correspondence None.
- 4. Family-focused Outreach & Marketing Plan The Board of Trustees discussed areas in which short and medium term outreach and marketing efforts could be made to bring a greater awareness of the Academy to families and communities. Areas discussed: distance to the Academy, the Sanborn effect, a wait and see mindset, construction constraints, home district sports, transportation and bussing, homeschooling families, general lack of awareness.
- 5. Personnel TG nominated Ms. Elizabeth Barros as a Seacoast Classical Academy teacher. RB moved to accept the nomination of Ms. Elizabeth Barros as a Seacoast Classical Academy teacher. MG seconded. 6-0.
- 6. Facilities/Lead Remediation TG shared the testing and remediation of lead in the Academy's drinking water. KR moved that Seacoast Classical Academy Chartered Public School accept and expend the grand funds from the Drinking Water and Groundwater Trust Fund and enter into a grant agreement with the New Hampshire Department of Environmental Services; and Rebecca Bates, Treasurer of Seacoast Classical Academy Chartered Public School, be authorized to sign the grant documents on behalf of the Academy. MG seconded. 6-0.
- 7. Parent Council TG discussed establishing the Parent Council in this first year. RC moved to amend membership in the Parent Council, in the first year, allowing all interested parents to be on the Parent Council, without election, and without a limit to the number of volunteers. RB second. 6-0.

- Finance Committee RB discussed setting up a Finance Committee to focus on the financial operations and assist the Treasurer and Executive Director. RB moved to create a Finance Committee chaired by the Treasurer of Seacoast Classical Academy CPS and composed of one to three additional Trustees, and up to four non-voting members to include the Academy's Executive Director and Accountant. KR seconded. 6-0.
- 9. Academy Credit Card RB discussed the acquisition of AMEX cards by the Academy. RC referred this matter back to the finance committee.

- 11. Adjournment RC moved to adjourn. LA seconded. 6-0. Meeting adjourned at 8:28PM.
